Good Morning Don, This is Charlotte Neufeld, the owner/operator of Creative Little Learners. Your name came to me, as a person to discuss the new initiative to decrease childcare fees for parents

I "opted in" to the childcare initiative before the deadline, in hopes that parents fees would be reduced commencing April 1st. In my application, I did make it apparent that fees were increasing in September, and that the parents were all aware of this (with my increased fees, parents fees will still be lower that what they pay now)

I received an email On March 31, 2018 stating

"We have reviewed your application to determine your eligibility for the Initiative. At this time, we require additional information to supplement your application. You will be contacted by an Adjudicator to discuss your application in order to finalize the review."

At this time, I could not decrease the parents fees for April, as I had to wait for an adjudicator. On April 11, 2018, I received a second email that mentioned that my fee increase" Does not appear to align with your facility's historical fee increases; and Does not align with other provider fees in your area".

I was asked to write an explanation as to why I was increasing my fees (first time ever since opening in 2016). I wrote my letter explaining my education, philosophy of education, why I increased my fees (better programming) and I was greeted with "We regret to inform you that, based on the information you have provided us to date, your facility has not been accepted to participate in the Initiative at this time. We compared your facility's fee and increase(s) with the median range of fees charged by other Family child care providers, in the Service Delivery Area where your facility operates; and We sent an email to your facility, asking you to provide us with: Additional information that would demonstrate how your facility's fee increase(s) do, in fact, align with your historical fee pattern; or, Additional information that would show a bona fide, meaningful and unexpected increase in your expenses that was unplanned and beyond your control. Examples of these kinds of expenses could include: a sudden and unexpected increase in operational expenses; loss of revenue routinely received from a source other than parent fees or government funding; or, an unexpected increase/pressure outside your control that would impact your facility's ability to continue to operate."

Firstly, I have polled my area, and I have the lowest fees. I also connected with 13 daycare's in the langford area, close to me and once again, I am very much on the lower end, so this is inaccurate for them to say that I do not align with other provider fees in the area. As noted above, they are also comparing me to family childcare centre, that of which I am not. I am a multiage age facility and need to have more education and also can have more children in my care.

Secondly, i was told that everyone would be looked at on an individual basis. This is quite ironic, as two other centres within a KM of me, all got the same generic letters back of denial When I called the CCOF prior to opting in, I talked about my fee increase in September and was told this would not be an issue. After not being accepted, reading the media realizing people got accepted with massive increases without explanation is quite troubles, i turned to contacting the CCOF again. At this time I was told that they could not speak to this but If I just write the letter, it will be looked at and everyone will get accepted as there is so much money to give out. In the end, I received an email back stating once again that my fees don't fit in and i didn't have an unexpected increases

At this point I am quite disappointed that my parents are not getting a fee reduction. If this is about helping families, they need to look at a different approach.

Do you have any suggestions as to next steps?

# **Report 1—Salmon Farming**

# What we examined (see <u>Focus of the audit</u>)

Salmon farming, also referred to as salmon aquaculture, is the farming of salmon for commercial purposes. In Canada, it is carried out primarily along the coasts of British Columbia and the Atlantic provinces. In 2016, the salmon aquaculture industry in Canada was valued at \$1 billion.

Canada is the fourth largest producer of farmed salmon after Norway, Chile, and the United Kingdom. The Canadian salmon farming industry is considered to have significant potential for growth due to Canada's long coastline, cold water temperatures, and proximity to the United States market.

This audit focused on whether Fisheries and Oceans Canada and the Canadian Food Inspection Agency managed the risks associated with salmon aquaculture in a manner that protected wild fish.

# Why we did this audit

This audit is important because salmon aquaculture is a growing industry in Canada that provides an important source of fish, given declining wild fish stocks. Globally, aquaculture now provides half of all fish for human consumption. Raising farmed salmon in net pens in the ocean has potential effects on wild fish that need to be understood and addressed, as appropriate.

# What we concluded

We concluded that Fisheries and Oceans Canada did not adequately manage the risks associated with salmon aquaculture consistent with its mandate to protect wild fish. Although the Department had some measures to control the spread of infectious diseases and parasites to wild fish in British Columbia, it had not made sufficient progress in completing the risk assessments for key diseases that were required to understand the effects of salmon aquaculture on wild fish. It also had not defined how it would manage aquaculture in a precautionary manner in the face of scientific uncertainty. Moreover, the Department did not adequately enforce compliance with aquaculture regulations to protect wild fish.

The Canadian Food Inspection Agency had measures to prevent the introduction and spread of infectious diseases with respect to aquaculture. However, the Department and the Agency had not clarified roles and responsibilities for managing emerging diseases. This lack of clarification created a risk that potential emerging diseases affecting wild salmon would not be adequately addressed.

# What we found about...

# Studying the effects of salmon farming on wild fish

Overall, we found that Fisheries and Oceans Canada had not made sufficient progress in completing risk assessments for key diseases, which were required to assess the effects of salmon farming on wild fish.

This finding matters because the Department committed to conducting scientific studies and assessments to understand the effects of aquaculture on wild fish.

• Fisheries and Oceans Canada had not made sufficient progress in completing risk assessments for key diseases

**Recommendation.** Fisheries and Oceans Canada should conduct its planned disease risk assessments by 2020 to increase its knowledge of the effects of aquaculture on wild salmon, as it committed to doing in its response to the Cohen Commission report.

# Preventing the spread of infectious diseases and parasites

Overall, we found that although Fisheries and Oceans Canada and the Canadian Food Inspection Agency had put in place some measures to mitigate the spread of infectious diseases and parasites from farmed salmon, key elements were missing. For example, Fisheries and Oceans Canada's program for auditing the health of farmed salmon in British Columbia was out of date, and the Department had limited laboratory capacity to provide timely surveillance test results. In addition, the Department and the Agency had not clarified roles and responsibilities for managing emerging disease risks to mitigate the potential impacts of salmon farming on wild fish.

This finding matters because diseases and parasites present in salmon farms in the ocean may pose a risk to wild fish.

• Some measures to address disease risks in aquaculture management were not yet in place

**Recommendation.** Fisheries and Oceans Canada and the Canadian Food Inspection Agency should clarify their roles and responsibilities for managing emerging disease risks to mitigate the potential impacts of salmon farming on wild fish.

**Recommendation.** Fisheries and Oceans Canada should determine and communicate how it applies the precautionary approach to managing aquaculture when there is uncertainty about the effects of aquaculture on wild fish. The Department should also clearly articulate the level of risk to wild fish that it accepts when enabling the aquaculture industry.

# Controlling the effects of drugs and pesticides

Overall, we found that Fisheries and Oceans Canada did not conduct adequate analysis to know whether its rules for drug and pesticide deposits at salmon farms would minimize harm to wild fish. In addition, the Department did not define limits on the amount of drugs or pesticides that could be deposited, or confirm the accuracy of information self-reported by aquaculture companies.

This finding matters because drugs and pesticides used in aquaculture operations can harm wild fish, especially those living on the ocean floor.

 Fisheries and Oceans Canada had not assessed the effectiveness of its rules for depositing drugs and pesticides at salmon farms to minimize harm to wild fish

**Recommendation.** Fisheries and Oceans Canada should establish thresholds for the deposit of drugs and pesticides into net pens to more effectively minimize harm to wild fish.

**Recommendation.** Fisheries and Oceans Canada should develop and implement an approach to validate the accuracy of information that aquaculture companies report regarding their drug and pesticide deposits.

# **Controlling fish escapes**

Overall, we found that Fisheries and Oceans Canada had not set a national standard for the quality and maintenance of equipment, such as nets and anchoring systems, to reduce the risk of fish escapes.

This finding matters because preventing fish escapes is important to minimize the risk of causing negative genetic effects in wild salmon. This is especially important in Atlantic Canada, where escaped farmed salmon have begun to interbreed with declining wild salmon populations.

• <u>Fisheries and Oceans Canada did not set a national standard for nets and other equipment to prevent fish escapes</u>

**Recommendation.** Fisheries and Oceans Canada should initiate discussions with its counterparts in the Atlantic provinces to address the quality and maintenance of equipment on salmon farms to prevent fish escapes.

# **Enforcing and reporting on compliance**

Overall, we found that the Department did not sufficiently enforce its <u>Aquaculture Activities Regulations</u> to minimize harm to wild fish. It also did not always publish detailed or up-to-date information about such matters as disease outbreaks.

This finding matters because enforcement is important to ensuring that aquaculture companies are complying with regulations designed to protect wild fish. Publishing information about disease outbreaks and compliance with regulations is important to building public confidence in government regulation of the industry.

 Fisheries and Oceans Canada did not adequately enforce compliance with regulations to minimize harm to wild fish

**Recommendation.** Fisheries and Oceans Canada should more effectively enforce aquaculture regulations and pursue additional enforcement measures.

**Recommendation.** Fisheries and Oceans Canada should provide timely public reports with detailed information on companies' drug and pesticide deposits, and on the health of farmed fish in British Columbia.

I understand that the Municipality of North Cowichan (MNC) has invited Halalt, FLNRORD, and EAO to a meeting to be held by May 15, as required by the Certificate. The purpose of the meeting is to review the monitoring report and flow release information and to seek Halalt's and FLNRORD's input on the operation of the wells for the year ahead. This will be the first of several annual meetings that MNC is required to hold and to invite Halalt, in order to ensure an ongoing dialogue about any potential effects from summer pumping of the wells. The EAO is aware that the MNC has also contacted Halalt in regards to installing the Banon Creek flow measurement gauge, as required by the Certificate.

In consideration of the factors raised during the amendment and the approved conditions, the EAO is of the opinion that the Chemainus Wells amendment would have no adverse impacts on Halalt's right to fish. The EAO believes that the mitigation of releasing water from Holyoak Lake and Banon Creek would augment the Chemainus River flow and create additional habitat for fish. We remain committed to working with the Halalt on the implementation of the conditions and to continuing to seek to understand and address Halalt's concerns.

The Government of British Columbia has released the report that it received from the Minister of Agriculture's Advisory Council on Finfish Aquaculture (MAACFA).

The council worked over the past 18 months to complete the report, which provides strategic, immediate and long-term recommendations.

They are grouped into six themes:

- Salmon farm locations
- Aboriginal rights and title
- Marine planning and community engagement
- Pathogens and disease
- Alternate technologies and approaches
- Transparency and information gaps

The report recommends policy changes by both the B.C. government and the Government of Canada, some of which require new funding to implement.

The Province is releasing the report to allow for public review, and to enable consultation with Indigenous peoples, the aquaculture industry and Fisheries and Oceans Canada. The report recommends further consideration of implications, risks and benefits.

The moratorium on issuing new tenures for finfish aquaculture will remain in place while the Province considers the council's report and recommendations.

The advisory council was formed in 2016 by the Province to provide strategic advice and policy guidance to the Minister of Agriculture about the future, and issuance, of new Crown-land tenures for marine-based salmon aquaculture in British Columbia. The members of MAACFA included representatives from the aquaculture industry, academia, non-governmental organizations, First Nations and federal and provincial government officials.

The council met 12 times between July 2016 and January 2018. It was provided with background on salmon farming (regulatory regime, operational arrangements and research and health developments) and presentations on finfish aquaculture issues. The council's meeting minutes are also available on the MAACFA webpage.
