Thanks for helping facilitate a cross-ministry response. So far I have connect with the MA teams in SDPR, MIRR, MMHA, MAH, AEST and given them an overview of the request but as far as I know only the

Premier, MCFD, SDPR and MAH have received formal requests for funding/meetings from UNYA (other Ministers have been cc'ed on these letters).

Minister Conroy has responded to UNYA explaining that MCFD cannot commit 10 Million at this time (a separate 10 Million request was directed at MAH), however correspondence from UNYA continues to refer to the 2018 budget so I believe a response from the Premier is expected before Feb 20<sup>th</sup>.

While MCFD cannot commit 10 Million at this time, we are open to exploring in what ways we could contribute to the project in the future, and would like to participate in a cross-ministerial discussion about what options are possible to support this project.

I have attached the most recent Feb 8 letter from UNYA to the Premier as well as correspondence with Minister Conroy – and as you can see below the Premier's correspondence unit has reached out to us about designating a lead Ministry for a response. At this time we believe that a cross ministry discussion is needed before designating a lead ministry.
