Deciding When:

Any decision around when, and when not, to include a full complan is at the
discretion of the Communications Director; we encourage CDs to connect with
their ED if they need guidance (and EDs with ADMs). If CDs encounter any
further pushback on their decision, they and their ED should consult Mike Lowe
or Robb Gibbs for further assistance and direction.

That said, whenever possible, Communication Directors should consider preparing a one-page communication outline that includes: Item Summary; Key Audiences; Key Messages; Key Stakeholders. We are urging this because we believe there will be some commonalities in these four areas, regardless of which option may be selected. We reinforce, this should be done whenever possible or practicable again, this is not required. Deciding When: Any decision around when, and when not, to include a full complan is at the discretion of the Communications Director; we encourage CDs to connect with their ED if they need guidance (and EDs with ADMs). If CDs encounter any further pushback on their decision, they and their ED should consult Mike Lowe or Robb Gibbs for further assistance and direction. Finally, Cabinet Operations and the Premier's Office are aware of this change. Thank you, Robb

Choices transitional shelter closes on a high note

Over 100 people successfully transitioned into permanent housing

VICTORIA, B.C. – Choices, the transitional shelter operating out of the former youth custody centre in View Royal, is closing its doors this week. But it is doing so with a strong sentiment of success.

Since partnering with BC Housing in March 2016, Choices has successfully transitioned 103 of our community's most vulnerable citizens into permanent housing. The final 40 residents were all moved into brand new suites at the former Tally-Ho Hotel in Victoria this week.

"It has been an incredible journey," says Don Evans, executive director of Our Place, which operates the facility.

"Choices was opened in response to tent city, and we couldn't have done it so successfully without the support of View Royal council and the local residents."

He adds, "To see the difference in these vulnerable people when they have a safe place to live, and three solid meals a day, is astounding. The staff truly went above and beyond to make everyone feel at home, and to work with each individual on a plan for future success."

When Choices first opened, residents elected to sleep in tents in the courtyard. But as winter approached and the interior was transformed from cells into rooms, every resident made the choice to move inside.

"Change is always difficult, and people were reluctant at first to move from tent city to Choices," says Our Place Director of Housing Debbie Berg. "But once they were here, you could visibly see health returning to them. Once they stabilized, many people were able to return to work, while others entered detox and recovery programs – some for the very first time."

Berg adds, "When it was time to close Choices, the remaining residents had a similar fear as when they first arrived, but Cool-Aid has done a fantastic job of making everyone feel welcome at the former Tally-Ho."

Our Place is a unique inner-city community centre serving Greater Victoria's most vulnerable: working poor, impoverished elderly, mentally and physically challenged, addicted and the homeless. Individuals and businesses provide the majority of financial support for its programs and services. Our Place provides over 1,800 meals per day, hot showers, education, job skills, free clothing, counseling and outreach services; plus 135 transitional housing units and 60 overnight shelter mats. Most importantly, it provides a sense of hope and belonging to our neighbours in need.

In August 2017, Our Place, the current operator of Choices, suggested that the building be turned into an addictions recovery centre. Our Place said it would need to secure about \$4.7 million in funding from the province.

The proposed therapeutic recovery community would be a supportive housing project with recovery services for 40-50 people experiencing homelessness with addiction, with an expected length of between 12 and 24 months.

Choices transitional shelter closes on a high note

Over 100 people successfully transitioned into permanent housing

VICTORIA, B.C. – Choices, the transitional shelter operating out of the former youth custody centre in View Royal, is closing its doors this week. But it is doing so with a strong sentiment of success.

Since partnering with BC Housing in March 2016, Choices has successfully transitioned 103 of our community's most vulnerable citizens into permanent housing. The final 40 residents were all moved into brand new suites at the former Tally-Ho Hotel in Victoria this week.

"It has been an incredible journey," says Don Evans, executive director of Our Place, which operates the facility.
"Choices was opened in response to tent city, and we couldn't have done it so successfully without the support of View Royal council and the local residents."

He adds, "To see the difference in these vulnerable people when they have a safe place to live, and three solid meals a day, is astounding. The staff truly went above and beyond to make everyone feel at home, and to work with each individual on a plan for future success."

When Choices first opened, residents elected to sleep in tents in the courtyard. But as winter approached and the interior was transformed from cells into rooms, every resident made the choice to move inside.

"Change is always difficult, and people were reluctant at first to move from tent city to Choices," says Our Place Director of Housing Debbie Berg. "But once they were here, you could visibly see health returning to them. Once they stabilized, many people were able to return to work, while others entered detox and recovery programs – some for the very first time."

Berg adds, "When it was time to close Choices, the remaining residents had a similar fear as when they first arrived, but Cool-Aid has done a fantastic job of making everyone feel welcome at the former Tally-Ho."

Our Place is a unique inner-city community centre serving Greater Victoria's most vulnerable: working poor, impoverished elderly, mentally and physically challenged, addicted and the homeless. Individuals and businesses

provide the majority of financial support for its programs and services. Our Place provides over 1,800 meals per day, hot showers, education, job skills, free clothing, counseling and outreach services; plus 135 transitional housing units and 60 overnight shelter mats. Most importantly, it provides a sense of hope and belonging to our neighbours in need.

Hi Shelley... I see how this can be a bit confusing. It's a matter of what is included.

- When using the term "salary" we usually mean STOB 50, which is predominantly base salaries, overtime, lump sums payments etc for all staff except the Premier.
- There is also STOB 51, which is supplementary salaries. This includes things like maternity/parental leave and the health and welfare in lieu pay that auxiliaries receive.
- Then there is STOB 52, which is your benefits chargeback. That's for all our benefits, like pension, CPP, EI, MSP, extended health etc. It's a flat rate charged on whatever your STOB 50 costs are (the rate is 24.34% in 1718, and will be 24.8% in 1819).
- Lastly there is STOB 54 which is legislative salaries, in your case the Premier's salary.
- Altogether these are usually referred to as "salaries and benefits".

The budgets of \$7,262,000 for 1718 and \$7,274,000 for 1819 are STOB 50 only. I've highlighted it in yellow below.

The \$9,160,000 in the forecast document is an unusual combination and includes only STOB 50-52, but not STOB 54. We can change that if you like. I've outlined what this includes in red below.
