Freedom of Information & Records Management

Background:

- The opposition has questioned whether government is properly handling records and responding to Freedom of Information requests.

- Some FOI responses for requests of Ministers' and staff emails have turned up zero records for certain periods.
- A number of FOI responses have revealed some use of personal or legislative assembly email addresses use by Ministers.
- The OIPC has previously stated that: "The routine destruction of transitory records is necessary to reduce the volume of government records and the cost of managing records." (Elizabeth Denham, Oct 22, 2015)

Message:

- We hold ourselves to a high standard, and some recent examples have fallen short of that.
- Our government and its staff have been directed to manage records properly, and we will be providing additional training to staff.
- We are directing staff to take a cautious approach to ensure no mistakes are made.
- In a small number of cases where best practices may not have been followed, we have taken proactive steps to address it and comply with the rules.
- It is important that rules and best practises are followed and that decisions are documented appropriately. Our government is committed to doing that.

Kinder Morgan

Background:

- The Federal Finance Minister announced that the government is prepared to indemnify the pipeline project against purported extraordinary political risks caused by the BC Government.
- Minister Morneau announced that the offer would be available to another investor if Kinder Morgan were to back out.
- Reports suggest that the Federal Government may consider buying the pipeline if Kinder Morgan backs out and then re-selling it to a private operator and/or pension funds.

Message:

- We are standing up for BC's environment, economy and our coast against the threat of a bitumen spill and we are doing so entirely within our rights and within the law.

- We will continue to defend our environment and the tens of thousands of jobs and billions of dollars of economic activity that depend on it.

But aren't you creating delays and uncertainty for the project?

- Kinder Morgan has been clear that the province has been dealing with permitting requests fairly and in a timely manner.
- The greatest uncertainty for the project is the court challenge by First Nations in the Federal Court of Appeal.

- Now the Court may re-open the case because of reports of serious problems with the federal government's consultation with First Nations – that is on the federal government.

Alberta Bill 12

Background:

- Alberta passed Bill 12 on Wednesday to give them powers to restrict shipments of gasoline or other petroleum products.
- BC Attorney General sent a letter to the AB Government saying that the bill is clearly unconstitutional and suggesting they send it to the courts for an opinion before royal assent.

Message:

- The Alberta government has been clear that they don't want to and don't expect to try to use this legislation.
- The fact is, Alberta can't use this bill to target British Columbians because to do so would be entirely unconstitutional.
- We don't expect them to try to invoke these extreme and unlawful measures, but we are prepared to defend British Columbians with the full force of the law.

Gas Prices

Background:

- Andrew Wilkinson has called for a temporary reduction of gas taxes.
- Refining and marketing margins in BC are significantly higher than other regions of Canada. Refining margins are the difference between the price of crude and the price of refined product. They include operating costs.
- Economist Robyn Allan says there are no cost or supply constraints that explain current prices, arguing instead that "oil companies are gouging us."

Message:

- I understand people's frustration about gas prices. It is one of many costs people experience and that is why we are working to make life more affordable for British Columbians.
- We are eliminating MSP fees, avoided ICBC hikes planned by the old government, and eliminated tolls. We are investing in affordable housing and childcare for people.

- Even Andrew Wilkinson has said the provincial government doesn't play a big role in determining gas prices.
- We don't control the markets but we are committed to working every day to make life more affordable.

Would you consider taking off some of the Carbon or other taxes, or giving drivers a rebate?

- The increase in the carbon tax to meet the federal mandate adds just a penny per litre – that isn't what is driving prices.

- We are increasing climate action rebates for low and middle income families to ensure a majority of British Columbians are better off than under the old government's plan.

E&N Corridor

Background:

- A study on the E&N Rail corridor was announced under the old government by then Minister of Transportation Todd Stone.
- A request for proposals was posted, asking for a consultant to examine the feasibility of using the E&N rail corridor between Victoria and Langford as a regional transit route. The RFP required that a report be due by end of July.

- Minister Trevena told media on Nov. 22 that the RFP had been put on hold.
- Consultation with local First Nations and municipal partners about how best to transform the E&N rail line into a functional corridor, led by MLA Mitzi Dean, has wrapped up.
- Premier Horgan commented on the issue on May 15, saying “the business case doesn’t seem to be there” and suggesting bus lanes are an immediate and efficient solution to gridlock. (as reported in Times Colonist)

Message:

- This is a problem that’s keeping people stuck in traffic, and we need to tackle the congestion.

- I thank the Member for Esquimalt-Metchosin for her work over the past few months leading discussions with our municipal partners and First Nations about how best to transform the E&N rail line into a functional corridor.

Employer Health Tax

Background:

- On May 15, the opposition raised concerns in Question Period about the potential impacts on non-profits and charities as well as public sector employers like school districts.
- A UBCM survey says total EHT/MSP costs for many municipalities will increase and that they may have to raise property taxes to cover costs.

- Eliminating MSP premiums will save individuals and businesses \$2.6 billion - and even after factoring in the EHT it is a net tax cut of \$800 million.

Message:

- We are eliminating MSP premiums, saving families up to \$1,800 each year. This is one of the biggest tax cuts in BC's history.

Will you address concerns from municipalities so they don't need to raise taxes?

- Families will see savings of up to \$1,800 from the elimination of MSP.
- Municipalities have other options, but even if even if some choose to cover the EHT entirely through property taxes, the cost per residential property amounts to a few dollars a month.

School Tax

Background:

- In 2019 the school tax will be increased by 0.2% on the value of homes assessed over \$3 million and 0.4% on value over \$4 million. This represents the top 2% of homes in BC.
- School taxes have existed in BC for decades. the modern residential school tax framework was introduced in 1991 by the Social Credit government. The funding has always gone into general revenue.
- Eligible homeowners (seniors 55+ and families with children) can defer their property taxes until the house is sold.

Speculation Tax

Background:

- Some developers have said they are suspending or cancelling projects because of the speculation tax.
- Opposition MLA Ben Stewart said on May 14 that their government would cancel the speculation tax within the first 100 days.
- Andrew Wilkinson introduced a bill to apply a new capital gains tax on profits from condo flipping, but the bill would not apply to out-of-province and foreign speculators who do not file income taxes in BC.
- Profits from condo flipping are already taxed either through federal capital gains taxes, or in many cases the CRA determines they are to be taxed as regular income both federally and provincially.

Wildfire Management Budget and Abbott-Chapman Report

Background:

- Media may ask why our government allocated \$63 million for wildfire management and \$15 million for disaster relief in Budget 2018 when the 2017 wildfire season cost estimates were much greater.
- Final estimates for 2017 are \$568 million for wildfire management and \$350 million for disaster relief.
- The 2017 fire season was exceptional and record-breaking. Over the course of the longest provincial state of emergency, over 65,000 people were evacuated.
- Chief Maureen Chapman and former cabinet minister George Abbott were asked to produce a report on the 2017 season.
- On May 10 the report entitled *Addressing the New Normal: 21st Century Disaster Management in British Columbia* was released.
- On May 14, George Abbott told CHNL that there is “a growing gap, the last ten to 20 years, between the amount that government is paying for response when floods and wildfires occur, and what is spent on prevention.” Abbott said that to fully embrace all 108 recommendations, it would take hundreds of millions of dollars.

Hi Mike & Talea, Jennifer, John & Evan.

We urgently need some explicit clarification from the Provincial level in terms of what support the province can supply to offset expenses for landfilling costs for debris from this disaster.

Health risks are increasing as molds grow while people wait for us to convey the direction of what support the Province can supply us.

I understand that there were significant conversations last week at your level that touched these issues, but we still haven't received any clarity, and days from now will be too late.

It feels like we're struggling to provide support for the average people here; businesses have their structures in place, public infrastructure has a realm of support available -- the general public is starting to feel ignored.

We have NGO's ready to take on some of this work, but they're hesitant to take on the financial burden given the applicability of charitable donations for that use.

Mike, we mentioned this concern when you were here the weekend before last with us. Thanks again for giving us your day

John, you told me that you'd respond promptly with requests that we had --- this seems like a simple request for clarity, even if the answer is 'no'.

Jennifer, thanks for the call last night, and sorry I had to run for that Council meeting. This is one of the two issues I mentioned. I'd still be pleased to talk once you get to Ottawa tonight if you can find the time.

As a reminder of where I fit here, I'm the liaison to the Policy Group (the elected officials across the six local governments in the scope of this disaster) to the EOC, and Chair of the RDKB.

I'd really appreciate an answer, even if that answer is no Provincial support, since we need to clarify for our people.
