A quick fact check on what the Liberals were suggesting in QP today:

Johal suggested today that we were increasing the carbon tax on gas by 5 cents a litre this year. That's inaccurate – it's actually only 1.1 cents a litre.

The increase in the Carbon Tax is to meet the federally mandated carbon price of \$50 per tonne while giving certainty to business and individuals.

The Budget also details an additional \$40 million per year to low and moderate income British Columbians through enhancements to the low income climate action tax credit (page 75).

From Susan Farmer:

We received 3625 emails in total from 2017. These were mostly original emails – no clear template/form letter being used.

Of those, just over 100 wanted to keep things as is (switching as we currently are).

The rest wanted to abolish it – however, some of those wanted to keep us on the DST time forever (summer schedule) – so there were different opinions on that.

For 2018, it had been pretty quiet, up until this past weekend & the days leading up to it. We've had 231 come in. Some of these are via a form letter that also requests a referendum about it. Haven't looked through all of the 2018 ones (they're not sorted) – almost all are saying to stop it – with differing thoughts as to which timing we should remain on year-round. I've only come across one in support of continuing DST for 2018 so far.
