B.C. Green caucus statement on final mobility pricing report

VICTORIA, B.C. – Adam Olsen, B.C. Green Party spokesperson for transportation, released the following statement in response to Metro Vancouver's final Mobility Pricing Study report. Olsen says statements by the Mayors' that mobility pricing will be politically difficult underscore the need for provincial leadership on the issue.

"As our province grows, we need a strategy to help get people where they need to go efficiently and affordably," said Olsen.

"Mobility pricing is used all around the world as an effective tool to reduce congestion, limit emissions and pay for infrastructure. It is very exciting that the report found that mobility pricing could reduce congestion by 20 to 25 per cent. This would improve quality of life for Metro Vancouverites and go a long way to helping us meet our climate goals.

"As the Metro Vancouver mayors noted today, implementing mobility pricing will be politically difficult, especially as Metro Vancouverites struggle amidst an affordability crisis that has no easy remedies. British Columbians must have affordable, accessible alternatives to single occupancy vehicles if we are to move forward with mobility pricing. But we must also acknowledge there are serious social, environmental and economic costs of inaction. A failure to reduce congestion will lead to loss of economic productivity, increased stress and its related health costs, loss of precious family and recreation time, and the dire consequences of increased greenhouse gas emissions. The sooner we can come together to advance solutions, the better of British Columbia will be.

"That is why we need strong provincial leadership to chart a path for the future. Our Confidence and Supply Agreement (CASA) with the B.C. NDP commits to working with the Mayor's Council to develop a fair and equitable long-term funding model for transit. Our team is closely analyzing this report and will continue to engage with local governments and British Columbians to determine the best path forward. We will keep pressure on government and continue to work collaboratively with them to fulfill our shared commitments on transit, climate and affordability."



Andrew Weaver to introduce legislation to support companies that pursue social and environmental goals

VANCOUVER, B.C. – Andrew Weaver, leader of the B.C. Green Party, announced today that he will introduce legislation that would enable B.C. companies to incorporate as benefit companies. The bill, which Weaver announced following a roundtable with business leaders in Vancouver, would amend the *Business Corporations Act* to allow companies that choose to incorporate as benefit companies to pursue social and environmental goals, rather than just profit.

"This legislation is an opportunity for B.C. to lead the country in supporting businesses that want to be a bigger part of developing innovative solutions to the challenges of the 21st century," said Weaver.

"The world is experiencing tectonic shifts - from climate change to automation, we need to think differently in order to turn these challenges into opportunities. Government and individuals cannot solve these problems alone. Businesses play a huge role in our society and they are part of the solution. Companies that pursue a triple bottom line are on the cutting edge of rethinking the role of business in the 21st century. They know that acting in the best interests of people and the planet is the best way to build a thriving economy for the long-term.

"This legislation would provide a legal framework for companies that choose to pursue social and environmental goals and operate in a responsible and sustainable manner. By making B.C. the first jurisdiction in Canada to allow businesses to incorporate as benefit companies, we are sending a strong signal about the kind of economy we want for our province."

Weaver's bill is his caucus' first bill to be put through the official legislative drafting process, making it possible that this could be the first Private Member's Bill in B.C.'s history to be passed into law.

Just FYI, sent this to to the Globe and the TC already but not planning on sending it as a release.

It has always been the B.C. Green Caucus' position that this project poses significant risks to B.C.'s economy and environment, the health and safety of our residents, and to our commitment to reconciliation with Indigenous peoples. B.C. has a right to stand up for the interests of British Columbians and we stand firm in our support of the B.C. government's position on this issue.

This project should never been approved. It is due to a sad lack of economic and climate leadership that B.C. has been placed in this situation. We have a federal government that promised to submit it to their overhauled environmental assessment process, to secure social license for resource development projects and to meet our climate targets. I know firsthand as the only B.C. MLA to intervene in the NEB hearings that this project was not approved based on facts and evidence. It is also clear that this project does not have social license -60% of British Columbians voted for parties who ran on protecting our coastline.
