Further to our conversation, here are the circle agreements that we have been using to create an inclusive work environment:

1. Confidentiality. The personal stories we share, we hold in confidence. Note this helps with reducing gossiping and lateral violence.
2. Take what you need and offer what you can. This takes any hierarchy that exists and puts it on its side, recognizing there is a leader in every chair.
3. Listen with curiosity and compassion, with discernment rather than judgment. An invitation to let go of our intern and external critic.
4. Use silence as tool to ground oneself, to refocus re-center on our intention for gathering.

At the end of offering agreements, I like to ask if anyone has any other agreements they would like to offer. Then I count to 20 to allow time for people to either gather the courage to offer one, or to give time for people to think about one. Sometimes people offer the agreement to not use acronyms. Over the years Aboriginal youth interns have offered the following agreements:

- Silence can also be used as a tool to show respect for each other by honoring their words with silence.
- Belief in good intentions, the belief in the basic goodness of people.
- Have fun!
- Meet people where they are at on their journey.

I then ask if everyone is okay with the agreements. Then I invite people to embody the agreements by taking a few moments to sit in silence and bring awareness to their breathe and their body in breathe. Letting go of what ever was happening leading up to now, and what eer may be happening later on today.

The agreements used repeatedly overtime, help to shift behaviour and culture change. The agreements can be used at the beginning of a meeting, they only take five minutes ad end up saving a lot it time in the end. The agreements have been used in the Aboriginal Youth Internship Program and are a key factor in having 100% retention for Year 9 and 10, and we have 100% retention to date for the current Year 11 of AYIP. AYIP was recognized for the Diversity and Inclusion Champion in the Public Sector by BC Workplace Inclusion Awards in 2017.

One of the narratives in response to using circle agreements is that there is not enough time. Making five minutes of time to do this at the beginning of meetings in the long run saves a lot of time both during and outside of meetings to manage and reduce conflict.

As I mentioned these agreements are starting to be used in pockets across government, including here in the Legislative building. As well, Stephanie Gabel, who is at MIRR and leading the Indigenous language table has been putting them into practice at MIRR.

Last year the Community of Practice of Policy hosted a reconciliation session and committed to following up in a years' time. Since then, every ministry has been mandated to implement the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP), the Truth and Reconciliation Commission (TRC) Calls to Action and the Tsilhqot'in Supreme Court decision (TSCD). Each ministry is "responsible for moving forward on the calls to action and reviewing policies, programs, and legislation to determine how to bring the principles of the declaration into action in British Columbia."

This session will provide an opportunity for ministries and agencies that are active on reconciliation; to share their strategies, challenges, opportunities and lessons learned. There will also be an opportunity to individuals to share their own reconciliation efforts with the goal to build a network of support moving forward. Speakers will include representation from the Premiers Office, The Public Service Agency, the Office of the Auditor General, and the Ministries of Indigenous Relations and Reconciliation; Children and Family; and Tourism, Arts and Culture.

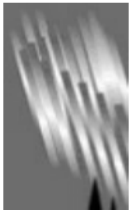

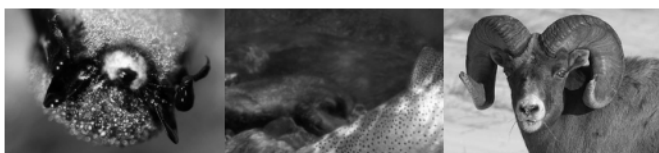
