Dear Premier Horgan,

Good afternoon Premier Horgan,

It is my understanding the Canada bid to be part of the possible hosting of the FIFA World Cup of Soccer will be forwarded to FIFA today and Vancouver will not be included as a possible host city because the British Columbia Government has not signed off on the agreement to host.

Currently the bid does not have a signed Stadium Agreement from Vancouver since the share holder of the stadium authority is the Province of B.C. All other candidate cities have signed their Host City Agreement, Training Site Agreement and Stadium Agreement. The Province of Quebec have signed their Stadium Agreement. All have signed unmodified documents to be submitted into the bid to FIFA. The documents are currently being held in escrow, as each city will finalize a collateral agreement with Canada Soccer that will withdraw them for the bid process before 2020 (if needed).

My concern is that the decision that has not been made to allow Vancouver to be included and as such, at the end of the day, Vancouver have lost the opportunity to be part of hosting the most viewed sporting event in the world. This is caused by the failure to sign an interim agreement that has an opt out clause in it.

We are not only closing the door on being a host province, but Vancouver Island and Greater Victoria, are missing out of possible becoming training camps/venue for participating teams. These camps are fully paid for by the participating individual countries and have historically provide a great legacy of facilities to host communities at no cost. A very small example would have been the legacy left to township that hosted the German Camp for the last world cup. Germany built training fields, a hotel, a medical facility, a number of structures needed to support the technical and medial needs of the team, and a number of other facilities. These were all donated to the community at the end of the World Cup.

I am not suggesting that this will happen here, but with Seattle in the running as an American host city and Vancouver, Greater Victoria would have become a perfect site for a country to stage and train in. However, without an agreement in place it would also lessen the opportunity for Seattle to be chosen and if we would have had two host cities so close, Victoria would have benefited greatly, not only for the training opportunities but also for our tourism.

Needless to say, I am so disappointed in this decision and do not understand your reluctance to do so.
