Hi there. As discussed briefly, here is a very short summary of the federal tax changes as they affect MLAs.

Bill C-44, (June 2017) repealed Subsection 81(2) of the *Income Tax Act*, making Members' non-accountable allowances taxable in the 2019 and subsequent taxation years.

The areas where BC MLAs receive non-receipted allowances are Members' In-Constituency Travel Allowance, and the \$1,000 per month Capital City Living Allowance option.

The issue is currently being discussed by the Legislature's Finance and Audit Committee. The FAC deliberates in camera as do most audit committees, and then the committee's recommendations come before the Legislative Assembly Management Committee, which is a public committee. The timeline is not yet known.

If asked, suggested response:

We understand that the issues arising from Bill C-44 will be addressed through the Legislative Assembly Management Committee. Those meetings are open to the public and the media, and any decisions made will also be public.

  - Members of the government, particularly ministers, should refrain from participation in demonstrations or protests on this issue, s.13
    - If events do occur that trigger media inquiries, caucus members should seek approval from the caucus communications director before commenting in the media or on social media.
  - Members of the public, including constituency association leaders and others, are free to do as they see fit and their participation in peaceful protest is their right.
    - Notwithstanding these guidelines, it is appropriate for caucus members to express sympathy and understanding for the concerns of those expressing their views on the project as they did during the Site C decision process.
    - Caucus members should remind concerned members of the public of the government's active record of legal and regulatory actions since taking power that are intended to defend BC's interests, particularly protection of coastal waters from oil spills, in the face of expanded bitumen exports.
