The PO line received five abusive and disturbing voice mail messages from this caller received on Saturday evening.

There is a long history of previous email correspondence and abusive emails under CLIFF 706742, the context is his issues with the BC Securities Commission.

Jake at Correspondence reports this morning: "Guy is a very frequent writer on the BCSC. We have tonnes of emails from him. I'd recommend screening out his calls. I've alerted LAPS a week or two ago about a particularly threatening email."

His last three voice mail messages contained disturbing threats directed against the current Premier's reputation (but not physical harm), how the caller had information to destroy PJH. In one message he reference LAPS, noting that no one could touch him until he actually did something.

I've kept the five messages for future reference.

You no doubt are aware of this individual.

Lastly, I must add that I have no record of any previous phone calls from^{s.22} since I arrived here last August.

The office has had a couple of interactions by phone with s.22 this morning.

First thing this morning he called to insist that he would be coming to the constit office to get a piece of paper saying we couldn't help him. I reminded him that in fact our Constituency Assistants had tried to help him and had sent him to his MP to get Federal assistance. I told him Constituency office staff would be happy to help if we can clarify what it is exactly that he is looking to resolve. Also made him aware that after being verbally threatening to staff both at this office and at MP's office in the last few days, he would have to control his anger and communicate respectfully or the authorities would be called. He concluded by saying he would be down to the office shortly.

Later in the morning I heard from staff at Leader of Opposition Wilkinson's office. s.22 had contacted them saying "he wasn't getting any help" from MLA/MP. I gave Wilkinson's staff a head's up that s.22 has a tendency to communicate aggressively and that Constituency staff are prepared to help if he wants to be clear in what he needs help with and adopts a non-threatening approach to communicating with staff.

Finally I got a call back from s.22 saying he was going to speak with Libs...but would be back to speak with us in the days ahead.

Will report any future interactions with the constituency office staff if he continues to be aggressive and threatening to CAs.
