Good afternoon,

The EAO became aware that the Premier is meeting with the Vanderhoof City Council on June 20<sup>th</sup>. The mayor and council has voiced the following to our District Manager re New Gold: The municipality is frustrated with the amount of time and delays that have occurred from the EAO, in regards to Caribou mitigation. I am pleased to provide you with a few bullets on the topic.

- New Gold has made several changes to the proposed Blackwater project to address issues raised by Indigenous Groups and both provincial and federal government technical advisors. These changes were related to tailings dam safety, the treatment of mine water and the newly proposed amended routing of the transmission line.
- These changes have triggered new assessments and Indigenous consultations, increasing the elapsed time of the EA process.
- The EAO, provincial and federal advisors, Indigenous Groups and New Gold have recently come to a common understanding of the effects of the proposed Blackwater mine on caribou. New Gold is now revising its effects assessment and proposed offset in order to address the impact.
- While the statutory timeline for the Blackwater EA is currently suspended as a result of the project design changes, the work associated with the review is most certainly not. The EAO continues to work with all parties towards the timely resolution of the remaining issues so that Ministers have the comprehensive information they need to make a decision on the proposed Blackwater project.

#### **Background:**

- A number of nations in the Kamloops area support the pipeline expansion and have signed benefit agreements with Kinder Morgan.
- Simpcw Nation and Whispering Pines Indian Band have both expressed interest in potentially buying equity in the project and banks have reportedly been speaking with First Nations in BC about the possibility of financing stakes.
- The Secwepemc Nation has opposed the pipeline and the proposed route through their territory.

Message:

- There are many First Nations whose rights and title are impacted, with a diversity of views on the project.
- There are some that have expressed varying degrees of support and there are others who are currently in federal court.
- That's not for me to decide, and I'm not going to speak for First Nations.
- What I can speak to are the actions our government is taking to protect our land and waters and the thousands of good paying jobs that depend on them.

*If First Nations buy into the project would that change your position?*

- A change in who owns the pipeline doesn't change the risks of a bitumen spill.
- If the Federal Government, or anyone else chooses to buy the pipeline, I still have a responsibility to protect our environment and economy from the risks of a spill.

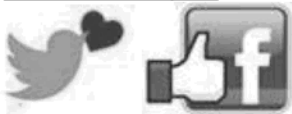
