Don reviewed the briefing note. He supports the concept of a cross-agency review implementation team to evaluate the recommendations in the George Abbott / Chief Maureen Chapman report, and to integrate those with recommendations developed in other tiers of after action review. While he recognizes that full implementation of the recommendations would involve additional resources, he has asked that EMBC and FLNRO examine internal reallocations to cover the resource needs for the project team and recommendations evaluation process.

He asked that Rick Manwaring and Bob Turner:

- Develop a joint plan to co-manage the cross-ministry evaluation of recommendations.
- Develop a plan for the implementation and tracking of those recommendations identified as being within government's near-term capacity.
- Identify how the two ministries will structure themselves to implement the recommendations and maintain strong coordination.
- In the near term, establish a dedicated resource (or resources) to coordinate government's action on recommendations related to First Nations communities.

Don asked that you provide a brief work plan for this sometime over the next two weeks, and that priority be placed on resourcing the recommendations related to First Nations communities. He does support the project team concept, but consistent with his requests to all ministries, he is asking that you look at internal reallocations before seeking new resources.

I am following up on your question about the Vanderhoof Air Show.

I understand from Tourism, Arts and Culture that applications from the municipality and the Air Show had not been submitted in time for their event funding application deadline. As a result, the funding requests are being evaluated separately.

Other than passing your question on to Ministry officials, our office does not have a direct role in event funding.
