Hello Bobbi,

I had the chance to review the draft ToC. A few comments below:

1. My main comment: Being mindful of something the Greens said at our last meeting, "what's the hook?". I think there is an opportunity to set goals for each of the three main areas – transportation, buildings, industry – beyond the GHG reduction numbers. For instance, many jurisdictions (including Vancouver and Victoria) are setting 100% renewable energy goals. While I recognize this particular example is problematic for many reasons, I think there are lessons to learn from it. We could take a similar approach - transportation section could set a goal of 100% renewable by 20XX and similar goals for public transit/reducing traffic; buildings section could set a goal of 100% net zero new buildings by 20XX; and industry section could set a goal of....well this one is more tricky...goal of electrification of XX% of industrial operations by 20XX? This goal setting concept gives us an immediate "hook", which would help structure the document and help focus the headlines of the climate plan on our vision. Further, it creates the boldness factor in communications terms without having to add a bunch of expensive new policies to what's already in the plan. See the Oslo plan for a great example of what I mean.
2. In the "BC's competitive advantage" section I think there is an opportunity to position BC as the first jurisdiction in the world to capture the clean energy trifecta – cheap, green, reliable energy. Two out of three is easy, three out of three is difficult and the advantage BC can capture. This is also an exercise of goal setting and boldness. By making BC the world-leader in clean energy, we can X, Y, Z.....
3. In the goals section 3.4 – can we add a job creation estimate? The plan will create XX amount of jobs? I'm not sure if we want to go there.
4. Also in section 3.4 – I'm anxious of the approach section, and in particular the "success is global emissions reduction" frame. While yes that is true, our plan must commit and be laser-focused on reducing BC's emissions to meet our targets. Anything less will be difficult for the minister and Green partners I suspect. Anyway, just a caution.
5. Section 4.1 – Agree on need to weave in Ec-Dev topics. Very important. I also think there is a good opportunity to highlight BC success stories and clean tech companies.

Hello, see attached. I tried to offer a quick snapshot of July based on reviewing the info from Greg and also from reviewing various real estate sources and blogs. As I'm not a subject matter expert here, this is a very high-level view.

Couple things:

- I've noticed Ministry of Finance already tracks and publishes housing sales, housing starts, and foreign buyers data. It is unclear to me why this info cannot be easily expanded and included in a monthly report for senior staff and premier.
- The economist at MAH will be sending me a one-page executive summary of his work. He compiled the data and charts in the PDF that Greg sent. I have high expectations that the quality will be good and can be replicated on a month-to-month basis.
- At the ED Housing Committee today I requested that baseline data be compiled and shared for the list of indicators being developed for HWG performance reporting. This should be available soon from BCStats.

I think we also talked about the usual timing for the announcement of the rent increase.

The all-items Consumer Price Index for British Columbia is typically released by BC Stats near the end of the third week of August.

We usually post the allowable rent increase amount for the following year early the following week (last year was August 21).

It must be posted before the end of September so that landlords issuing notice of rent increase effective January 1 can meet their requirement to provide three months’ notice of the increase.
