EMBC UPDATE – September 10, 2018 AS OF 0700 HRS – ASSESSMENT

An accommodation barge containing 18k litres of gasoline and 15k litres of diesel ran aground on Lina Island south of the Village of Queen Charlotte. The vessel is reported to be leaking fuel internally; no leaking of deleterious material outside of the barge has been observed. An Incident Command Post will be stood up at the Provincial Ministry FLNRO building in the Village of Queen Charlotte, and all support activities for this incident will be undertaken by the Ministry of Environment's Emergency Operations Center.

Regional updates are located in the regional summaries below.

PROVINCIAL WEATHER

The frontal system that has been moving through BC over the weekend is exiting into Alberta and spreading moisture in its path. The BC Peace and Columbias will have showers this morning. The low near Haida Gwaii continues to keep the BC coast fairly wet. Expect windy conditions around Prince Rupert as well. Subsidence (drying air) in the lee of the Coast Mountains will limit showers in a strip from the Bulkley Valley down to the Okanagan Valley.

The cold front continues to move further south, near Dawson Creek, on Tuesday afternoon. Temperatures will cool along and behind the front, and winds will be gusty. A chance of snow in the afternoon will mainly be contained to the eastern slopes of the Rockies, and lower areas behind the cold front such as Fort Nelson may see a mix of snow and rain.

Through Tuesday, other parts of the BC interior from Prince George to the Washington border will remain moist with showers and isolated thunderstorms due to a broad upper trough. The offshore low will move west of Port Hardy and spread showers to the west coast.

NWE PREOC remains activated to level 2

Regional District Bulkley Nechako (RDBN): A SOLE (expires Sept 13) is in effect for the entire Regional District.

Electoral Area C: 1 Alert remains in place due the North of Tezzeron Fire (G51632).

Electoral Area D: One Order in place due to the Island Lake Fire (R11921). An Order remains in place due to the Cheslatta Lake Wildfire (R11683).

Electoral Area E: 1 Order and 2 Alerts due to the Nadina Lake Fire (R21721) are now in effect. 1 Order and 1 Alert remain for the Verdun area issued due to the Verdun Lake Fire (R11796). 1 Order and 1 Alert in place due to the threat of the Tweedsmuir Fire Complex (71W19VC).

Cheslatta Carrier First Nation: A BCR remains in effect. 1 Alert for 8 properties remains in place.

Regional District Kitimat-Stikine (RDKS):

Electoral Area D: A SOLE (expires Sept 15) is in effect for the entire Electoral Area. 1 Order remains in effect for the Telegraph Creek area due to the Alkali Lake Fire (R91947). One Alert remains for 14 properties in the Caribou Meadows area.

Lake Babine Nation: 1 Alert remains in place due to the threat of the Torkelsen Lake Fire (R32182).

Nak'azdli Whut'en First Nation: A BCR and 1 Alert for 280 properties remains in effect due to the threat of the Shovel Lake Fire (R11498).

Nee-Tahi Buhn First Nation: 1 Order and 1 Alert for 5 properties each are in place due to both the Island Lake (R11921) and Verdun (R11796) Fires.

Skin Tyee First Nation: 1 BCR, 1 Order for 8 properties and 1 Alert for 8 properties are in place.

Tahltan First Nation: 1 Order for 128 properties remains due to the Alkali Lake Fire (R91947).

Tl'azt'en First Nation: 1 Alert for 225 properties remains due to Shovel Lake Fire (R11498).

Wet'suwet'en: 1 Order for 7 properties is in place due to the Nadina Lake Fire (R21721).

Yekooche First Nation: The one Order for 40 properties in place due to the Shovel Lake Fire (R11498) was verbally rescinded.

Electoral Area I: A SOLE (expires Sept 14), 1 Alert in the Chutanli Lake area in place. 1 Alert in the Bazaeko Blackwater Area.

Electoral Area I & J: 1 Order for 47 properties in the Shag Creek area remains in effect.

Electoral Area J: A SOLE (expires Sept 12), and 2 separate Orders for Tweedsmuir Park area and Klinaklini Lake area remains in effect. The Alert for the Whitton Lake area still stands. 1 Alert for 56 properties in the Dean River Valley remains in effect.

Central Coast Regional District (CCRD):

Area A/ Nuxalk First Nation: 1 Alert for 12 properties issued for CCRD Kimsquit/Dean River Channel area due to the threat of the Tweedsmuir Complex Fires (71W19VC).

Lhoosk'uz Dene (Kluskus) First Nation: 1 Order and 1 Alert remain in place due to the Chutanli Lake Fire (G41607).

Ulkatcho First Nation: 1 BCR and 1 Alert for approximately 360 people remains in effect for IR#14A.

Electoral Area B: A SOLE (expires Sept 14) and 1 Alert for the Snowy Mountain Range Land (no properties, livestock only) remains in effect due to the Snowy Mountain Fire (K51238).

Electoral Area C - Sportsman Bowl: A freshet related SOLE (expires September 17) remains in effect.

Electoral Area D: A freshet related SOLE (expires September 18) remains in effect.

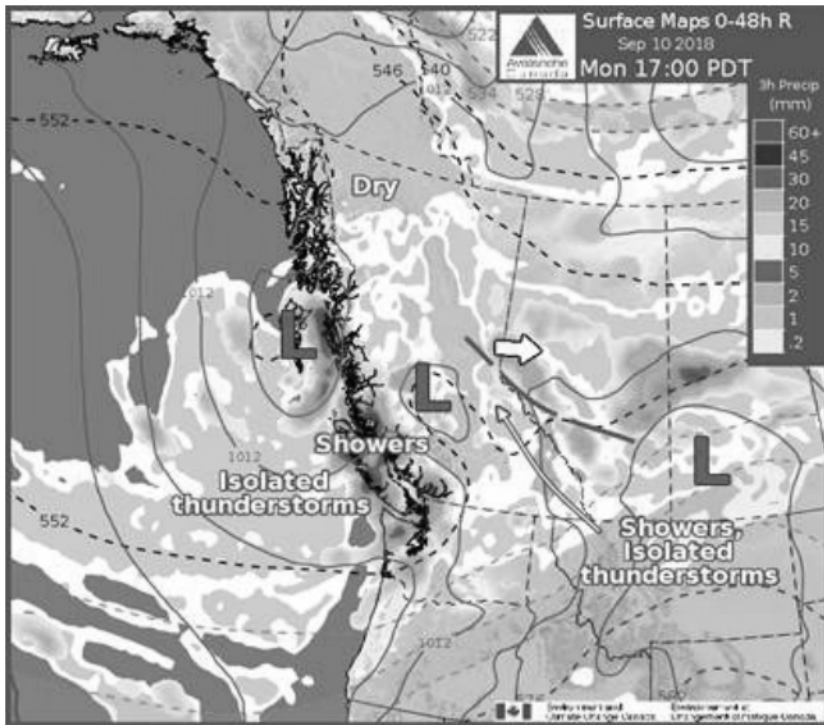

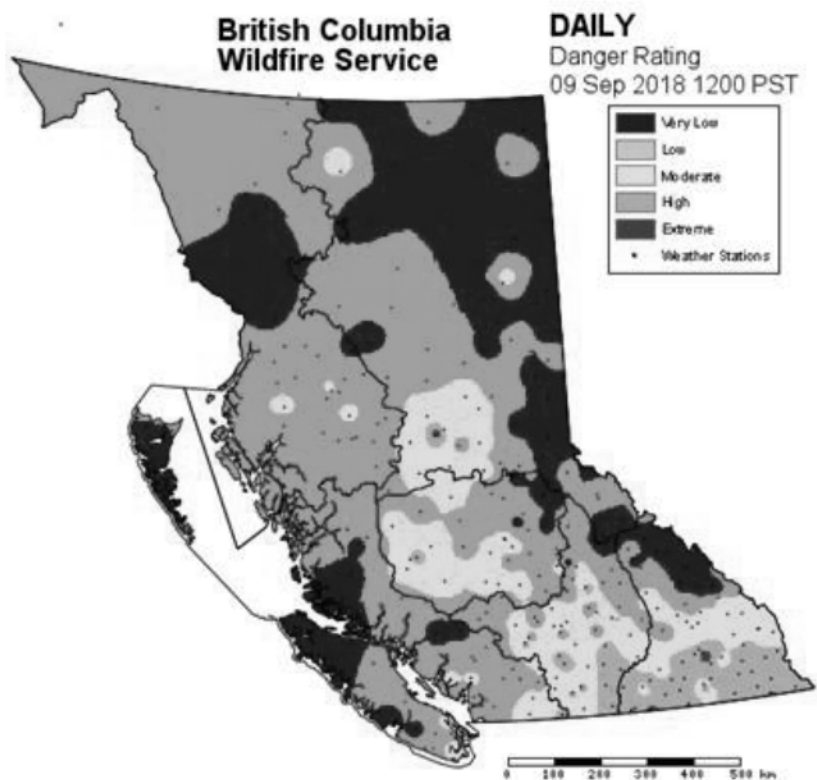
