Good to have seen you this morning, and thanks again for the presentation. As I mentioned earlier, I have a few questions I'm hoping you can help me with:

1. The rental housing task force was listed as one of the engagement projects your team was involved in. Can you let me know what sort of data was collected? We had face to face meetings where we collected specific ideas via sticky notes, and then an online discussion forum with Spencer Chandra Herbert, the chair of the Task Force. All the data is being rolled up into a report. That report is being finalized right now.
2. You mentioned your team has access to historic data. I'm wondering if there were any engagement projects related to reconciliation prior to the new government coming in, and if so, what kind of data is available? Nothing with a specific focus on reconciliation that I can think of.

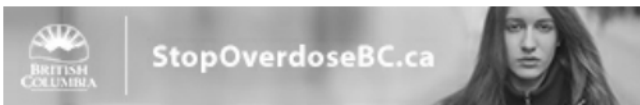
