

#### **General Info**

The BC Wildfire Service is internationally-recognised as a leader in wildfire management and is known for its skilled and committed personnel, uncompromising safety attitude, and innovative use of technology.

British Columbia's forests and wildland cover over 94 million hectares (nearly a million square kilometres) and are the most diverse in Canada. Confronted by an average of 2,000 wildfires each year, highly trained fire crews are successful in containing 94 percent of all wildfires (rank 1-4) in B.C. by 10am the following day.

Top priority in fighting wildfires is crew and public safety, followed closely by protection of property. The third priority is high environmental values (ie. Community watersheds, habitats of species at risk, etc.). The fourth priority is resource values (ie. Timber harvesting sites, resource extraction sites, etc.)

#### Why we sometimes let fires burn

- A naturally-occurring wildfire may be deemed beneficial to renew and maintain a healthy ecosystem. In these cases, crews will monitor and manage a fire, rather than fight it.
- Fire is a natural component of many ecosystems and when there is no immediate threats to life or property, we may allow the fire to burn so the benefits of fire in these ecosystems can be realized.
- This also frees up resources to put towards higher-priority fires.

#### Aircraft

- While airtankers and helicopters are a highly visible part of wildfire response, they do not put out wildfires. Rather, they provide critical support to our crews on the ground.
- The majority of wildfires in British Columbia are quickly contained and extinguished by personnel on the ground. For larger fires, or when access is difficult, aircraft may <u>assist</u> ground crews by dropping retardant, foam and/or water to help contain the fire.
- Helicopters perform many different tasks, such as dropping water on "hot spots", transporting personnel to and from the fireline, and giving BC Wildfire Service staff an aerial view of a wildfire.

#### Martin Mars Bomber

- While the BC Wildfire Service has called upon the services of the Martin Mars on previous occasions, officials have found that the Mars has limited applications compared to more modern aircraft and there are unique logistical challenges in using this aircraft. Whereas more modern airtankers run on easily accessible jet fuel, the Mars runs on leaded-type fuel, which is becoming increasingly scarce. The considerable size and design of the Mars means it can scoop from only 113 water bodies in British Columbia (where modern amphibious skimmers can access 1,700), and it is limited to landing on water (as opposed to amphibious aircraft that can land on water or tarmac). The Mars must be refuelled on water, which requires the installation of significant infrastructure while operating away from its home base in Port Alberni. These factors greatly reduce the operational flexibility of the Mars.
- Another important point is that the capacity of the Mars makes it difficult to integrate with fire
  suppression operations in the air and on the ground. The large drop pattern of this water bomber
  means that firefighters on the ground have to stop work until the drops are completed, which may
  increase the risk of a fire escaping during the critical attack stage. The targeting accuracy of more
  modern aircraft allows firefighting crews to take a more aggressive approach to fighting a wildfire and
  enables skimming aircraft to work in conjunction with retardant-delivering airtankers and rotary-wing
  operations.
- The Province of British Columbia maintains a fleet of 32 fixed-wing aircraft, including 16 airtankers, 8 birddogs and 2 parattack jumpships. The fleet includes AT-802 "Fire Boss" aircraft, which can skim up to 3,025 litres of water in 15 seconds. Sending the Fire Boss out in groups of four allows for a nearly

continuous circuit of aircraft dropping water if a source is nearby. Fire officials also have the option of dividing up the Fire Boss group to attack multiple targets at once, which is especially valuable when fighting a series of fires sparked by intense lighting storms. Lastly, if one aircraft must stop operating, the other three can continue firefighting.

When additional resources are needed, the province has contracts in place with several different
companies for firefighting aircraft, fixed-wing and helicopters, including the Coulson Group. The
province can also make use of long-standing mutual aid sharing agreements to bring in aerial
resources from other agencies. Through these agreements, the province has the ability to increase its
air tanker capacity significantly this season, as and when needed.

The province is currently reviewing the recommendations of the independent 2017 BC Flood and Fire review report, *Addressing the New Normal: 21st Century Disaster Management in British Columbia*. The report is available online at <a href="https://bcfloodfirereview.ca">https://bcfloodfirereview.ca</a>. The report's recommendations will play a significant role in determining how British Columbia approaches wildfire risk reduction, including firefighting technology and aerial resources. The province will be releasing a response in October 2018.


