Ministry of Social Development and Poverty Reduction:

- \$100 increase in income and disability rates
- \$200 increase in earning exemptions
- Fully restoring the BC Bus Pass program
- Developed a feasibility study to explore basic income
- Appointed Minister's Advisory Forum on Poverty Reduction, and engaged in a province-wide consultation to inform the poverty reduction strategy

Federal government:

- Canada Child Benefit
 - Introduced in 2016, increased in 2018 to keep up with the cost of living
 - Provides a tax free monthly payment to families with children under the age of 18
 - Income tested, so lower income families receive higher payments
 - The maximum annual amount for families with children under the age of 6 is \$6,496 and for children aged 6-17, the maximum annual amount is \$5,481
 - In July 2018, the federal government said this benefit has lifted more than 300,000 children out of poverty in the two years since it was first implemented

I suggest you proceed with directing the Ministry program areas to address the comments from CABRO and TBS and if PAO requests more information or changes mid next week, we can figure out how/if deadlines need to be revised to allow time for Ministries to address those issues.
