Hi Allegra,

To my knowledge we have not received any written correspondence from this gentleman however, he does call our office regularly to voice his concerns re BC Housing and many other issues.

Often in his calls he speculates that BCH is picking and choosing applicants and giving priority to individuals that do not need the housing as badly as the people he knows. He then gives us a time limit on how long we have to start providing housing to him and the individuals he knows and advises he will stage a protest if the time limit is not met. We've connected him to BCH and had staff explain the process of offering housing to applicants and discuss his own file. We've

also provided him with the contact information for the ombudsperson if he feels the information we have provided is unsatisfactory.

We still hear from him regularly and when he calls I attempt to address his concerns/direct him to resources, feel free to redirect his calls back over to MAH.

The OCIO is applying eligibility criteria for workstation orders effective immediately, as per <u>Service Bulletin 1115</u>. Below is a summary of some of the points, and information on what this means for you as a Site Contact:

Current Workstation Eligibility Criteria

- Only government employees and BPS clients are eligible for government-provided workstations
- Employees are eligible for one workstation only
- Contractors are not eligible for voted workstations; exemption may be granted with cost recovery to the requesting ministry

What this means if you need to order a net-new workstation:

- Continue to attach a completed <u>Workstation Justification Form</u> (also found on our Service Request form) to your request. It has been updated as follows:
 - Now includes the above workstation eligibility criteria to highlight if an Eligibility Exemption will be requested
 - Requires additional information to identify government employees
 - A CHIPS employee ID will be required for existing employees
 - A CHIPS position number will be required for net-new employees and employee numbers within
 60 days

What this means if you need to order an additional workstation:

- The new <u>Eligibility Exemption Request Form</u> must be used to apply for a Workstation Eligibility Exemption (i.e. additional workstation for user that already has an assigned workstation)
- A recoverable TCA (coding) is required
- Exemption Requests will be reviewed by the OCIO and decisions made monthly

- You will need to attach a completed <u>Workstation Justification Form</u> as well as a completed <u>Eligibility Exemption</u>
 <u>Request Form</u> to the Service Request.
 - The FIN IMB Service Desk will follow the instructions outlined in the bulletin to obtain approval for the additional workstation. We will advise when approval has been obtained, confirm the recoverable TCA, and will then proceed with submitting the iStore order.

Additional Information:

- We will be updating our Service Request forms so there will be one for Net-New Workstations, and one for Additional Workstations with instructions and links to the appropriate forms.
- As we receive more information and clarification I will share this information with you and update our forms accordingly, including but not limited to:
 - o When is the cut-off for getting a form reviewed for that month?
 - o What does recoverable TCA mean?
 - What does "A CHIPS position number will be required for net-new employees and employee numbers within 60 days" mean? Do we need to provide an employee number when available?
 - o What does this mean for loaner/test machines?
