Hi Fazil and Jill,

Following discussions between Ministries and with Cabinet over the past several months^{s.12} and particularly about the placement of the Integrated Data Office (IDO), I am writing to inform you of the decision and the rationale that underpins it.

As new technologies continue to generate ever-growing amounts of digital data, protocols surrounding the safe custody and appropriate use of data entrusted to government agencies are becoming increasingly important. This applies to information held directly by government ministries, and to data held by organizations that receive public funding and deliver programs or services on our behalf. Our data interfaces with British Columbians are evolving, and technology is presenting us with new opportunities to use citizen and resource data to optimize internal programs and services. Commercial collection and use of data to drive business intelligence is growing as well, with some exceptional successes and some notable privacy breaches. As you will know, Ottawa initiated consultations on a national data strategy earlier this week which are intended to address growing public unease with some of the ways that data is being accessed and used by business interests. For all government agencies, data, information management and technology advancements will be increasingly complex fields of practice in the years ahead.

The Ministry of Citizens Services (CITZ) and Ministry of Jobs, Trade and Technology (JTT) have important mandates for information management and for economic and technology sector development. As it relates to IDO, the decision has been made to transfer IDO and the related Data B.C. operation to CITZ. This decision respects the importance of being able to continue the valuable work IDO does to improve the delivery of government programs and services, while ensuring that the organization is seen to be distinct from the technology sector development and tech sector data commercialization interests that are addressed within JTT. B.C. Stats will remain with JTT. It is my expectation that collaboration between these units will continue. The presentations, analysis and documentation of IDO's potential and its organizational history were appreciated. While IDO needed time to reorient itself away from the data commercialization intentions of the former administration, it is a program that does valuable work that offers promise to improve government programs and services. I hope this decision will give IDO a solid organizational footing from which to continue its momentum. The Integrated Data Deputies Committee has been helpful in developing a shared understanding of how the program will operate, and I would like to see that continue.

Jill and Fazil, I would ask that you meet in the near future to develop an implementation approach and that you follow up with me and with Lori Halls as quickly as practical after that to confirm your related organizational plans.
