



All combos just result in Siri turning on. I believe there is something wrong with this device, because as PREM TECH has documented, it actually doesn't turn off when you do any of the things that should make the device turn off.

Because I have created a record (photos I sent you) and saved it to a government server, I have cleared my text messages on the device (they were transitory to begin with but I have created and sent you a record since the FOI request came first). The network is composed of SUCCESS, the National Association of Japanese Canadians, Nikkei Seniors Healthcare and Housing, and Progressive Intercultural Community Services (PICS).

Roundtables typically take between 60-90 minutes, so we could potentially extend the visit to SUCCESS to include the roundtable with the network members and the tour of the facility.
