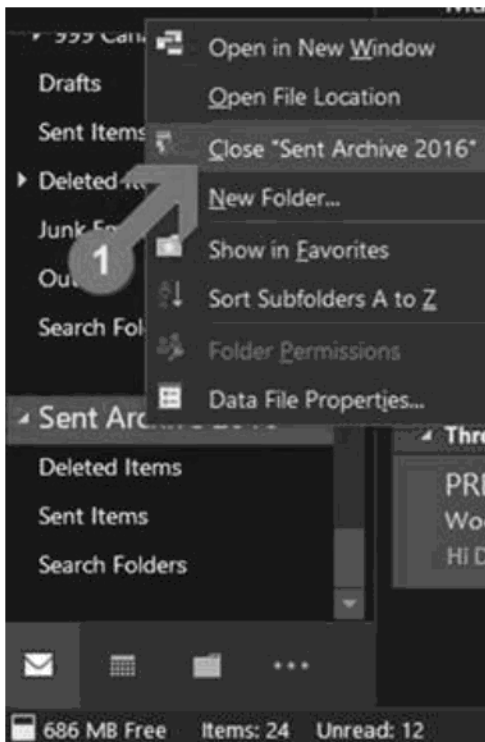

Further to our conversation, based on the Wildfire and Flood recommendations, 22 of 108 recommendations relate directly to working with Indigenous governments and communities, 24 relate to land stewardship and 22 relate to coordination, it would be prudent to consider for the lead role that preference be given to Indigenous People. In the spirit of Reconciliation, and it would be preferential to consider this statement in Bold Preference will be given to applicants who self-identify as Indigenous as per Section 41 of the Human Rights Code, similar to what we did for the Indigenous Initiatives Lead.

Some of the Indigenous Relations Behavioral Competencies that we selected for the Collaborative Stewardship Framework include:

- Change Leadership
- Collaborative Planning, Organizing and Coordinating
- Managing Organizational Resources
- Building a Trust-Based Relationship
- Promoting Accord

Hi s.22

It was really good to see you yesterday! I hope this message finds you well! In follow up to our conversation, here is some information about the Adverse Childhood Experiences study (ACES). If you are aware of the exercise of the privilege walk, this would be the continuum from the other end of the spectrum. Dr. Felitti discovered that of people had four or more of 10 adverse childhood experiences there were more like to have more health determinants like obesity, auto-immune, strokes and were likely to die about 15 years earlier. Adults with 6 or more adverse childhood experiences were also like to attempt suicide. Perhaps you are aware of this information already? If not, I am sharing.

Alberta has developed free curriculum training about the brain story. I am on module 8. Here is a youtube video about it. <https://www.youtube.com/watch?v=LmVWOe1ky8s>.

ACES has huge implications right into high school, here is a great documentary on transforming high schools; <https://acestoohigh.com/2014/12/02/paper-tigers-trailer-a-peek-into-documentary-about-lincoln-high-school/>

WA. Lincoln was the first high school in the country to integrate trauma-informed and resilience-building practices, which resulted in an 85 percent decline in suspensions and a 40% decline in expulsions after the first year. After four years, suspensions had dropped 90 percent, expulsions dropped to zero, and graduation rates increased five-fold.

The initiative is grassroots, and implementation of using the ACES questionnaire and then having doctors in the meetings, ask the patient, how they see that childhood experience impacting them and their health today had huge positive impacts have been reduced hospital and doctors' visits as well as cultivating resilience. There is also an initiative to "Blackfoot" -ize it.

A lot of this is something our indigenous cultures and knowledge recognizes. A lot of their figures (triangles) could be supplemented by an indigenous perspective. If one were to take a birds eye view of a triangle structure, it would be circular, and could invite space for indigenous perspective and knowledge into the framework.
