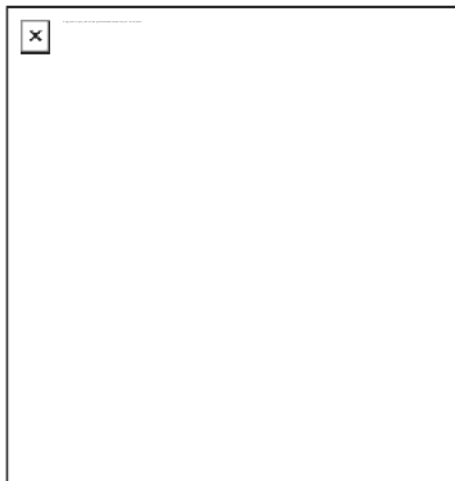

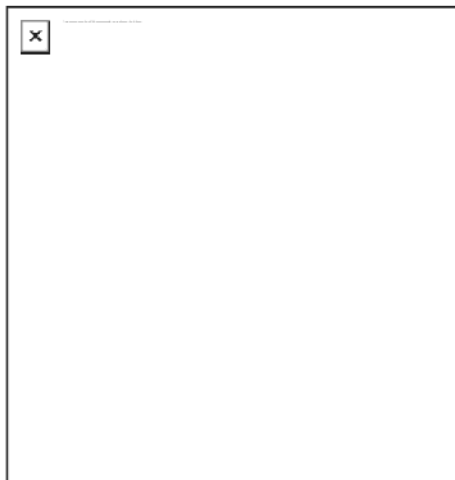

Community initiative in the wake of the violent murder of Surrey teenagers

Surrey - On June 4th, 2018, Surrey teens Jaskarn "Jason" Singh Jhutti, 16, and Jaskaran "Jesse" Singh Bhangal, 17, were found dead from gunshot wounds in the locality of 192 Street and 40th Avenue in Surrey.

With these callous murders, two more names were added to a list of over 300 South Asian males whose lives have been lost to gang violence in the past two decades. The age of the victims in last week's senseless killings has the community reeling in shock. Within the outpouring of grief and fear over this latest tragedy there is a palpable sense of trauma, that a crisis point has been reached and that something must be done to wrestle our youth from the clutches of this deadly criminal lifestyle. In response to this, we as concerned individuals, from a variety of non-partisan backgrounds, have come together to seek a critical intervention comprising both long and short-term measures to save the lives of our children.

As volunteer grassroots activists, it is neither our intention nor objective to represent a community or people. We are simply a group of concerned residents who feel it is crucial to ensure that preventative and proactive steps are taken regularly to understand and counter the epidemic of regional gang violence. We have begun round-table discussions, with experts from law enforcement, educators, counsellors, mental health workers, parents and the students themselves to understand the issue better. We realize that this disease affecting our community is a problem two decades in the making, and seeking overnight solutions will be gullible, and hence our approach must be nuanced, holistic and thorough.

Wednesday, June 13 at 6PM 'Wake Up Rally is taking place at 13450 104 Avenue. A community is in grieving, and where we must together seek solutions, we must also begin to heal together, and understand the challenges our kids face on a daily basis at school and outside.

We realize that the process will take time, and we are committed to the creation of a multi-stakeholder committee to ensure that this becomes a "living issue" and not a reactive exercise to violence in our community. Solutions must be preventative and proactive, and measures must be taken regularly to address the threats confronting our youth. Mandatory participation from the Mayor of the City of Surrey, Chief of Police for Surrey RCMP, senior leadership from the Surrey School District, other elected officials and members of the public with expertise in relevant subject areas (mental health, social work, counseling, threat management, to name a few) will ensure that a structure exists that holds stakeholders and participants accountable for the well-being of our children in Surrey. The situation has reached a crisis level threatening to corrode a thriving community which many have sacrificed and worked hard to build and sustain. Concern, frustration and anger must be replaced with collaboration, corrective action and implementation.

Dear Mira,

I am looking forward to meeting you and your colleagues.

I am happy to introduce our work and hear more about the priorities in BC. I have met and discussed this work with the Minister and senior climate change teams in Alberta, New Brunswick and with John Moffet and the federal team in Ottawa. I attach some information about us.

We want to maximise our effectiveness so it is important that our research findings are useful to you and applied in your work. I would also like to explore any opportunities to work directly with you on their application or other possible joint projects (we have worked extensively in Europe at a senior government level).

We have two major projects underway which will, I am sure, be very relevant in BC. You may have received some information on this already from Tzeporah:

a) Albertan Narrative Project

Climate Outreach has trained and supported 40 Albertan partner organizations to run discussion groups across a wide cross section of Albertan society to design and test climate change narratives. We believe this may be the largest qualitative participatory communications design project ever tried on climate change. I will be in BC following the final 2 days review with the partners and can report on both the innovative methodology and initial findings. In particular I want to present the project with a view to running a similar approach in BC, possibly as part of a national project in 2019. There is already strong interest and substantial initial funding for a national roll out.

b) Communicating Carbon Pricing- Climate Outreach has been commissioned by the World Bank Carbon Pricing Leadership Coalition to produce the first ever guide on how to communicate carbon pricing (both Tax and ETS). This work is also at the first draft stage and George can report on its initial findings.

The final outputs from both of these projects will be launched in September and I will happily share them with you then. But I also thought they might be relevant and useful before then.

Regarding a time to meet, I am free all morning. I need to be on a plane to Calgary at 3pm but I am otherwise currently free up to that time (and allowing a reasonable time to get to the airport and check in).

I now about to go on the move so can pass over to my colleague Tara Clarke (tara.clarke@climateoutreach.org) for any further information you might need about me and our work and to sort out a good time for me to come.
