BC Legislative Internship Program:

- operated through the Legislative Assembly
- open to BC residents who have recently received a Bachelor's Degree
- runs from January to June
- student have placements in both a party caucus as well as a ministry

- You should wear a short-sleeved top to the clinic.
- You should plan to remain at the clinic for 15 minutes after being immunized.
- Plan to arrive at least five minutes early.

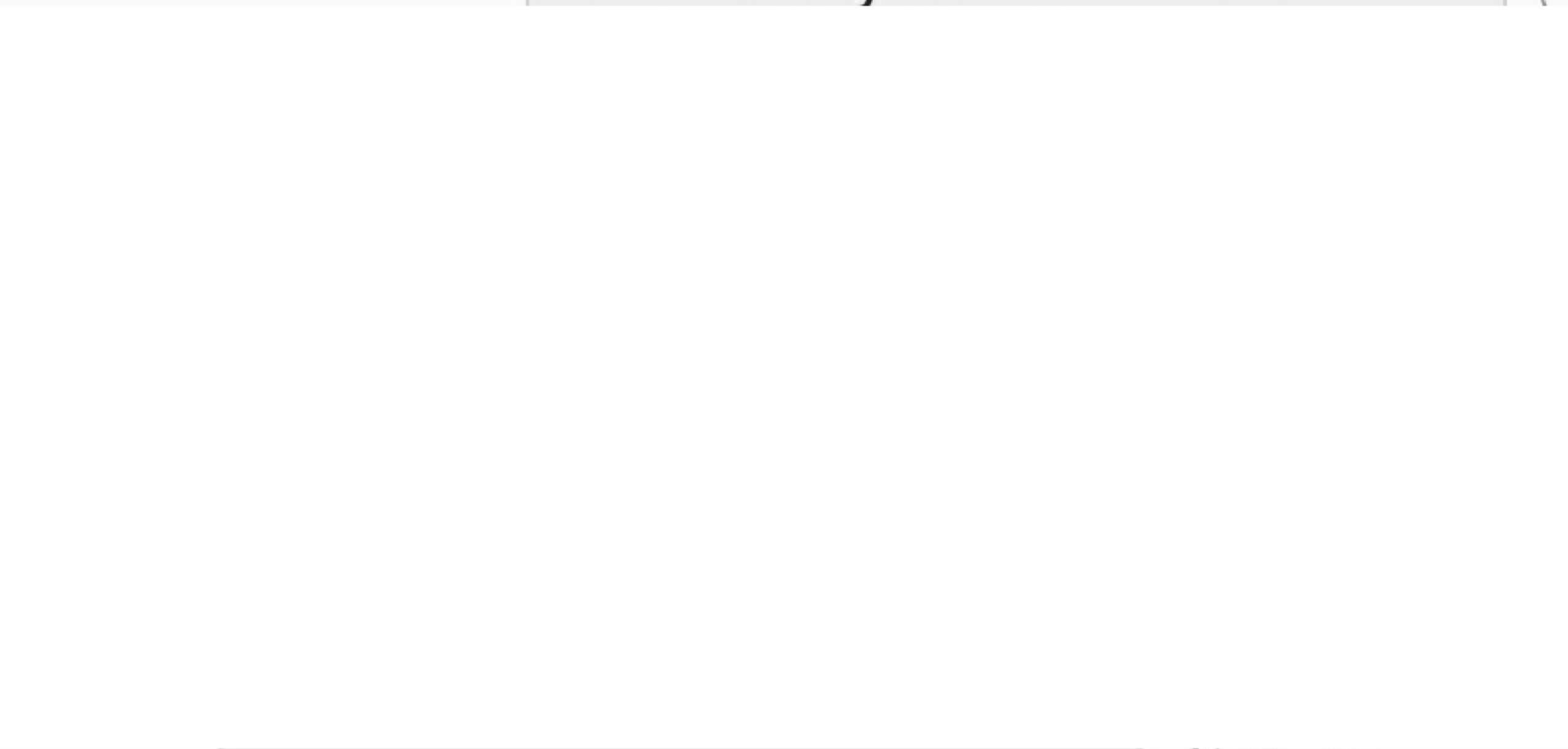

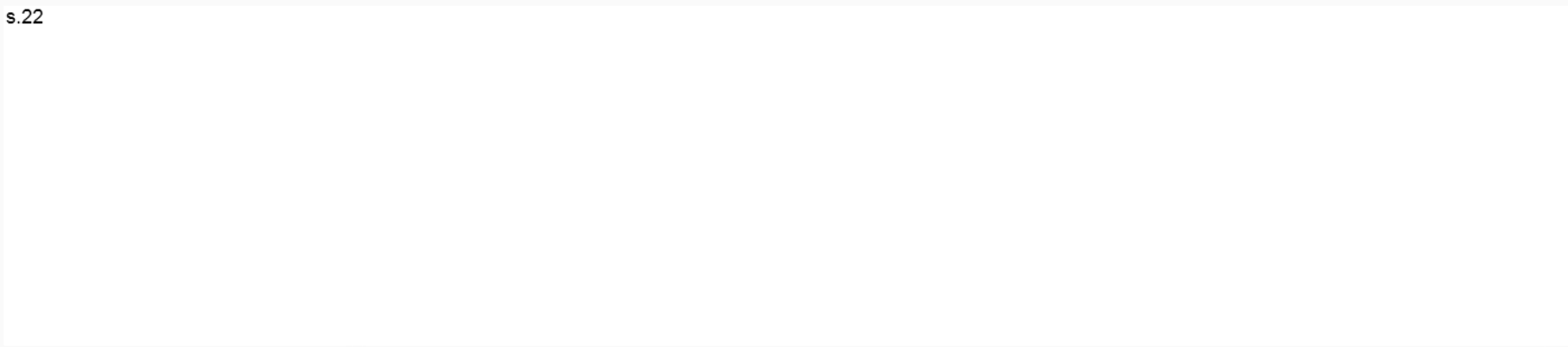
