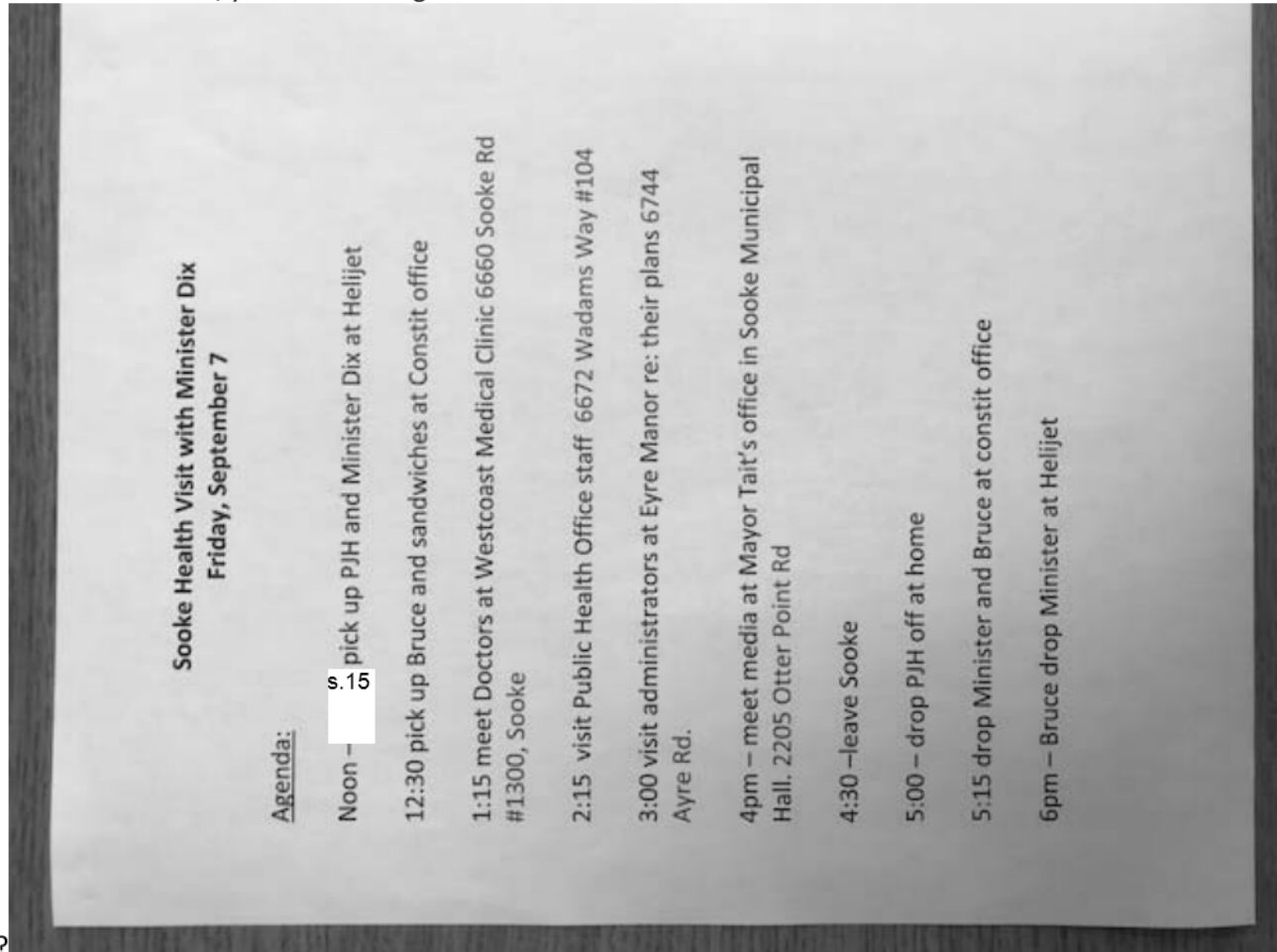

Brief overview:

The Eagle Spirit Energy (ESE) Chiefs Council represents 35 First Nations from coastal First Nations near Prince Rupert in Grassy point B.C. to First Nations in Fort McMurray AB. For the past six years the ESE Chiefs Council has been working on the ESE corridor project (the “Corridor”). The Corridor will transport both LNG-NGL and upgraded crude oil from the Coast in B.C. It will be able to accommodate future pipelines for the transportation of LNG and partially upgraded bitumen. It represents the only opportunity for our communities to generate sustainable own-source revenues which would allow us to solve our own problems. It is the greenest project on the planet through Indigenous Environmental stewardship. Given our concern for the environment, we have developed the best-in-class environmental model using state-of-the-art spill prevention and response procedures to protect the coast, significantly exceeding the standards of the Oceans Protection Plan. The Eagle Spirit Energy (ESE) Chiefs Council represents 35 First Nations from coastal First Nations near Prince Rupert in Grassy point B.C. to First Nations in Fort McMurray AB. For the past six years the ESE Chiefs Council has been working on the ESE corridor project (the "Corridor"). The Corridor will transport both LNG-NGL and upgraded crude oil from the Coast in B.C. It will be able to accommodate future pipelines for the transportation of LNG and partially upgraded bitumen. It represents the only opportunity for our communities to generate sustainable own-source revenues which would allow us to solve our own problems. It is the greenest project on the planet through Indigenous Environmental stewardship. Given our concern for the environment, we have developed the best-in-class environmental model using state-of-the-art spill prevention and response procedures to protect the coast, significantly exceeding the standards of the Oceans Protection Plan. 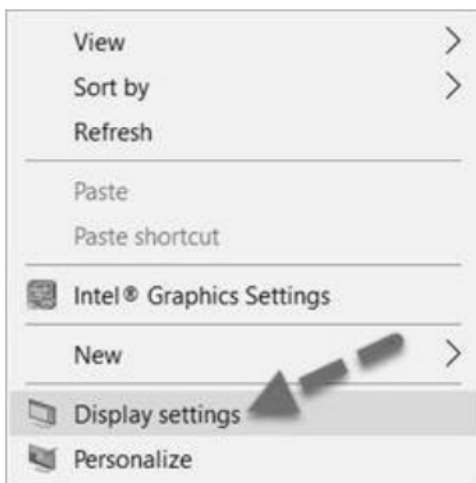

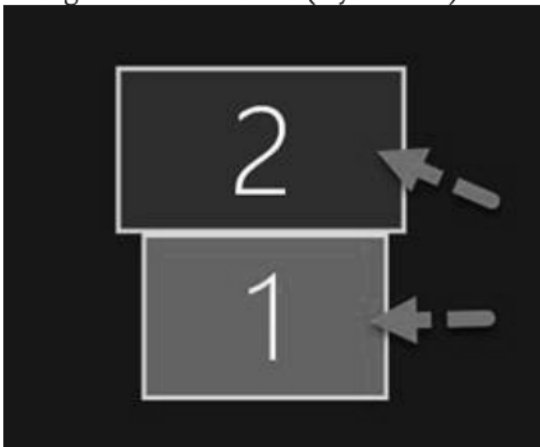

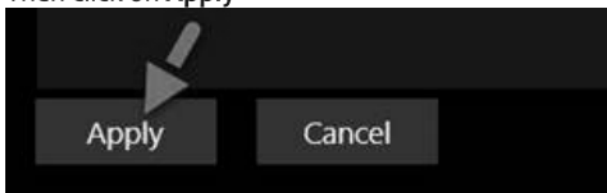

Disciplinary Hearings for Mt Polley Engineers

Background:

- At 1pm on Wednesday, the Engineers and Geoscientists of BC are announcing disciplinary hearings for three individuals related to the 2014 breach of the tailings storage facility at the Mount Polley Mine.
- The disciplinary hearings follow an extensive investigation by the regulatory body which alleges the three individuals involved in the design, construction and monitoring of the tailings facility were negligent.
- The allegations are not yet proven. A disciplinary panel will hold hearings in 2019 and could impose sanctions including reprimand, restrictions, suspension, cancellation of membership or a fine up to \$25,000.
- The Province continues to assist the Federal government in its investigation which could result in charges against the company under the federal Fisheries Act.

Message:

- The Mt Polley tailings pond failure was an unprecedented disaster that never should have been allowed to happen.
- I'm aware of the findings and recognize that they are not yet proven. I will let that process play out without direct comment.
- But this situation helps underscore the importance of our review of professional reliance.
- British Columbians should be assured that a strong, transparent process is in place that upholds the public interest and high environmental standards.

Why were no provincial charges laid if the regulatory body found negligence?

- The Province continues to assist the Federal government in its investigation which could result in charges against the company under the federal Fisheries Act.
- Potential penalties under federal legislation are significantly higher than those under provincial acts.

Dear Selina, Carol, and John.

First, please accept my sincere gratitude for the time and energy that you have (and will!) invest in the flood recovery process. Your attention is important for--and appreciated by--the community.

I wanted to recap our conversation from today, Carol, and ensure that the others understand where we're at as well.

We need a decision on the emergency housing, which is about a \$3 million proposal that includes (1) temporary mobile units, (2) hotel/motel/short-term rental financing, (3) existing rental unit financing, (4) rental unit mobilization and development, (5) restoration financing, and (6) administrative support for all this.

We don't want this proposal to get hung up on other funding decisions that it's saddled to, because it's getting dangerously cold. Other decisions (e.g. the need for case-managers for wellness supports) are equally critical to recovery process and the well-being of the community, but we need each decision point to not be slowed by independent obstacles.

In parallel, our Provincial recovery framework is lacking a forum for strategic policy dialogue. While the PDRB and EMBC processes are delivering effective operational conduits between local and provincial activities, we are not setting clear vision, objectives, and outcomes from the political level to guide those operational decisions. In other jurisdictions (countries) such a liaison exists to help deliver those guiding principles for operational delivery. This would assist in ensuring alignment of solutions that are developed internally with needs in the community, and monitoring success for our shared objectives. This is particularly something to consider from the Premier's cross-ministry perspective, John. Let's work on this?

As a case-in-point, the emergency housing decisions ought to be tested against some agreed policy objectives such as (a) saving lives and improving health,

- (b) financial accountability and saving money,
- (c) Creative strategies to deliver permanent solutions, and
- (d) respecting legislative obligations.

I have been an ardent supporter of our partnership with the Province, as well as the receptivity, openness for creativity, support and patience that you at the Province have exhibited. There's some strain on that recently, but I still really believe that we're charting a productive path forward as a Provincial "disaster recovery guinea pig" that will end with a better future for both the future model of recovery and our communities here and now. Thank you.
