Recent discussions around the proposed repeal and replacement of the BC Environmental Assessment Act have been brought to my attention. I understand we are at an impasse regarding a legislated consent-based environment assessment process and a meeting is being planned with the First Nations Leadership Council and yourselves. To prepare for this meeting I am attaching a recent United Nations study of

the Expert Mechanism on the Rights of Indigenous Peoples titled, *Free, prior, and informed consent: a human rights approach*.

I am aware that some government officials are pressured by industry organizations to refuse to use a consent-based mechanism in any new legislation. They view consent as a veto and this approach is counter-productive to reconciliation. Seeking consent is a term which we are very concerned about. We must collaborate to find a solution prior to the introduction of this legislation.

I look forward to our upcoming meeting.

Recent discussions around the proposed repeal and replacement of the BC Environmental Assessment Act have been brought to my attention. I understand we are at an impasse regarding a legislated consent-based environment assessment process and a meeting is being planned with the First Nations Leadership Council and yourselves. To prepare for this meeting I am attaching a recent United Nations study of the Expert Mechanism on the Rights of Indigenous Peoples titled, *Free, prior, and informed consent: a human rights approach*.

I am aware that some government officials are pressured by industry organizations to refuse to use a consent-based mechanism in any new legislation. They view consent as a veto and this approach is counter-productive to reconciliation. Seeking consent is a term which we are very concerned about. We must collaborate to find a solution prior to the introduction of this legislation.

I look forward to our upcoming meeting.

**Brief overview:**

The Eagle Spirit Energy (ESE) Chiefs Council represents 35 First Nations from coastal First Nations near Prince Rupert in Grassy point B.C. to First Nations in Fort McMurray AB. For the past six years the ESE Chiefs Council has been working on the ESE corridor project (the "Corridor"). The Corridor will transport both LNG-NGL and upgraded crude oil from the Coast in B.C. It will be able to accommodate future pipelines for the transportation of LNG and partially upgraded bitumen. It represents the only opportunity for our communities to generate sustainable own-source revenues which would allow us to solve our own problems. It is the greenest project on the planet through Indigenous Environmental stewardship. Given our concern for the environment, we have developed the best-in-class environmental model using state-of-the-art spill prevention and response procedures to protect the coast, significantly

exceeding the standards of the Oceans Protection Plan. According to an exhaustive federal governmental study (see: <https://bit.ly/2Pdl4RP>), the Corridor has the best and most environmentally-safe port location on Canada's west coast.

As well, the Corridor has:

- Preliminary financial commitments from one of the largest national oil companies in the world
- Executed agreement with Canada's Four Craft Pipeline unions – who represent over 330,000 members from the International Union of Operating Engineers (Canadian Piping Trades), the Labourer' International Union of North America (LIUNA), the United Association Canada, and Teamsters Canada

On the Thursday August 30 Weekly EMBC Operational Wildfires Update Call, meeting participants received a very brief update on the provincial government's efforts to coordinate cross-ministry work in response to the report by Chief Maureen Chapman and George Abbott titled "[Addressing the New Normal: 21<sup>st</sup> Century Disaster Management in British Columbia](#)." As of August 27, I have been asked to assist in coordinating the province's response to, and implementation of, the recommendations.

A comprehensive and meaningful response to the report's recommendations will not be possible without working with Indigenous governments and communities.

The provincial government has committed to release an initial action plan (e.g. a high level approach) to the report's recommendations by October 31, 2018. However, this initial action plan is not intended to constrain future options, discussion, or engagement.

In the coming weeks, it would be very informative to have initial input from the First Nations Leadership Council regarding appropriate methods for future engagement on this initiative. If a short briefing and discussion would be useful, please let me know if there is a contact that I can work with regarding your availability, or if it is preferred for this item to be incorporated into another regularly scheduled meeting opportunity. Further, if it would be useful to have presentations on this topic at meetings with members of your respective organizations during the Fall, and/or at the First Nations Leadership Gathering, we would be happy to accommodate such meetings.

Gentlemen ... I am following up for Dr. Dick Beamish as we have now received confirmation of the federal governments contribution to the International Year of Salmon research cruise in the North Pacific, March 2019. DFO will provide \$250K to

bring our confirmed funding up to \$700K (\$\$ from federal government, a group of BC salmon farming companies, a private donor, and the Pacific Salmon Endowment Fund). A confirmation of \$250K from the Province of BC will ensure the vessel contract can be signed and planning for the research to commence. I am also writing now as we have hopes to complete funding details before the annual meeting of the North Pacific Anadromous Fish Commission meetings that begins next week in Khabarovsk, Russia! This date is important as we will have to plan and make several alterations to the vessel and its power supplies in order to support our science equipment and laboratory needs.

I should also relay that Russia has agreed to modify the original cruise plan to allow the vessel to complete the study by returning to Vancouver, B.C. for a few days before returning to Russia. This will be a great opportunity to profile the studies and collaboration between funders (late March 2019).

The Pacific Salmon Foundation is assisting by holding the funds for the contract, so any questions on process for transferring funds should be directed to Mr. Tim Sucic who I have included in this email.

At this time we really need the commitment of the Province to provide the \$250,000; we can work on receiving the funds later. Any assistance is greatly appreciated, but we really are now down to your commitment so we can proceed. Thanks.

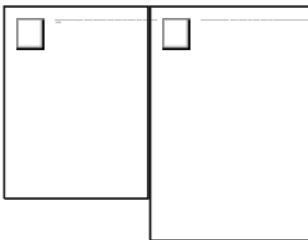
