Hi Monica,

Just a quick note to provide a few thoughts on next steps. I understand the desire to ensure that Government is moving forward on considering and implementing recommendations (and able to demonstrate it is doing so). The Working Group will also need to align with Stephanie's process. It would be helpful to better understand the Premier's Office's process; e.g., timing, leads, coordination and engagement process, anticipated outcomes.

You may want to spend some time meeting with ministry contacts individually (shake the trees, a bit) to fill out the table and brainstorm the 'how' of partnership on these recommendations. It would also be helpful to understand how ministry executives have been engaged.

Very few of the Abbott/Chapman recommendations fall directly within MAH's sphere of responsibility. I've created a draft annotated table of the recommendations that are of most interest to our Ministry; many of these would see us in a supportive role (e.g., facilitation, advisory, etc.). Our executive team will be considering the finer details regarding timing, level of engagement, resources required and we will provide these to Stephanie.

Thanks for coordinating. I echo Caitlin's appreciation for the opportunity to coordinate on an inter-ministry basis.
