Thanks for the call.

Minister Chow brought forward the idea of an MOU between the City and Province to pursue the idea of a Museum in Chinatown.

A draft of the MOU is in the works (headed by Dr. Henry Yu). This would be a high level MOU that speaks to values alignment (eg. UNESCO heritage status for Chinatown, apologies for Chinese Head Tax and Historical Discrimination, recognizing the importance of the Chinese Canadian contribution etc.).

Minister Chow wanted this to be signed on BC Day long weekend. The Mayor and I thought that since the main stakeholders will already be present on July 29<sup>th</sup> for the BC Artscape opening, it may be an opportunity to do both – celebrate the opening and sign the MOU.

I haven't seen the MOU yet but I wanted to gage your Office's interest with this idea.

- Form it around a project (ie. Development of a policy, implementation of an initiative, writing a report) so that there is a defined mandate and timeframe.
- Smaller working groups could be included to ensure cross cutting issues such as: newcomers, gender equity, urban/rural, BIPOC, etc.
- Highlight and include marginalized voices
- An Open call for nominations is an engagement exercise of its own – an opportunity to build intentional relationships
- Representatives are mentored as leaders and community organizers
- The Council acts as ears on the ground for issues in their communities, and can communicate relevant government initiatives to their community

Most recommended Model for Youth:

Points on the British Youth Council

- Registered Charity/Non profit in the UK
- Has a Young Mayors program (and youth parliament and youth standing committee – same framework of any young person 11-18 voting for them).
- The youth parliament has 300 elected Members aged 11-18. Annual youth elections throughout the UK. In the past 2 years 1 million young people have voted.
- To a large extent the elections take place within the schools in each of the project areas.
- Mayor's make decisions with the support of 25 young Advisors (made up of runners up or other nominated people)
