All local governments, including the Capital Regional District, were notified by circular to the CAOs on June 6<sup>th</sup>, 2018 just after the EQ program opened for intake (May 31, 2018).

ICIP-EQ has conditional access to the funding for a non-local government water system. Applications from improvement districts or water utilities must be made by the sponsoring regional district or municipality. If the application is successful in obtaining program funding, the ownership of the infrastructure and associated assets must be transferred to the sponsoring regional district or municipality.

Unfortunately, the Municipal Finance Authority (MFA) is limited to providing financing to municipalities and regional districts.

Hi John,

We meet a few months ago prior to the election regrading Site-C and solar as an alternative. To remind you, I am part of a alternative energy worker's cooperative based on Vancouver Island. Since our inception have have installed approximately 1.5 Mega-Watts of solar in BC. I live in Sooke.

**In spring, BC Hydro - with approval of the BCUC - curtailed the net metering policy to limit solar capacity to annual electrical consumption.** This ended the ability of British Colombians to build - at their cost - and generate and income from small renewable energy facilities such as solar farms.

This is clearly the wrong direction to go for the environment, for a green future, for our kids, for innovation, for job creation, and for entrepreneurship in BC. It is neither forward-thinking nor driving to a net zero / carbon neutral future. It is blocking individual our ability to supply surplus electricity to neighbours and within our own communities.

**Here are some thoughts to improve the net metering program for BC Hydro and British Columbians:**

- The BCH net metering (net billing) program is one of the better ones in terms of ease of application and simple technical and legal requirements;
- I don't disagree with BCH's position on overproduction on an annual basis since the program was not intended to be a source of revenue for home or business owners. However, there are many who would like create a revenue stream from renewable energy at levels below 100 kW. So I believe there should be a separate program or policy to address that;
- The policy on overproduction was implemented hastily and without Virtual Net Metering or some other way for communities, housing co-ops or other organizations to build larger systems that feed a single meter - thus creating economies of scale - but that share the benefits with multiple investors who have separate meters, net metering is only for those privileged with the finances to make the up-front investment; and
- The program should have a contract or other assurance to customers that the program will not be cancelled or changed in such a way that customers end up with stranded assets.

**I would like to speak with you to discuss the above with the goal of promoting renewable energy within our province.**

I am puzzled as to why the Saskatchewan\Alberta option for the lotteries is not being considered? The system is so superior to the current BC one that it seems like a logical way to go. The lottery system is not where the money laundering has been happening. By moving the lotteries over to the non-profit sector the government can focus on the casinos. They would also keep the revenue from the casinos under their directed control. The government can still provide direction to the lottery system through its license agreement. The original intent of the lotteries in the beginning was to support the charitable sector, BC watered it down over the years with eventually the Harcourt government moving all the funds into general revenue.

Changing to the Saskatchewan model would be something that transcends one term and would become a long term legacy of your government. This would be actual structural change that improves the lives of British Columbians. I should point out that this system has been supported by all governments in Saskatchewan, be they from the left or the right, because it works!

Dear Premier Horgan and others,

Once again I have a question for you about culture. We have heard a number of times about the problem of money laundering through the casino system. As you know, I believe that the way the lottery system is run in Saskatchewan and similarly in Alberta is a great model that is far more effective than the BC system. The non-profit sector under license from the province in Saskatchewan run the lottery system, with three umbrella organizations SaskSport, SaskCulture and SaskRec providing the support to their respective sectors. The province is able through the licensing process to make sure issues and priorities that they have are addressed. For the non-profit sector it means much better response to funding issues, it means strong organizations that are much more than funders.

So back to the casino situation. In Saskatchewan, casino's are not part of the lottery system that the non-profits run, they are still under the direct overview of the province. I would suggest that handing off the lottery and granting function to a Saskatchewan model would level the government with the ability to focus on oversight of the casino system.

Will you take a hard look at the benefits of the Saskatchewan model for the lottery system?

Thank you Maureen for the reply to my email. Of course I am very disappointed in my party and the government for this decision. Allow me to make both a comment and an alternative request for the government to consider.

## 1. Comment

I am disappointed in the short term view of the value of these lands. The professionals in our public service know how quickly forests regenerate on the west coast of Vancouver Island. Unlike the interior of BC a replanted forest would be impressive after just 25 years and even more so in 50 to 70 years when it is mature. That is a very short time frame if we want to preserve a coastal wilderness for our children and grandchildren to experience and enjoy. Unfortunately no action will mean subdivision and residential sprawl where a wilderness coastline could be easily be realized in a very short time period with little public expense. Please reconsider this decision by looking at the timeframe for forest regeneration on the west coast.

## 2. Alternative Request

Only as an alternative, if the government is willing to let this land slip away from easily achieved public ownership and protection, please change the Private Managed Forest Act law and regulations so that after logging the owners are prohibited from being able to have the land subdivided and developed either by themselves or a third party developer rather than being required to replant the forest and maintain it as Managed Forest Land. Unfortunately our experience out here is that subdivision and development always follow logging on Private Managed Forest Lands. Residential sprawl is replacing our coastal wilderness at an alarming rate. Another BC Liberal gift to their corporate donors that must be reversed.

Thank you very much for your email addressed to MLA John Horgan regarding land in the Shirley/Jordan River area. My name is Maureen and I am a constituency assistant in John's Langford office. Please allow me to apologise for my delay in responding to your email.

Thank you for bringing forward the suggestion for the government to purchase private land, at this time the government has no plans of purchasing parcels of land in Jordan River for forest management purposes. Although these lands were previously part of a Tree Farm Licence (TFL) they were a portion of the privately owned component of the TFL. The Minister of Forest Lands and Natural Resource Operations and Rural Development at the time, with the consent of the licensee, adjusted the boundary of the TFL by removing the private lands from the licence area. Since removal the lands have continued to be managed as forests, and are subject to the Private Managed Forest Land Act. Under the Act, in exchange for a lower property tax, private landowners commit to managing for key public environmental values; specifically, protection for soil conservation, critical wildlife habitat, fish habitat, drinking water quality and prompt reforestation. The Private Managed Forest Land (PMFL) program is voluntary, and is administered by the Managed Forest Council (<http://mfcouncil.ca/>). If sold the land will be subject to local government and bylaws or the new owner may decide to continue to manage the land as a Private Managed Forest, and submit to the council a proposed management commitment. If the council determines that a proposed management commitment meets the

applicable requirements the land will be classified as Private Managed Forest and will be subject to the PMFL Act.

Western Forests Products has recently listed properties for sale in the Jordan River area. The properties are part of the private lands deleted from a Tree Farm Licence in the early 2000s. BC Parks from time to time has funds to purchase private lands for inclusion in the provincial parks and protected areas system. In 2017/18, BC Parks had a budget of approximately \$10 million for private land acquisitions. At this time, a land acquisition budget for 2018/19 has not been established. The parcels of land that Western Forest Products have listed have been heavily logged. BC Parks has no interest in these parcels due to the recent logging, thereby limiting their potential contributions to the provincial parks and protected areas system. If BC Parks had a land acquisition budget at this time, there would be many properties, both on Vancouver Island and throughout the Province, of a much higher priority. The parcels are adjacent or near the Jordan River Regional Park operated by the CRD. CRD Parks looked at Section 73 and two other parcels, and determined that the lands are not suitable for park purposes as they had been recently logged, which limited their ecological value, and concerns about the maintenance or deactivation requirements for the network of forest roads.

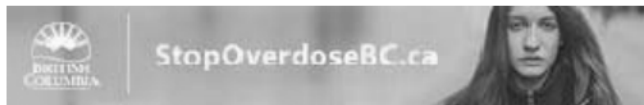

- Members of local First Nations have issued a news release suggesting they are closing portions of the Cariboo, Omineca and Skeena to all LEH hunting. The following LEH Areas within the boundary include:
  - 5-3, 5-4A, 5-4B, 5-4C, 5-5, 5-6, 5-10, 5-11, 5-12A, 5-12B, 5-13A, 5-13B, 5-13C, 5-14, 5-15B, 5-15C, 5-15D, 6-1, 7-4, 7-10, 7-11, and 7-12B, and
  - Portions of 5-2, 6-2A, 6-2B, 6-4, 7-3, 7-5, 7-6, and 7-8.
- The Province considers the licences of guides, resident hunters and non-resident hunters to be valid.
- At this time we do not know what First Nations are planning with respect to enforcement of their announcement.

- In the Cariboo for example, all resident hunting is managed through Limited Entry Hunt which is the most closely managed hunt opportunity, and throughout the Chilcotin the LEH hunt is further enforced with compulsory inspection to confirm harvest information and inform management.
- The Province's data on moose harvest management clearly shows LEH harvest managed does not lead to moose population declines.
- In the Chilcotin LEH hunting has been reduced by 60% from 2011 levels.
- On August 24, further closures and access restrictions were put in place after additional consultation with First Nations.
- We are not planning on expanding existing closures at this time.

### **What is the impact of wildfires on moose populations?**

- Analysis of the effects of the 2017 wildfires are consistent with prevailing science that suggest that wildlife populations are not significantly impacted by wildfires, and any wildlife mortality directly related to fires is considered to be outweighed by the long-term benefits of wildfire to habitat and wildlife.
- For example:
  - The Province prescribes burns frequently in areas to improve wildlife habitat and thus benefit population growth.
  - The 2017 Plateau fires in the Chilcotin were aerially surveyed and show ungulates remaining in newly burnt landscapes. In Zone 5-13A (60% of which was in the fire perimeter), surveys comparing moose densities before and after the wildfire showed moose populations remained stable.
  - Surveys following the 2017 Elephant Hill Fire did not notice a change in moose numbers within the burn and some of the highest densities observed were within the burn.
- Nevertheless, as a precaution additional reductions to LEH in the Chilcotin were implemented to address the removal of security cover and the potential for increased hunter success as a result of the 2017 wildfires.

1) Prior to 2002, indexation occurred in January and July that reflected the actual cost of living. This was changed by the Liberals to once a year in January no longer at the cost of living.

Instead, the cost of living would be reduced by 1% and minus any fractions the rate may be at. In other words if cost of living was at 2.75% an injured worker

would lose 1.75% and end up with only 1%. As you can imagine, this felt very degrading and caused those on WCB pensions to fall behind even more.

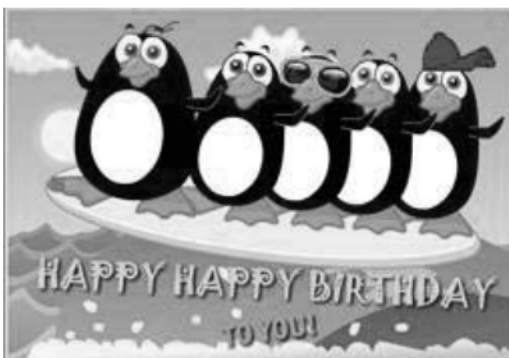

- Rock quarries in BC are permitted by statutory decision makers (SDMs) in the Ministry of Energy, Mines and Petroleum Resources (the Ministry) under the requirements outlined in the *Mines Act* and administered under various regulations, central to which is the Health, Safety and Reclamation Code for Mines in BC, and may be subject to other provincial, federal or local/municipal legislation and regulation.
- OK Industries Ltd (OKI) has applied for a Mines Act permit to quarry 150,000 tonnes per year of rock over 25 years. OKI currently operates the All Fun quarry on Millstream Rd, less than 600m south of the proposed quarry.

- The Ministry is currently in the process of reviewing this Application and no decision has yet been made.
- The statutory decision maker attended a District Council meeting on October 2, 2017. The SDM has also received concerns from other potentially affected stakeholders over the course of the last year. The primary concerns that have come from the District, community and stakeholders include:
  - Proposed activity (quarry, processing) is not consistent with District zoning;
  - Additional permits may be required from the District;
  - Impacts from quarry blasting on the two landfill sites to the north;
  - Impacts to groundwater from quarry blasting and potential contamination from nearby landfills;
  - Impacts on residential area from noise, dust, vibration, traffic, etc;
  - Impacts to sensitive ecological features on the property (including wetland, sensitive habitat and species).
- The SDM has requested additional information and reports from the proponent related to surface drainage and groundwater, buffers and road access, noise mitigation measures, reclamation plan, and the potential impacts of blasting on nearby wells and structures. A meeting was held with the SDM and OKI on December 11, 2017 and the additional information requirements were discussed.
- The proponent has informed the Ministry that they are working with their consultants to provide the information and reports requested and indicate that these will be provided by the end of the year. Once all of this information has been submitted to the Ministry the proponent has agreed to attend a public meeting or open house.
- The Ministry understands the District's and the community's concerns regarding the protection of its groundwater resources and the impacts that may be associated from quarry blasting in addition to the identified ecological values this site has and how they are relevant to the surrounding lands.
- The Ministry's review of the Application will take into consideration the potential impacts on these resources and will also include assessments of other factors, including potential noise and dust impacts to surrounding properties. The Ministry undertakes to consider and weigh all relevant information and perspectives, and is committed to conducting a thorough and comprehensive review based on input from the District of Highlands and other affected stakeholders and agencies.
- The Ministry is committed to working with Highland's staff, will share the reports submitted by the proponent and plan to attend a public meeting or open house with the proponent.
