**Subject:** DM Committee Conflicts with Cabinet Committees

As the fall schedule resumes, we are going to be reminding DM's offices / Secretariats to do their best to avoid scheduling DM committees at the same time as related Cabinet Committee meetings or ones where their members might need to resource or present at a Cabinet Committee at the same time.

Before sending out a note to the Secretariats about this, I wanted to check whether the secretariat scheduling staff currently receive the Cabinet Committee schedule and any updates? Or if not, could they? I had raised meeting conflicts with Dana Eckardt in the DMCNR secretariat, but she did not think she had access to or received information on the Cabinet Committee schedules.

I don't want to add to the Cab Ops workload - DM Committee scheduling is something the secretariats can work out. But just as a examples, on September 17, DMCNR was scheduled at the same time as a SSP meeting. Then on September 18, DMCSSP extends into the same time as the ELUC meeting, and should end early enough that DMs resourcing ELUC can get from 1810 Blanshard back down to the buildings. We will also ask Secretariats to avoid scheduling DM committees at a time that overlaps with PA, LRC or (wherever possible) Treasury Board.
