I want to share with you the meeting analysis that I asked Charlotte to do of PJH's calendar. I always find this to be a very informative process. It provides a sense of who we/he have been spending time with and therefore which sectors we will want to prioritize in the months ahead. This is the second 6 month period she has analyzed so it has comparisons which I found very useful.

One point to note: the Premier significantly increased the time he spent with specific cultural communities these past six months over the first six months. That percentage of time would be even greater if we had included July in this analysis. I hope we can continue to build on that.

Hello Lisa Beare and the Ministry of Arts and Culture,

My name is Corinne Lea, and I am the operator of the Rio Theatre. As you may be aware, I'm currently in the midst of a highly public campaign to purchase the Rio property, one of Vancouver's last iconic independent theatres with many thousands of supporters and customers. We're trying to save it from developers who want to tear it down and build condos.

Our campaign has been extremely successful, we have raised over \$500,000 in donated funds from the community for our non profit, Vancouver Art House Society, and the rest of the funds have come from private investors, big and small, who all want to help save the theatre. I am personally making a significant investment. Additionally, Vancity has approved a \$4 million mortgage.

It has been 6 months of hard work and we have almost everything we need to buy the property for the matching \$7.5 million purchase price that was offered by the developers.

During our campaign, Vancouver's Mayor showed his support and proclaimed #SaveTheRio week, plus we are in advanced discussions with the City and the Federal government for funding support. Just today the City approved a grant of \$375,000 for our non profit Society and I'm told the Federal grant will be a longer process.

As successful as we have been, we have little margin for error and the Property Transfer Tax, especially after the recent increase, has proved an additional stumbling block that we need to overcome. We would need to raise an additional \$207,000 just to pay that tax.

I'm quite sure that the original intent of the property tax hike was not to obstruct the saving of an East Vancouver cultural institution from developers!

I would like to formally ask your assistance with the Province to waive this tax. We have not otherwise appealed to the Province for any support, and believe that such a waiver is a suitable proxy for more direct forms of funding being proposed by the City and the Federal government.

This has been such a huge team effort to save the theatre, which is beloved by the community, and it would be amazing if there is a way the Province could help us! We have over 25,000 supporters for our campaign, and they would all be very grateful for your support.

Please let me know if you are available to discuss in more depth or if you need any more information to inform your decision on this matter. I am confident that we can demonstrate to you our high cultural and community value to BC. Or if you have any other ideas of how the Province could help assist us with funding to save the Rio we would be very grateful.
