- **Approval for the Provincial Ceremony Service Provider**

- As per the rationale outlined below, we are hoping to confirm that we can secure our a/v event supplier ProShow for 2018 in a Draw Down arrangement with GCPE.
- ProShow has been the on-going a/v supplier for the Premier's Awards for the past 13 years. They have been a trusted supplier and a partner in growing the ceremony with us as they have consistently delivered a flawless production and add considerable production value to each event. In addition to the on-site technical support, they understand the magnitude and importance of this "no-fail" event and are involved in the pre-production and planning as well as on-site guidance to ensure a consistent and first rate experience both behind the scenes and on stage.
- ProShow also provides creative input into the ceremony. As the program area, we deliver the final versions of

videos separated into each category for the awards ceremony. ProShow then helps to create the flow for the rest of the evening as they contribute to the timing of the program with on screen videos and stage transitions , transition music for winner announcements, stage camera and winner spotlights. With the addition of the live cast to the ceremony, they provide invaluable technical support for the live cast recording of the show as it is being filmed.

- Given the short window to vet a new supplier, we are hoping to confirm the arrangements with ProShow for 2018 and would will ensure that we go out for RFQ in January 2019 for next year's event.

- **Filming Premier Horgan for the Regional Webcast Openers**

- As per 2017, we would like to request that Premier Horgan pre-tape an opening message for each of the regional webcast ceremonies. This took no more than 20 minutes as he gave a short, unscripted welcome and acknowledgement to the finalists from each of the regions. This year, there will only be two pre-taped messages as we have combined out Vancouver Island and Lower Mainland finalists to one ceremony. - As the first regional ceremony is October 11<sup>th</sup>, we would ideally have this completed by Monday, October 1<sup>st</sup>. Can you confirm these arrangements and schedule 20 minutes or so to film this once again in the Premier's Office? If necessary, we can travel to Vancouver to do this at his convenience.

Our past practice has been to send over final drafts of the letter to the PO and then they are returned to us on letterhead and signed to be included in the gift package that our office sends out. So your comments on Red FM came my way today, and I just wanted to clarify some stuff on the funding- the money is all part of the same envelope and it's just structured this way for accounting reasons. Although the province's and Mayors' council money goes to different projects, the province is still funding 40% of the overall plan. The LRT would not be happening if not for the province's contribution to the plan.

Some more info:

### **Who is funding and delivering both projects?**

- Canada, B.C., TransLink and local municipalities are all funding partners in the Mayors' Vision.
- Both the Province and TransLink will be the major funders for the assets they will own. TransLink is directing most of its funding towards the Surrey LRT, and B.C. is directing most of its share of funding to the Broadway Subway as this is an extension to the Millennium Line which is already owned by the Province.
- The Province is contributing 40% to the overall Phase 2 Mayor's Council 10-Year Vision, which includes the Broadway Subway, Surrey LRT and several other projects.
- The Broadway Subway, with an estimated budget of \$2.83 billion will be funded and delivered by the Government of B.C., with contributions from the Government of Canada and the City of Vancouver. It will be fully integrated into the regional transportation network and operated by TransLink upon completion.
- The Surrey LRT Project with an estimated budget of \$1.65 billion, will be funded and delivered by TransLink, with contributions from the Government of Canada and the City of Surrey.

I'm about to head into a meeting, but here's a bit of background for you. Let me know if you have any questions. Basically, we're hoping to be able to resolve the situation and find appropriate places for these folks to go soon, but no one is being removed from the park at this point.

Background:

- Last week, Saanich police enforced a court order to remove campers at the tent city in Saanich's Regina Park. The campers subsequently moved to Ministry of Transportation land nearby.
- On September 18th, police removed campers located on Ministry of Transportation land at Ravine Way and Pat Bay Highway in Saanich, citing safety concerns.
- Campers then tried to move to Saanich municipal park land. Police indicated people could camp between 7 pm and 9 am, but could not camp permanently.
- Campers then moved to Goldstream Provincial Park, where they are occupying three campsites.
- Langford Mayor Stew Young has criticized the provincial government for a lack of action on homelessness and raised concerns about how the tent city will impact the park and community.
- BC Parks has closed Goldstream park to other campers, citing public safety concerns.
- After speculation that campers would be forcibly removed today (Sept 20), media is now reporting that this is not the case.
- The District of Saanich has issued a press release offering a site for modular housing units. BC Housing is assessing the site to determine if it is appropriate.

**Horgan - rent increases**

*By Horgan/Robin confcall VCO*

Selina Robinson: Firstly, I want to give a heartfelt thank-you to the members of the Rental Housing Task Force -- Vancouver-West End MLA Spencer Chandra Herbert, the task force chair; and Saanich North and the Islands MLA Adam Olsen; and Courtenay-Comox MLA Ronna-Rae Leonard. They were asked by the Premier and myself to expedite the recommendations on the annual allowable rent increase, and the task force presented them on Monday.

Their first recommendation was to get rid of the formula that was introduced to us by the previous government, and remove the additional 2% allowable increase. The task force heard, as the Premier and I have heard, that people throughout BC are struggling to make ends meet and a 4.5% increase after many years of increases is just too much.

I'm pleased to say that we are taking action on this recommendation and we will be limiting that annual increase to inflation only. This means the annual allowable rent increase for 2019 will be limited to 2.5%.

At the same time, we know that landlords are facing increased costs to provide safe, secure housing. And that's why we are also accepting the task force's second recommendation to allow for additional increases above inflation for case where renovations and repairs have been completed. We will be consulting with landlords to work out the full details, but the increases will be done through an application process.

We recognize that supply is key to bringing down rental costs in the long term, but renters have told us that they are hurting and they need help today. That's why, in accepting these recommendations, we are taking careful steps to address this aspect of the housing crisis and ease the pressure on renters, while also making sure that landlords have the tools they need to continue to invest in their rental properties.

I'd like to invite the Premier up to say a few words.

John Horgan: It is good to be here today to address an issue of significant concern to renters here in BC. For now coming on 14 years a BC Liberal formula allowed rent increases of the rate of inflation plus 2%. So for a number of successive increases above the inflation rate have been hitting renters particularly hard.

We've been listening, as Selina said, to renters and to landlords. To work with Minister Robison, I appointed Spencer Chandra Herbert, Ronna-Rae Leonard and Adam Olsen to talk to landlords, to talk to tenants' organizations, to talk to individual tenants about how best we could put in place an initiative that would allow them to have some relief for one of the most important costs any of us have.

You'll also know that we have been in a significant housing crisis for the past decade, particularly in the lower mainland, but right across BC. If we're going to meet the needs of the homeless and hard to house, if we're going to meet the needs of renters and if we're going to meet the needs of those who want to enter into the housing market, we need to bring on more supply that's affordable for British Columbians. I believe the response today to the task force



recommendation is a good first step. Eliminating the additional 2% rate increase will allow renters today to have some comfort that they are only going to see their costs go up by the cost of living.

But there's more work to do. The task force will continue to consult. Their final report will be coming to government in the weeks ahead. And we will continue to work with landlords to ensure that we bring on more supply and that those who do need to make significant improvements in their properties can do so with an expectation that those costs can and will be recovered. But at the end of the day, we have made affordability [inaudible].

We want to make sure that we're taking every step we can as a government to reduce costs for people. We started by eliminating the tolls on the Port Mann and Golden Ears Bridge, we've eliminated or will be eliminating in the next 12 months medical services premiums. And by capping the increase in rents for regular people, we're doing our best to make life affordable for British Columbians.

We have much more to do, but this is a good step in the right direction. I want to thank you for coming. I also want to, again, thank Spencer Chandra Herbert, Adam Olsen and Ronna-Rae Leonard for the work that they have done to get this expedited report to us so that we can meet the October 1 deadline. Cabinet has just approved that.

I will also say cabinet is moving forward, as we committed to in the campaign, a poverty reduction plan that we'll see more of in the legislative session that starts next week. Poverty reduction is critical to meeting the needs of British Columbians. That means bringing on more housing. That means making sure that services are there for people so they can realize their full potential, so that they can make full and comprehensive contributions to our community, to themselves, and to their families.
