Hi

Troy Fire & Life Safety will be conducting tests of the fire alarm system from December 10<sup>th</sup> to the 15<sup>th</sup>.

They will be inspecting and performing smoke testing of the various devices in the Main Building (Mon, Tue & Wed), 612/614 Government & 421/431 Menzies (Wed, Thurs & Fri). During the smoke testing the fire bells will be on bypass so not to actually ring but the signal will still work and that is what they will be testing during the week. On the Saturday the 15<sup>th</sup> the Bells will be rung in all buildings as each bell is required to be tested. The elevator sensors will also be tested during the week to ensure the elevator moves to the correct floor when the signal is activated.

The bell ringing will be disruptive for those in the building that day, so if you plan to have staff working perhaps you could advise them of the pending work so they can change their schedule if possible. It should be noted that the fire doors in the main building will be closed on the Saturday since they are activated when the bells are rung. Please share this email as required.

I apologize for the short notice of this necessary life safety work. If anyone has any concerns now or while the work is in progress, please do not hesitate to contact me or the LFS office. I apologize for any inconvenience this work may cause.

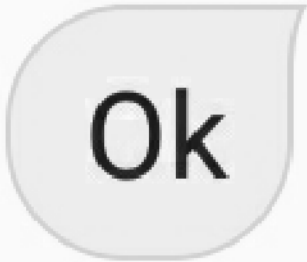

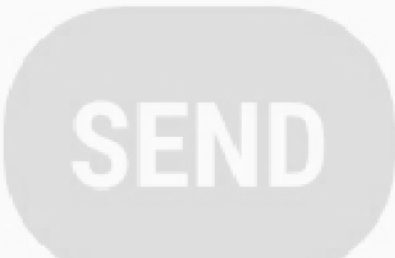
