Sage/Sheena – below is some info that just came from Transportation on cost comparison between Broadway and Evergreen (Palmer's two columns criticizing the difference, asking why it's so much more expensive per kilometer than Evergreen, and asking why cost details are being redacted in public documents). May be worth showing to PJH before his scrum.

Key Messages

- Getting the best value for public dollars is a fiscal responsibility we take very seriously, and the Broadway Subway project is no exception.
- To ensure a competitive procurement process and protect our negotiating position, some portions of the business case and other project documents must be withheld at this time.

Disclosure of Costs

- We will be starting the competitive selection process shortly. At the end of procurement a report will be released which will include the contract value and other cost information. Examples of other project reports are available (such as Evergreen).
- At the end of construction, full details of final costs will also be released, as was the case with Evergreen.

Comparisons to Evergreen Line

- In order to compare the cost of the Evergreen Line with the Broadway Subway, both projects should be considered on the same time basis. If Evergreen construction was to start in 2020, the costs would need to be

inflated by 7 years, and therefore the cost would be in the region of \$2 billion (not \$1.431 billion).

- The Broadway Subway is significantly different to Evergreen in a number of respects:
 - o The stations are all underground. Underground stations are about seven or eight times more expensive than the above-ground stations constructed for Evergreen.
 - o Evergreen was 23% tunnel and Broadway will be 85% tunnel – this is a significant cost driver because a tunnel is two to three times the cost of an Evergreen-style elevated guideway.
 - o Evergreen was in a relatively low density suburban area, compared to a very dense urban/commercial environment for Broadway. On Evergreen there were limited utility relocations – on Broadway we estimate these costs to be in the region of eight to ten times higher than on Evergreen. Similarly traffic management and bus relocation costs will be significantly more.
 - o Property costs are very high along the Broadway corridor – properties are high density commercial and values have escalated significantly over the past couple of years.
 - o It is not possible to build an Evergreen-style elevated guideway along Broadway due to constraints of existing adjacent property, guideway clearances at intersections, traffic requirements and the need for high-level stations. The Strategic Options Analysis provides further information on the analysis conducted as part of the business case.

Just writing a follow up story on this issue tomorrow after checking in with B.C. First Nations who faced wildfires this year.

I see the province announced a community resilience fund last week. Do you have any other plans to help First Nations mitigate the risk of wildfires?

The federal government provides resources to the province which are then distributed to the First Nations. (INAC says it has a 10-year, \$29.6 million Emergency Management Service Agreement with Emergency Management BC (EMBC) that includes funding for direct services to First Nations on reserve under all four pillars of emergency management (mitigation, preparedness, response and recovery), and an annual \$2.015 million service agreement with BC Wildfire Service to provide services on reserve.) Does the province have any plans to clear up the flow of resources to ensure that Indigenous communities can more easily access support?

Finally, Chief Rick McLean of the Tahltan says he spoke directly with the premier about this issue in mid-August and the premier then phoned Prime Minister Justin Trudeau to relay the chief's concerns. Did this happen and if so, when? What did the premier say in this call and did he receive any assurances from the PM?

Hi Laura,

Here is our response from the Ministry:

- Our top priority is the safety of all British Columbians, and that includes First Nations communities.
- We have escalated our response to fighting the wildfires throughout B.C. by declaring a state of emergency and requesting federal assistance.
- These actions will give us access to the additional resources we need to battle the wildfire situation, protect property and ensure the safety of British Columbians, including First Nations.
- We are committed to supporting First Nation communities who have been hard hit by B.C.'s wildfire situation.
- EMBC has provided Emergency Social Services support, including billeting and commercial accommodation, meals, clothing, incidentals, pet care, emergency transportation, and emotional support through community agencies to all affected First Nation communities.
- They have also provided communications systems, disaster psycho-social supports, HEPA filters to increase indoor air quality, and emergency social services (ESS) for all ordered evacuees.
- On Wednesday, we opened a group lodging centre in Burns Lake for 200 people, including members from Cheslatta, Nee-Tahi-Buhn, and Skin-Tyee First Nations.
- We are having daily calls with affected First Nation communities to answer questions, provide assistance and support, including helping with forms, resource requests and notifications and expense eligibility.
- Response agencies have put in place a number of new processes and resources to improve how we engage and partner with Indigenous communities, including Indigenous liaisons in Provincial Regional Emergency Operation Centres.
- First Nations have extensive knowledge and a deep connection to the forests, waters and lands of their territories. We are working to include this wisdom and experience in our approach to planning around – and responding to – wildfires.
- Given the unpredictable behaviour of this year's wildfires and the number of significant wildfires in all areas of the province, we're bringing in the additional resources we need to keep people and communities as safe as possible.
- We heard that some First Nations expressed concern about communication on wildfires between the Nations and the Province.
- As a result, we have increased our communication with First Nations, and reached out to specific nations that have expressed concern. The Provincial Regional Emergency Operation Centre has been communicating daily with

Nadleh Whut'en Nation, and provincial staff met with community leaders August 16th.

- The BC Wildfire Service, Emergency Management BC, and Ministry of Indigenous Relations and Reconciliation staff are working closely with the First Nations Health Authority, Indigenous Services Canada, First Nations community members and members of the First Nations Leadership Council to find ways to provide support to communities in the ways they need.
- The BC Wildfire Service is doing risk assessments and connecting with representatives from First Nations communities.
- In addition, in support of the provincial emergency structure, the Ministry of Indigenous Relations and Reconciliation staff are working at the Provincial Emergency Coordination Centre in Victoria and the Provincial Regional Emergency Operation Centres (PREOCs) in Prince George and Terrace, as well as at a joint Emergency Operation Centre with the Tahltan Nation in Dease Lake, to assist PREOCs in ensuring appropriate support for Indigenous communities and to address all requests and concerns as promptly as possible.
- Emergency Management BC has been coordinating daily, regional calls to ensure that wildfire experts, First Nations emergency management professionals and First Nations leaders are equipped with the most up-to-date information.
- Ensuring the safety of First Nations members and communities, and supporting the health needs and basic essentials for evacuees from their communities, remains a top priority for all of the agencies involved.
