I am writing today to let you know that Catalyst has entered into an agreement for the sale of our BC business to Paper Excellence Canada.

In purchasing all of Catalyst's shares, Paper Excellence will acquire our pulp and paper mills in Crofton, Port Alberni and Powell River, our Surrey distribution centre and Richmond administrative office, and our Seattle sales office. Paper Excellence will assume all of Catalyst's employee, pension, vendor and contractual obligations.

I know how important a competitive and successful pulp and paper industry is to the BC economy and communities across our province. I am pleased to say this transaction is good news for our customers, employees, our operating communities, and BC's pulp and paper and forest products industries. It is a positive outcome.

Paper Excellence is privately owned and headquartered in BC. They are a proven operator with five mills in Canada and two in France.

Together with Paper Excellence, our immediate goal is to make the transition as seamless as possible with minimal disruption to our customers and employees alike.

The transaction will be subject to a pre-closing review and clearance by the Competition Bureau, which is customary for a transaction of this size. We are confident the transaction will not raise any competition issues with respect to pulp or other commodities, and will help in fact to preserve mills and competition in British Columbia. We expect the transaction will close by the end of the fourth quarter 2018 or early first quarter 2019.

I want to take this opportunity to thank you for your continuing commitment to Catalyst. We appreciate the steadfast commitment you made to strengthen our entire industry. We greatly appreciate the staff time and resources your government committed to our ongoing policy discussions. Moreover, we are grateful for your government's strong

support in defending Catalyst against the U.S. countervailing and anti-dumping duties. On behalf of all of Catalyst's employees, thank you.
