Subject: Re Minister Robinson and yearly notice of allowable rent increase

Agreement has been reached that MSR will not bring a decision item to Cabinet re the anticipated “up to 5%” rent increase allowance that will be in effect for 2019. The figure has to be released before Oct 1, because landlords have to give tenants 3 months notice for an increase to take effect Jan 1.

Instead she is going to bring a verbal update and some messaging for them, anticipating concerns from tenants when they hear this news. The Ministry has messaging prepared, so it’s available now or very soon.
