I hope this finds you well. I'm wondering if you would have time to meet with me and and potentially others from Watershed Watch in the next few weeks regarding a couple of high priority items.

We would specifically like to discuss the issue addressed in the attached letter from the LFFA (fish-friendly flood control in the Fraser valley) and how it can be a win for the Provincial government that also fits in with recommendations made by the Wild Salmon Advisory Council. We've been talking with Kenn McLaren about it, and others who are very enthusiastic and it would be great to get you in the loop and get your thoughts on how we can move it forward.

We would also like to discuss the public consultation process around the development of a BC Wild Salmon Strategy.

And if you would like, we could brief you on the successes of the known-stock indigenous-led fisheries we work with in the Skeena watershed that this year hit a milestone by bringing in two thirds of the total commercial catch of Skeena sockeye.

Request: reporter is writing about the injunction request filed on Nov. 26 by CGL. She would like to know:

- Has the minister heard of recent action taken against those attempting to defend their traditional territories?
- Is serving injunctions to leaders of the camp and bringing issues to court the best way to achieve reconciliation with Indigenous Nations?
- The Wet'suwet'en people reject any pipeline through their territory, and have consensus through their hereditary chieftainship system - how will Canada respect their governing system and work with the Nation to find a peaceful solution?

Suggested response:

GCPE to provide the following statement attributable to MMM:

The ministry is aware that Coastal GasLink has filed for an injunction. We acknowledge that this is a challenging situation and we hope that a respectful resolution can be achieved. We will assist in re-engagement efforts and we are looking to the company to find a resolution to the access issue.

For our part, the province recognizes the need to reset the relationship with the Wet'suwet'en Nation including hereditary leadership. Our reconciliation commitment isn't connected to any one project and is grounded in rights recognition.

A government-to-government relationship with the Office of the Wetsuwet'en that supports reconciliation is a priority. Indigenous Relations and Reconciliation Minister Scott Fraser has visited the Wet'suwet'en territory twice in the past few months to meet with leaders and elders to talk about how we can best support reconciliation.

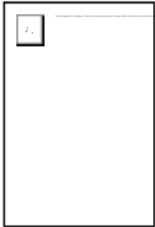

Yellowstone to Yukon has also been working hard to deepen our understanding of how to best support Indigenous rights assertion. We are hopeful that First Nations will continue to express and ultimately secure their appropriate rights to their lands, including title.

Indigenous peoples across Canada are including the concepts of Indigenous Protected and Conserved Areas in their planning and Yellowstone to Yukon supports the expansion of these designations throughout BC. Indeed, we are working with First Nations to develop strategies for the implementation of the recommendations of the Indigenous Circle of Experts Report and the National Advisory Panel Report (both attached) as to how Canada can meet its Biodiversity 2020 commitments for 17% terrestrial conservation by 2020. We believe in the concept of Ethical Space that is described in these reports and look forward to its evolution in practice. We also note that the ICE and NAP reports recognize an important role for environmental and philanthropic organizations in working in partnership with Indigenous peoples and governments to ensure effective conservation. We are committed to building these partnerships to effect both conservation but also the reinforcement of First Nations relationships to the land through the application of cultural land management principles.

We are heartened to hear that the province takes its commitment to strengthening indigenous relationships so seriously. We wish you every success in your role and look forward to staying in touch.

I had a chance to check in with Chief Joe yesterday and he's still disappointed and frustrated that the Premier didn't attend the exoneration event - I explained about the Premier's commitment and scheduling conflicts on the event day, but what he takes from that is reconciliation with the Tsilhqot'in is not the priority for the Premier or BC.

Do you think we could arrange a brief call between Chief Joe and the Premier? I think hearing directly from the Premier about the level of commitment might help get things back on track.

In the meantime, I think we should proceed to confirm the meeting with the Premier at the Leadership Gathering. It would make a difference if you could pull in a few key Ministers, even for a short meeting.

Don, I'm also wondering if we can schedule the Chiefs to meet as a block with Ministers as part of the meetings throughout the day? That would save time on both ends. In particular, Ministers Donaldson, Fraser, Mungall, Heyman, Trevena. Let me know if those arrangements can be made.

But I do think it is important to connect Chief Joe and the Premier to keep things from going off track. There is a lot of potential right now for groundbreaking trilateral work towards an agreement this Spring and I wouldn't want to see this potential derailed by misunderstanding and hard feelings between leaders. I'm hopeful we can clear it up if they can connect.

As I suggested in our call today, I will work to ensure the TNG leadership meet with the Premier at the upcoming First Nations Leadership Gathering and we work together to find a mutually-agreeable date to meet as the Tsilhqot'in-BC Leadership Table.

The BC Treaty Referendum was a province-wide referendum on First Nations treaty rights in British Columbia, Canada.

In the spring of 2002 the Premier Gordon Campbell and the British Columbia Liberal Party government sent out ballots to registered voters in the province.

The government called the referendum "an experiment in direct democracy," but the polling expert Angus Reid called it "one of the most amateurish, one-sided attempts to gauge the public will that I have seen in my professional career."

35.84% of ballots (763,480) were received by Elections BC by the deadline of May 15. Over 80 per cent of those ballots indicated agreement with all eight principles. Between 55,000 and 60,000 votes on each question were rejected.

shíshálh Nation and B.C. sign landmark agreement, breaking new ground in advancing reconciliation

VICTORIA – A landmark reconciliation agreement between the shíshálh Nation and B.C. recognizes and respects Indigenous title and rights, and supports self-determination and shíshálh self-government.

The agreement is a commitment to working together to protect the environment, as well as promote economic opportunity and growth for the shíshálh Nation and the entire Sechelt region.

“This is a historic day, that our people have worked towards for generations. We have advanced every path to true reconciliation,” said Chief Warren Paull, shíshálh Nation. “Every step of the way we have sought that a proper foundation be set based on recognition of our governments, laws, and jurisdiction, a true government-to-government relationship, protection of culture and our natural environment, and real investments in economic

growth. Today, that has been accomplished through a totally new type of agreement that will be to the enduring benefit of our Nation, and all who live in our Territory, for decades to come.”

This is the first major reconciliation agreement between this provincial government and a First Nation. It represents a progressive and collaborative approach to the implementation of shíshálh title and rights, and the United Nations Declaration on the Rights of Indigenous Peoples. It also represents a new model that pushes past some of the obstacles that have been sources of delay and conflict in the past.

“The people of the shíshálh Nation have led with vision and courage to make transformative change for their community,” said Premier John Horgan. “Our government is proud to work with shíshálh Nation in a renewed government-to-government relationship, based on rights, reconciliation and respect. It’s part of our commitment to advance reconciliation with Indigenous peoples and build a better future for everyone in B.C.”

A key part of the agreement includes the establishment of a landmark government-to-government working relationship that will create new decision-making structures between the Province and shíshálh government. Other key components include land transfers, economic and socio-cultural investments, establishment of a land-use planning process and joint aspirational long-term commitments.

The agreement includes the transfer of three parcels of Crown land adjacent to existing shíshálh lands to be used for economic development purposes, including gravel extraction as well as for social and cultural purposes.

B.C. is providing approximately \$36 million to support land purchases and implementation costs. Funding for implementation and forestry initiatives will be spread over the first five years of the agreement while both parties look ahead to how the agreement might evolve to encompass other types of land and resource decisions.

The agreement formalizes the Shared Decision Making Pilot Agreement for forestry decisions and broadens the scope to include additional forms of land and resource decisions over time.

B.C. has been working with shíshálh to actively engage industry stakeholders and local governments about the agreement.

Would love to connect with you for some advice about how the Ministry of Labour can engage with indigenous organizations to consult on potential amendments to the *Labour Relations Code*. This legislation is the framework for how unions come to represent workers and then how employers and unions interact. We recently released an expert report and are doing consultations with employers and unions on it, based on the website linked below.

We of course want to engage with indigenous organizations which may become unionized and with indigenous workers who may choose to join a union. Indigenous Peoples:

The proposed amendments do not relate to any of the Articles of the United Nations Declaration on the Rights of Indigenous Peoples, or the Calls to Action of the Truth and Reconciliation Commission.

Based on legal advice provided for other recent labour law amendments, the ministry anticipates that the proposed amendments do not give rise to a duty to notify or consult the treaty first nations or the Nisga'a Nation in BC. The ministry will confirm this view with Legal Services Branch for the proposed amendments.

As the amendments involve changes to a law of general application, they do not uniquely impact indigenous peoples. However, indigenous people are impacted like other British Columbians in their capacities as employers or workers. Indigenous stakeholder groups representing both employer and worker interests will be consulted in a form and manner that is consistent with the Province's 10 Draft Principles Guiding its Relationship with Indigenous Peoples.
