1. Premier's Opening Remarks

The Premier reported the actions of the Council of the Federation meeting this week. He will work with Premier McGuinty of Ontario to establish an agenda for a multi-day meeting to deal with some issues fundamental to a sustainable health care system. The Premiers also endorsed a national literacy strategy in support of the goal for Canada to become the world's most literate country within 10 years. The Premiers' agenda will also include how governments can work together to respond to natural disasters, and continued work on harmonizing environmental assessment reviews with the federal government.

2. For Information: Firestorm 2003 Provincial Review

The Honourable Gary Filmon presented the report of the examination of the interface fires of the summer of 2003. The recommendations for preparing, responding and recovering from interface fires were made to all levels of government, to the private sector, to communities and to citizens.

Cabinet Ministers were asked to bring forward to Cabinet their response to the report within a short time frame with a detailed plan including work already accomplished, and actions still to be implemented. Some cost items will need to be quantified and brought forward through Treasury Board for final determination at Cabinet.

The Minister of Forests will respond to those recommendations which impact this ministry's responsibilities. The Solicitor General will respond to the relevant recommendations on emergency preparedness, training, communication and coordination, as well as the standardization of rates paid, and to the principle of automatic aid. The Minister of Community, Aboriginal and Women's Services was asked to coordinate and communicate with the regional governments and municipalities through UBCM, as well as to contact the First Nations Summit to discuss the report and to ask how to work more closely with training, response and communications with First Nations.

3. For Decision: Tsawwassen Agreement in Principle

Cabinet reviewed a submission 'Tsawwassen First Nation Agreement in Principle", dated January 26, 2004 which recommended approval of the Agreement in Principle between British Columbia, Canada and the Tsawwassen First Nation.

Cabinet approved the Agreement in Principle and gave approval to proceed with Final Agreement negotiations.
