Subject: IMPORTANT - PLEASE READ - Public Service Response to Reduced Natural Gas Supplies

Hi All,

As you know, the Enbridge pipeline problem has been constraining the flow of natural gas to most of the communities of British Columbia. The good news, is that they have successfully restored flows in one of their two pipelines, but the first line will be out of service for an unknown period. So the flow of gas will be below normal rates.

We have been in close contact with Fortis, and are working with them to coordinate priority supply to families and communities.

The general priority of service will be residential and commercial first, then industrial. Some industrial customers have alternative fuel options, but some do not, and, if there is not enough gas available, will have to curtail operations.

In order to help mitigate the impact of all of this, it is important for the public sector to do its part in reducing demand in a safe and prudent manner. Accordingly, I am requesting that the thermostats of all government buildings that are heated with natural gas be turned down. I have already talked to Jill Kot about this, and where centrally controlled, arrangements are being made to turn the heat down to reduce consumption. I would also ask all of you to ensure that this happens in all the buildings you are responsible for.

For those of you with relationships with the broader public sector – e.g. schools, municipalities, etc, - I would ask that you reach out to them and ask for cooperation in this regard as well too.

If everyone in BC participates in this effort, we can reduce the number of British Columbians who have to be temporarily laid off, and we can keep the economy strong to generate wealth for all British Columbians.

You can expect further communication with respect to the status of this incident, and how long we might require such measures to be in place.

Hi All,

I am writing to advise of some organizational changes being made in my office.

Over the last year, Suzanne Christensen and her team in the Priorities and Accountability Office (PAO) successfully carried out their key role of providing consistent direction on mandate priorities during the start-up and establishment phases of government. With that work now substantially complete, the PAO group is being assigned to other functions across government where their skills and knowledge can be put to its best use. I want to thank Suzanne and her staff for all of their work over the last 14 months, and for the notable contributions they have made to shaping some of government's key initiatives, including housing, reconciliation, child care and more.

Suzanne will transfer to the Ministry of Indigenous Relations and Reconciliation in the role of Assistant Deputy Minister, where she will join Doug Caul and the executive team in advancing government's key reconciliation mandate. In particular, I have asked Suzanne to act as Secretary to a soon-to-be-established Cabinet Committee on Reconciliation, which will do the heavy lifting of building out the government's overall framework for Reconciliation, and to develop a significant public engagement process on Reconciliation.

Stephanie Papik, Jon Robinson and Leila Farmer will be taking up new assignments in other parts of government, and I expect you will be hearing about these in the days to come.

With the first year-plus behind us, the focus of my office will shift to policy and results delivery. In support of this, Christine Kennedy's team of Amy Miller and Allison Witter will be joined at the end of the month by Selena Basi who has chosen to return to work early from maternity leave. In addition to Selena, I expect that there will be one additional person joining Christine's team soon. Eric Kristianson will also be transferring from GCPE to my office, as Assistant Deputy Minister, Strategic Initiatives.

Please join me in thanking Suzanne, Stephanie, Leila and Jon for their many achievements and their hard work over the last 14 months. I know they will continue to add value in their new assignments.

Subject: JTT Restructuring/New Executive Responsibilities

Hi All,

Today Fazil and I implemented a significant restructuring of the Ministry of Jobs, Trade and Technology, redistributing Executive responsibilities, merging some divisions and shifting responsibilities between divisions. These changes are consistent with our focus across all ministries to place emphasis on priority initiatives that:

- Contribute to raising the standard of living across BC;
- Are practical and realistic in a BC context and in our fiscal environment;
- Do not impose avoidable costs on business;
- Avoid compounding affordability challenges; and,
- Wherever possible, benefit all of BC.
 - Or in the case of regionally-specific items, have considered impacts on other parts of BC.

Silas Brownsey will join the ministry in the newly established role of Associate Deputy Minister, Investment, Innovation and Technology, a role that merges several functions, including major investment, technology and innovation and the programs and services that address the needs of established sectors of our economy. Silas will work closely with other JTT divisions, my office and other Ministries to establish new programs and improve on existing ones, including:

- Maintaining a focus on emerging and established industries, across rural and urban BC;
- Supporting the Parliamentary Secretary for Technology and Innovation;
- Working with the Innovation Commissioner to identify innovation opportunities that optimize benefits for emerging and established industries;
- Leading the implementation of the pending Strategic Investment Framework;
- Coordinating investment programming across other mechanisms and sources of funding, including those
 in other Ministries, federal departments, regional trusts and similar vehicles;
- Coordinating initiatives related to the emerging economy and technology sector, including:
 - Technology sector engagement;
 - Regional Innovation;
 - Clean Tech;
 - Emerging Economy Task Force;
 - BC Tech Summit;
 - Innovate BC:

- Cascadia Corridor; and
- Engagement in the Digital Supercluster
- Coordinating initiatives in support of established business sectors;
 - Major economic sectors engagement
 - Regional programming
 - Gateway strategy (with Transportation)
 - Forestry Innovation Investment Ltd.
 - Nechako Kitimaat Fund
- Aligning the work of the division with JTT's newly refocused International Trade programming, with Small Business, Jobs and Workforce programming, and with initiatives in other Ministries.

Tracy Campbell will assume the new role of Assistant Deputy Minister, International Trade, which will combine the work of the former International Strategy and Competitiveness Division and the International Business Development Division, and provide support for the Minister of State for Trade. The International Trade Division will also lead BC's work on trade agreements and negotiations, trade research and market intelligence, trade missions and events, trade readiness programs, and trade services.

I have asked Fazil and Tracy to review the international trade and investment offices to ensure that these are configured for success and linked with other programs within and beyond JTT. To ensure that these programs are clearly focused on investment attraction that benefits British Columbians Tracy will be working closely with Silas to align the investment attraction function with landing and facilitation services in B.C., helping to direct investment to where it is most needed, and where it can be most successful. This work will require that our international trade and investment staff have or are able to develop direct personal familiarity with all regions of BC. As this work develops, I would see it working collaboratively with the Ministries of Agriculture, EMPR and FLNRORD, among others.

Christine Little will assume the role of Assistant Deputy Minister, Small Business, Jobs and Workforce, which combines some of the previous functions she had been leading with workforce and immigration programs. One of the priority tasks of the Jobs and Workforce division will be implementing the framework for measuring the business and economic impacts (cumulative impacts) of government policy decisions. This work will ensure that that Cabinet is informed of costs that policy change may impose on the business community, and allow government to better monitor, track and review cumulative impacts. In the immigration and workforce programs, I have asked that the division take a fresh look at immigration policy and bring a renewed focus to aligning skilled immigration with the industries and regions that are most urgently in need of talent, while maintaining BC's important immigration integration and support programs. The division will continue its current emphasis on small business programs and supports, including the Small Business Round Table and Small Business Task Force and will maintain its regulatory and service improvement functions and BC Stats.

Indigenous communities have a significant and growing role across every sector of our economy – in established industries, the emerging economy, in small business and in international trade. As such, there is not a designated "stream" for indigenous programming within one division, but an expectation that the needs

of emerging and established indigenous-owned businesses would be addressed within the programming of all JTT divisions.

With Tracy moving over to her new assignment, David Mortimer has been appointed A/EFO of the current "pod" of JTT, MAH, LBR and TAC. Lori Halls has begun consultations with Fazil, Jacquie, Trevor and Sandy as to how they want to proceed from here. Given the stage of the budget cycle, we will be imposing on Tracy to do a bit of "double duty" in helping David and those DMs over the next while.

Recognizing the significant shifts and program reprioritizations that have taken place, administration of the Venture Capital Fund, BC Immigrant Investment Fund, BC Renaissance Capital Fund and BC Tech Fund will shift to Management Services on an interim basis. I will review this when the other divisional priorities are sufficiently well-established.

Secretariat support for the Deputy Ministers' Committee on Sustainable Shared Prosperity and other DM-level working groups will be shifted to report to Fazil. Economic strategy will continue to be co-led between Fazil's office and my own.

With these changes, the roles that Jamie Hammond and Rob Mingay had been fulfilling have been absorbed within other divisions. I want to thank both Jamie and Rob for their work and their accomplishments in these and previous positions, and to wish them the very best in their future endeavors.

We've just received the signed OIC for Cannabis Worker Registration, to be processed as a corridor order. Can you please confirm if we can now move this OIC for signatures?

The summary for this item is below:

Establishes the regulation of workers in the retail and wholesale non-medical cannabis industry, including:

- requiring the general manager to establish and maintain a registry of employees and management staff in both private and government retail stores, Liquor Distribution Branch staff including warehouse staff, and those who work for marketing licensees;
- specifying who must be registered and providing authority for the general manager to revoke a person's registration;
- establishing the application process, fees, and requirements for a person to be registered;
- authorizing background checks;
- establishing general conditions that cannabis workers are subject to, such as keeping their contact information in the registry up to date; and
- prescribing offences and penalties relating to the registry.

Registration must be complete by October 17, 2018 so that the Liquor Distribution Branch and private licensees and are able to employ cannabis workers.

Of course, these types of indices are always arbitrary to some extent. Also, we would want to work over time with FNs to develop indicators we could all agree on. In that regard, I found this interesting:
