Hi Jarrett and Rick,

I need to relay the information for the visual look we want as quickly as possible to our graphics person in Toronto who is creating the pre-visualization of the proposed front of room look.

I am asking him to draw the pre-vis with the pewter coloured wall of drape up-lit with the Pantone colours you have chosen, it will include a stage with two 80" LED monitors positioned at the back with a podium centered between the monitors on stage.

I want to give him as much information as possible to go with as he will have a early am jump on this Monday with the time zone difference. This means he won't be able to ask any

questions.

I don't have an event graphic to give him to include on the monitors in the rendering, so I will give him a BCID logo for now unless you have something you want to forward me that I can include.

You mentioned in an earlier email that you thought we only needed to use 3 of the 5 Pantone colours to up-light the drape. Could you please confirm the preferred Pantone colours (by colour number) that you and Rick want use for the LED up-lights on the drape line?

You also mentioned that they did not need to be in any particular order, is that correct? If so should I tell our graphics person to go for the most appealing look? Let me know your thoughts?

The colours for the lights: Pantone colour numbers (in no specific order): 376 C, 369 C, 540 CP, 301 CP, 314 CP

I have attached an updated copy of the event order with the changes to the equipment we discussed for your review. Let me know if you have any questions?

Jarrett, I spoke to Mike Chambers and he agreed that we could easily use the existing sound system in the Alma room for both the Technical Briefing as well as the Premiers scrum. That includes the existing telephone interface which we can reuse to dial into the Telus conference bridge for the Premiers scrum.

I have updated that section of the quote to reflect those changes. I also included a set of 4 BC flags in that room for the scrum at no charge thinking they might be needed and would look better than a blank wall.

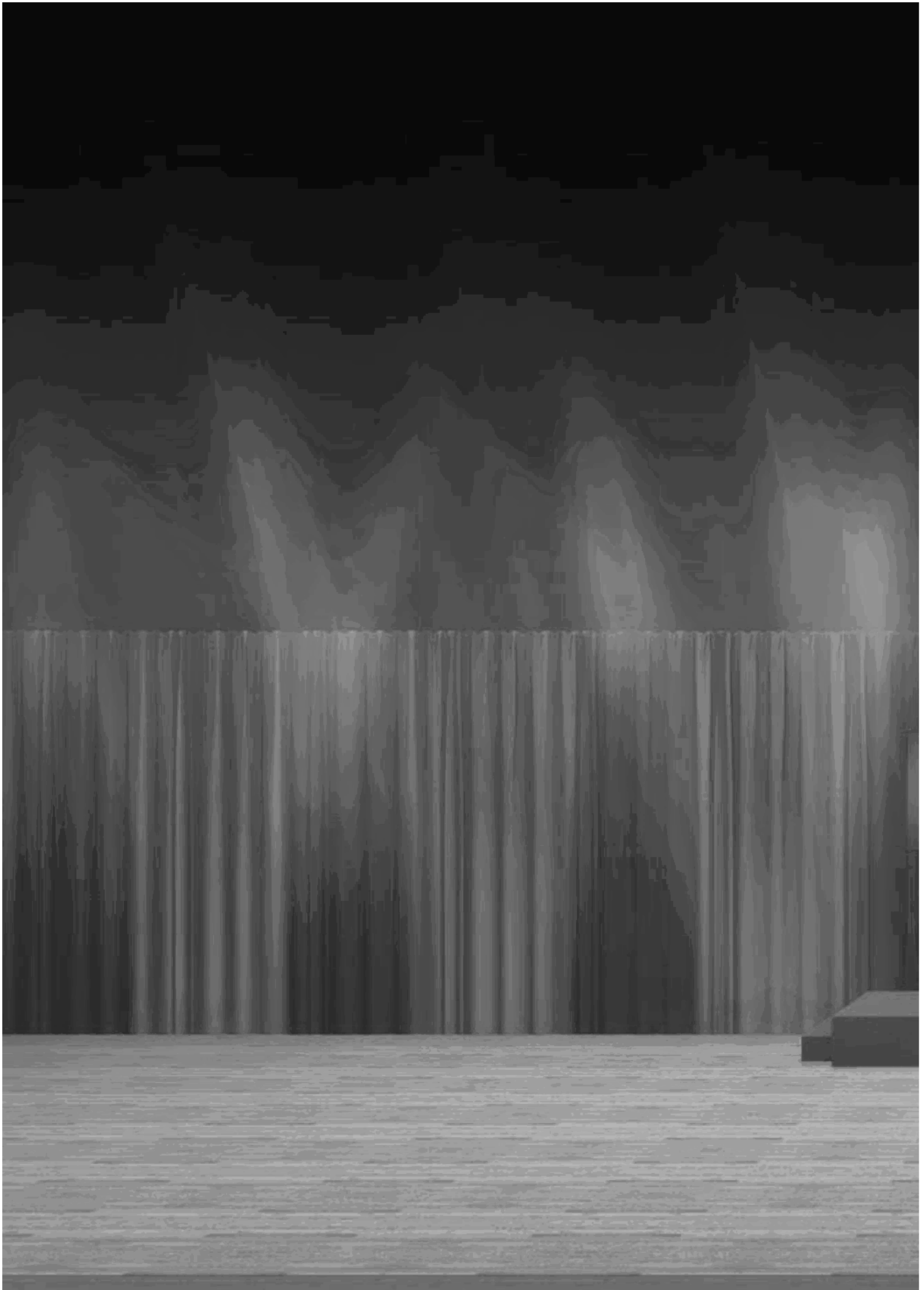

Dear Prime Minister Trudeau:

We are writing in response to the agenda for the First Ministers' Meeting scheduled for December 7, 2018 that was circulated to provinces and territories on November 30, 2018.

As proposed, the meeting agenda does not include any discussion on the crisis facing the energy industry and the price differential that is crippling the Alberta, Saskatchewan and Canadian economies. Our country is losing \$80 million dollars a day because we cannot get tide water access and world prices for Alberta's oil and gas.

During your recent visit to Calgary, you called the economic impact of the oil price differential "crisis". We agree. A crisis of this magnitude must be reflected in any discussion on "Economic Competitiveness".

We trust that the agenda for our upcoming First Ministers' Meeting can be revised to better reflect the need for a substantive discussion on issues of critical importance to the Canadian economy. Therefore, we request that Energy Market Access and the Economic Impacts of the Price Differential be added as an agenda item for discussion this week.

We all share a desire to improve the lives of everyday working Canadians, and this is a core issue that must be resolved.

Thank you and we look forward to a substantive and fruitful discussion this week.
