I also asked my team to update the Key Principles for Strategic Contracts based on your feedback (below), please let me know if you have any further edits.

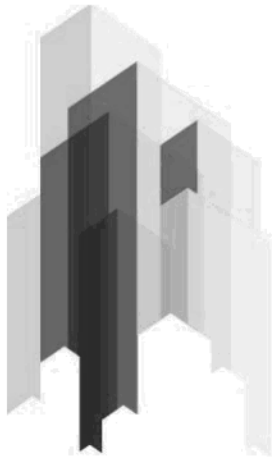

1 Executive Summary

The Real Property Division (RPD) supplies and manages real estate services to provincial ministries and voluntary Broader Public Sector (BPS) clients across BC. Since 2004, RPD has been supported in delivering facility management (FM) and construction project services through a Master Services Agreement (MSA) between the Province and Workplace Solutions Inc. (WSI). Preparation for procurement of a succeeding agreement in 2019 has been underway for several years. This paper provides an analysis of the current service delivery model, in comparison with repatriating the services, to ensure alignment with government objectives prior to proceeding with the final procurement phases.

In the current model, WSI manages services using **BC based staff and technicians**, supported by shared experts and services based on Ontario. Approximately **69 percent of FM services and more than 80 percent of construction project services are delivered through vendors, most locally based**.

An insourced model would be very similar, with Province staff replacing WSI staff, technicians and other support services. In addition, the Province would need to develop supporting infrastructure including a 24 hour operations centre, and maintenance management systems. Approximately 350 FTEs would need to be transferred or otherwise engaged.

Province objectives, including: fair wage policy; maximizing availability of FM and project work to local small and medium sized business; and increasing recognition of government funding of FM related services have been examined. As the current contract model is highly flexible, these objectives **can be achieved within either a contracted or insourced model**. They could be implemented before the current contract ends.

2 Background and Context

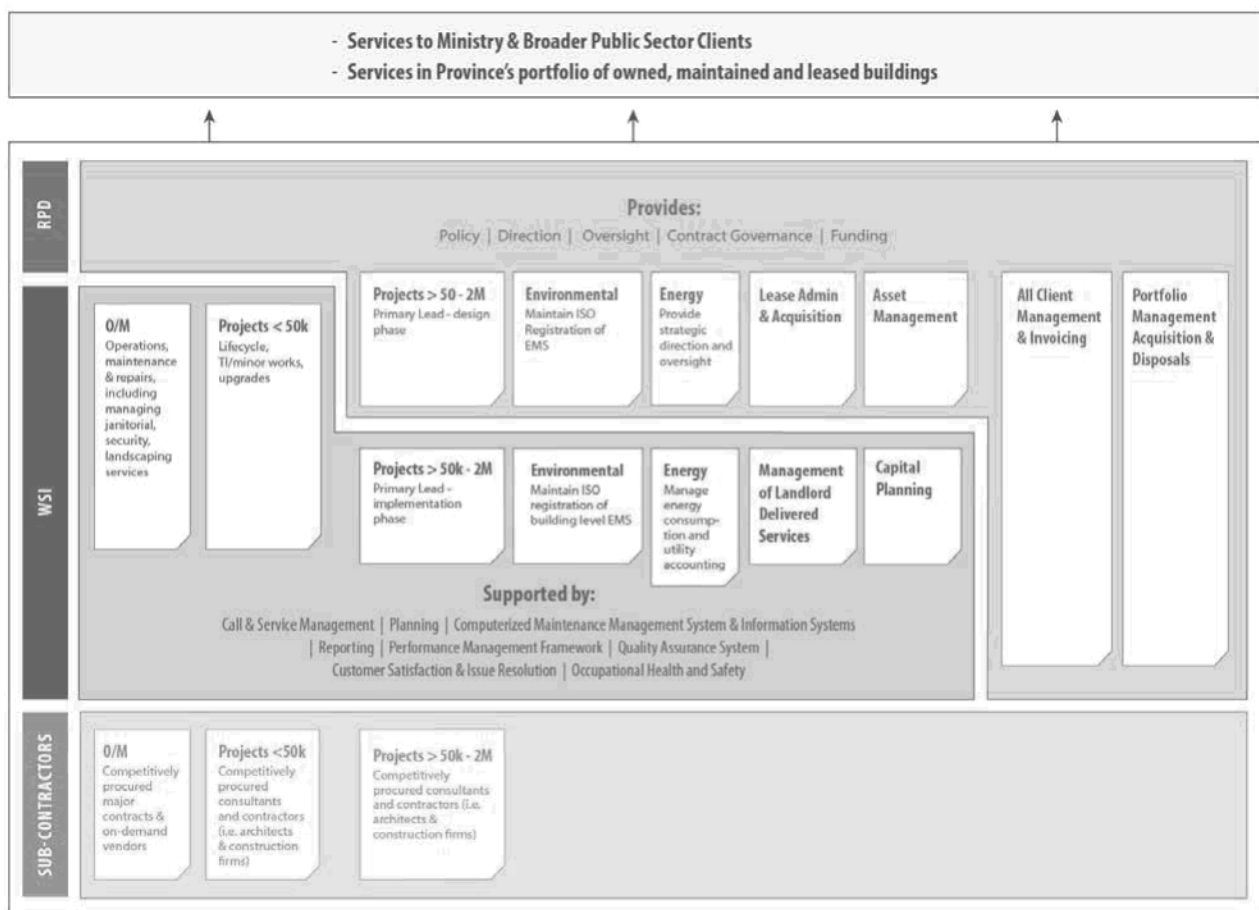
The Real Property Division (RPD) is the Province's lead agency for supplying and managing real estate services to provincial ministries and voluntary Broader Public Sector (BPS) clients across BC. RPD supports government ministries and the BPS in providing services to citizens by procuring and supplying required accommodation and related technology, products and services.

In 2003, based on the development and approval of a business case, RPD (then BC Buildings Corporation) made the business decision to contract out the delivery of facility management (FM) services. The Master Services Agreement (MSA) between the Province and Workplace Solutions Inc. (WSI) established the terms and conditions under which RPD agreed to engage WSI to provide FM services. The original agreement has been restated for subsequent terms. The final term of the agreement concludes on March 31, 2019.

3 Current State

3.1 RPD Current Model

RPD contracts with WSI to provide a range of FM services, including customer/occupant services, operations, maintenance project delivery (excluding very large projects), and supporting technology. WSI core service responsibilities include: janitorial; landscaping; security services; minor and major capital projects; and efficient energy/environmental management. RPD continues to provide core strategic and high value functions, including policy, direction, oversight, contract governance, and funding. The following diagram identifies the services retained by RPD and those included in the MSA. A detailed list of services is in *Appendix A*.



3.2 WSI Current Model

3.2.1 Organizational Structure

In accordance with the MSA requirements, WSI was established as a BC based subsidiary of the parent company BGIS (formerly Brookfield Global Integrated Services). WSI's local model is structured with a General Manager and suite of managers and directors that oversee core functions, including FM, project delivery services, operations, reporting and client services (see organizational chart in *Appendix B*). While many core functions are centralized, the organization is also structured to support the geographic dispersion of the portfolio, with regional offices in Victoria, Vancouver, Kamloops and Prince George.

WSI provides subject matter expertise in key support functions through a shared services model based out of their head office in Markham, Ontario. These key support functions include HR, AR/AP, audit and quality control, environmental ISO certification and other compliance requirements, procurement, health and safety, energy account management, major project delivery, and best practice (policy and procedures).

3.2.2 Operations

The core services delivered by WSI are managed through the following staffing model:

- **In-house technicians: These are BC residents** who are WSI employees and perform preventative maintenance and are dispatched on service calls by the operations centre. In-house technicians make up approximately 30 percent of the FM budget. See *Appendix C* for WSI staff locations within BC.

Competitively procured major contracts: Comprise approximately 34 percent of the total budget. With procurement run through WSI corporate head office, additional value can be realized when Canada-wide procurement leverages significant volume discounts. WSI procures services in alignment with BC procurement policy and use similar procurement vehicles (i.e. BC Bid). **On-demand suppliers** make up approximately 35 percent of the total budget (21 percent of which is related to utilities). Locally based suppliers from across the province are prequalified through head office. The open pre-qualification system ensures that there are sufficient vendors in each location who meet province specified qualifications (e.g. WCB, insurance, etc.). **In 2016/17, approximately 900 local BC vendors were sub-contracted to provide WSI work.** See *Appendix D* for sub-contractor locations within BC.

3.2.3 Project Delivery Services

WSI is responsible for project management and construction services for projects up to an individual threshold of \$2 million. These projects are managed through in-house project managers who competitively procure consultants, architects, construction firms and contractors. The majority of these projects are **delivered by locals, creating job opportunities in BC.**

3.3 RPD Contract Management

A team of approximately 20 FTEs within RPD is responsible for FM contracts. This team has direct accountability for monitoring and managing the overall performance of RPD property management outsourcing contracts including WSI. The team works closely with WSI and clients, ensuring processes

meet quality, service levels and client satisfaction. Physical site inspections are made of all properties, service levels and flow-through costs are audited and processed, and strategic direction is provided.

4 Insourced Service Delivery Model

Insourcing means discontinuing the outsourcing agreement and using government staff to perform the functions currently performed by WSI staff. A large part of the work would continue to be contracted out individually, as it was prior to outsourcing. Before MSA commencement, 59 percent of FM spend and 80 percent of project spend was contracted and a similar ratio is expected in an insourced model.

6 Achieving Government's Policy Objectives

6.2 Ensuring audit and adherence to payment of Minimum Wage for all facility management workers

WSI and its subcontractors are required to follow provincial employment standards, including minimum wage policies. Many WSI staff and subcontractors supporting facility management of provincial and broader public sector buildings are skilled trades (e.g. electricians/plumbers) and earn well beyond the minimum wage. However, in some service sectors (eg. janitorial and landscaping), wage levels are at a l.

The total WSI O&M budget for 2016/17 was \$88 million. The existing WSI contract funding model is based on a cost pass-through for direct services with a separate management fee indexed to portfolio size (equates to 4 percent of total O&M budget) provided to WSI to administer the contract. This pass-through model allows for flexibility in service and staffing levels. **Based on this model, RPD is in a position to ensure minimum wage in the current and future contract. RPD has already started work with WSI to develop a Minimum Wage Audit program. RPD has also created a position for carrying out this audit.**

6.3 Ensure local companies and small businesses have fair access to FM work opportunities

In 2016/17 approximately 900 local BC vendors were sub-contracted to provide WSI work (see *Appendix C* for sub-contractor locations within BC). WSI's procurement activities are based on open, transparent and competitive bidding processes as the foundation for yielding best overall value for the Province; and therefore, **provides a fair access to local companies and small businesses to FM work opportunities.** These processes are based on the Engagement Methodology defined in the Master Services Agreement (noted below) which outline the type of procurement activity based on the value of work to be undertaken. This methodology includes the use of Request for Qualification, Request for Quotation and Request for Proposal standard contracts and forms. Along with the methodology, is the typical engagement process and selection criteria used.

The delivery of FM services throughout the province provides an opportunity to align with broader government priorities for job creation. **Given the regional nature of the province's portfolio, the contract provides employment and economic growth opportunities for a number of small and large BC companies, and First Nations.**

WSI currently uses a simplified, lower cost prequalification mechanism for small businesses, especially in remote locations, thereby **minimizing administrative costs for prequalification process for small business.**

Effective communication and advertising of tender opportunities throughout BC is a priority for WSI. They advertise in the local papers, trade journals and continue to engage associations such as the Canadian Construction Association, local Construction Associations, and the Canadian Aboriginal and Minority Supplier Council (CAMSC) to ensure that all businesses have an equal opportunity to bid. This ensures that local subcontractors are aware of opportunities and fosters competitive bidding with a broad group of companies.

6.4 Increase recognition that current outsourced facility management services and project delivery are Province funded programs

In order to increase awareness that WSI and WSI supplier services are provincially funded, **RPD and WSI have already started work on developing a plan for co-branding, which will be implemented by end of the fiscal year.**

incentives to promote energy, water, waste reduction and energy savings are present in the current contract's performance measurement framework, ^{s.13,s.17}

Government has the flexibility to promote priorities in both contracted ^{s.13,s.17} The contracted model allows for additional input of best practice and innovation driven by the competitive market (e.g. advising or implementing Smart Building/Energy Retrofits).

Under the current s.13,s.17 it is possible to ensure contracted staff and subcontractors are paid in accordance with minimum wage laws, or higher, as the Province directs. WSI has already been asked to develop a framework for auditing.

WSI will develop a monitoring mechanism to ensure minimum wage adherence by WSI and all subcontracted companies working under WSI with a focus on Janitorial, Landscaping, and Security companies. RPD staff will also implement this area into their regular WSI audit activities. WSI would be instructed when renewing all subcontractor contracts to include strengthened adherence to meeting and verifying minimum wage pay requirements.

7.5 What were cleaning, gardening and security subcontractors paid in 2003?

In general, subcontractor employees were earning above minimum wage (\$8.00 in 2004). Records from 2003 that may have indicated unit pricing for these services are no longer available.

In order to provide an approximate answer, the 2004 BC Job Survey was referenced, and a number of samples for each of the 3 categories, most in the lower mainland, were collected. The table below presents an average of what private companies were paying workers in 2004.

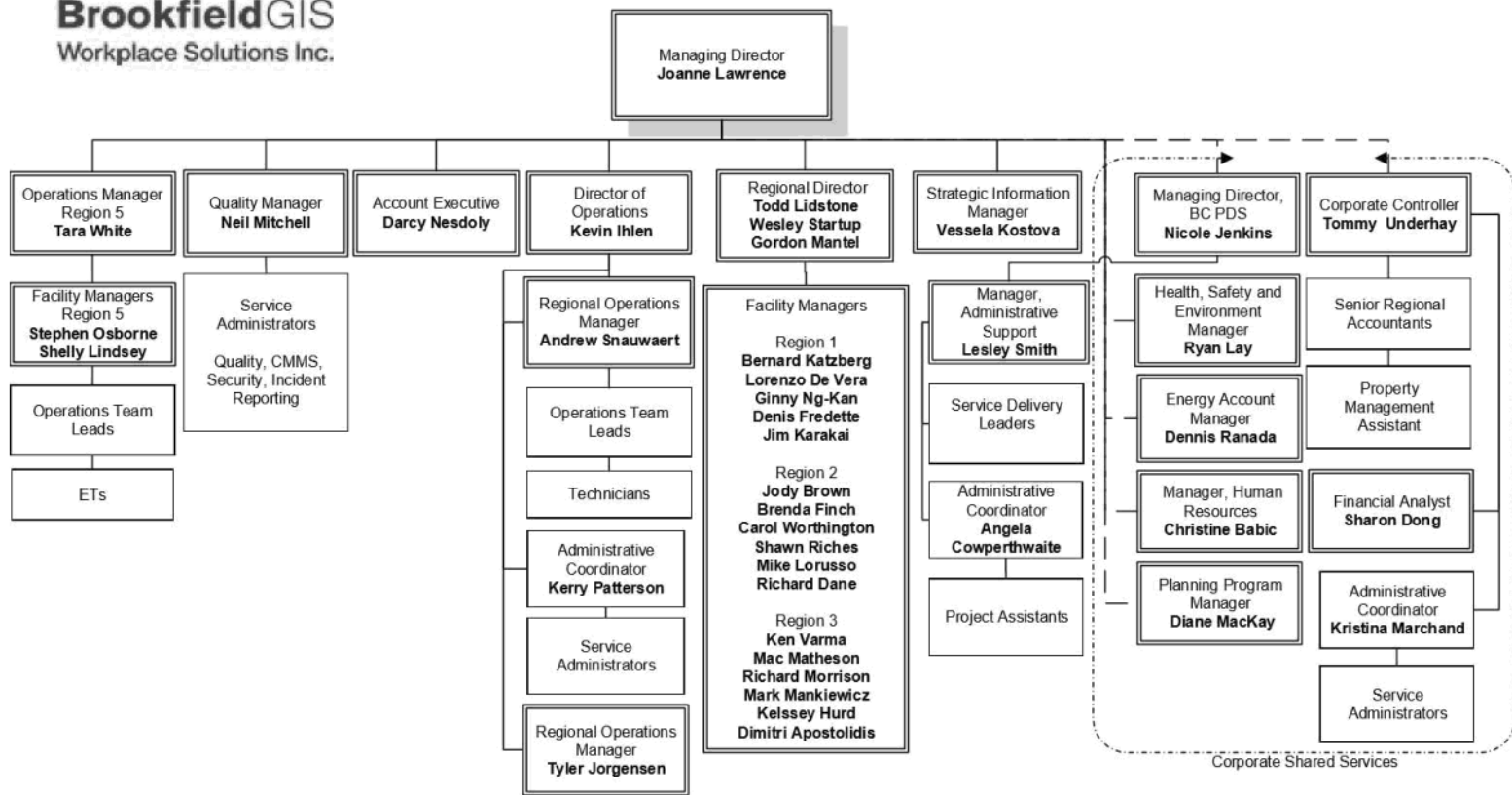
8.2 Appendix A – Services Provided Through the Current Contract

Services Include	Description or Comments
1. Operations and Maintenance	Includes managing and paying all utility costs, maintenance and repair (mechanical, electrical, elevating devices, general, other), janitorial, plumbing, waste management, snow management, roads/grounds and landscaping.
a. Scheduled (Preventive) Maintenance	Services to all building systems and structures, including equipment, components and finishes.
b. Corrective (Demand) Maintenance	Minor corrective items identified during regular preventive maintenance, observed by the service provider or initiated by a request to the Operations Centre.
c. Repairs	Minor repairs and component replacements as a result of breakdowns and failures. Major repair items are considered project work.
2. Project Management and Delivery	Projects are delivered under two processes: by facilities staff directly for clients if under \$50,000; and by project managers with more involvement from RPD if over \$50,000. WSI may deliver projects up to \$2 million. Larger projects will be procured separately by RPD.
a. Lifecycle	Minor lifecycle repairs are completed as scheduled or incorporated into corrective maintenance. Work of higher value is completed as a project. RPD provides funding for lifecycle repair and replacement through an annual approved plan for owned buildings.
b. Tenant Improvement	Tenant improvements may be funded by RPD or clients. These projects are completed as per the two project process described in item 2 above.
c. Upgrades	Upgrades are considered project work, as in b above.
d. Minor Client Requests	Minor client requests are completed as an on demand service and funded by the clients.
3. Energy Management	Energy use and utility suppliers are managed through an energy management program that covers all aspects of building operation management, client behaviour management, communications, reporting and innovations.
4. Environmental Management	ISO 14001 certification to the most up to date version is required in support of RPD's certified environmental management system.
5. Health and Safety Management	The current use and maintenance of a robust accident and incident reporting system allows for the identification, mitigation, reporting and prevention of all hazards to buildings and occupants.
6. Security	Security services include all of the following: intrusion alarm, access control systems, static guards, escorts, safe walk, patrols, installation and repair monitoring. Management of service provider staff and supplier staff in order to ensure all levels of security clearances are obtained and maintained to the required levels.
7. Call and Service Management / Operations Centre	Operations centre and call management system receives tracks, reports and manages all service calls and complaints. Accessible to the Province in real time.

Services Include	Description or Comments
a. Planning	On approval from RPD, annual plans are implemented. d. Quality Assurance	A quality management system that includes: data validation, goods and services received validation, and accounting and financial audits. Covers all aspects of services, including strategic, tactical and operational.
e. Records Mgmt.	A records management system that adheres to Provincial policies.
f. Information Management	IT systems to maintain records of transactional data, manage work order dispatch and tracking, project management, lifecycle and preventive maintenance planning, reporting to Province and clients, and regularly providing data transfers to Provincial IT systems.
g. Customer Service, Satisfaction and Issue resolution	Established process for identifying, reporting, tracking, escalating and mitigating issues.
