For instance:

Cleaner Transportation is primarily EMPR -

\$90M in 2019/20 for Clean Energy Vehicle Program Expansion

\$3m over three years to develop Zero-emission vehicle standard

\$5M to be invested by TRAN (through BC Transportation Financing Authority) in charging stations for rest stops.

\$6M over three years by TRAN for support of active transportation options.
