As discussed, a few take-aways I thought were worth sharing from my meeting with Sander (Hollyburn) yesterday. I will share with Craig as well.

The high-level points were:

- They are "spooked" by this see it as a one-off decision, knee-jerk reaction but they also very much want to partner with us
- UDI has developed a renters committee he is a member of it
- He is concerned that the municipal rental incentive programs need to be reviewed/changed because of this change (I'm unclear as to why)
- He said that the challenge with the increases being connected to repairs is that they are named as "unforeseen" repairs. He said none of their repairs are unforeseen because of the lack of tradespeople, they plan at least 3 years in advance for balconies, roofs, elevators etc.
- They build in Ontario so he reflected back some of the experience based on that he said the biggest issue is land depreciation
- Lastly, he offered to share any of their data with us to the extent it can be helpful

Long and short: I suggested they bring constructive ideas to the table about what they think would support Purpose Built Rental but wait until they see all of Spencer's recomemndations. He was open to that and has already followed up with me.

I connected with leaders in the Jewish community this morning to pass along our governments concern in light of the shooting in Pittsburgh and to ask how they are doing locally. I've also sent Nimmi names of leaders for MMF to call. She has to yet to reach him - I'm really hoping he's able to call today.

The Jewish communities national security response has kicked in - which means there will be increased police presence outside all Jewish institutions. The community in BC also has trained volunteers outside all the synagogues today (which are full because it's Shabbat). There will be letters out from community leadership to the entire community tonight. Importantly, so far the threat across Canada is not showing an increase or anything particularly unusual at the moment.

The tweet from the Premier was very important and will be really appreciated.

I know PSRK is working on government launching an anti-hate as campaign - the timing of this is critical, for all communities.

I'll keep you all posted if I hear more from community leaders this afternoon.
