Richard Purnell, director of income tax policy for the B.C. Ministry of Finance, said the province will be very interested to see the UBCM's submission and will look at it along with other submissions.

"We need to get this right," he said of the proposed law. He said it would "provide us very valuable information on who owns property so that we can pierce the corporate veil and really understand the supply and demand dynamics of the housing market as it relates to those who own housing through corporations, trusts and partnerships."

Purnell said the public would be able to search some of the information, while the more detailed information would be available to agencies such as law enforcement.
