Dear Friends and Colleagues,

Since receiving a positive final investment decision by LNG Canada's Joint Venture Participants in early October, LNG Canada has been busy moving forward into the construction phase of the project, doubling our workforce, working closely with our Engineering, Procurement and Construction contractor JGC-Fluor, and supporting Coastal GasLink to advance its Coastal GasLink pipeline project.

Coastal GasLink has unprecedented community and Indigenous support for its 670-km pipeline that will transport natural gas from northeastern BC to our plant site in Kitimat. Mayors and community residents up and down the pipeline right-of-way support the project, as do 20 out of 20 elected First Nations bands who have signed Project Agreements with Coastal GasLink.

LNG Canada supports the extensive efforts Coastal GasLink has undertaken to consult and engage with First Nations along the pipeline right-of-way and is pleased the pipeline has received so much support.

There is one group, however, that opposes the pipeline project and members of this group have erected a barricade over a public access road that Coastal GasLink needs to cross to access a small portion of the pipeline route, initially to conduct some pre-construction work, and later to construct a roughly 60-kilometre section of the pipeline.

On Monday, November 26, despite numerous attempts to respectfully consult with this group and find a solution that works for all parties, Coastal GasLink filed an application for an injunction, asking the Court to ensure it can access the public road and complete important field work this winter. We are concerned that a delay to Coastal GasLink's ability to conduct this work could impact the delivery of jobs and opportunities to local First Nations communities, and in turn, will impact LNG Canada's project schedule.

LNG Canada's first concern is for the safety of the public, for Coastal GasLink's employees and contractors, and for the individuals participating in the blockade. We respect the rights of individuals to peacefully express their point-of-view, as long as their activities do not jeopardize people's safety and are within the law.

There is considerable discussion of this issue in social media, with sharing among the ENGO community and supporters of the blockade. As it will likely be covered in mainstream media as well, we wanted to ensure our stakeholders had important background information, as issues such as these are complex.

- Coastal GasLink requires access to the Morice River Bridge, a bridge crossing on a public road
- The Morice River Bridge is located within the traditional territory of the Wet'suwet'en Nation.
- The elected representatives of the Wet'suwet'en territory support the Coastal GasLink project, however, some of the Hereditary Chiefs do not.
- Near the Morice River Bridge, a group calling itself the Unist'ot'en Camp has built a
 Healing Centre and some individuals live there permanently, while others visit and
 access programs and services the Healing Centre offers. Accessing the Morice River
 Bridge and constructing this portion of the Coastal GasLink pipeline will not require
 individuals living there to relocate. (See map attached)
- LNG Canada, along with others, has filed an Affidavit in support of Coastal GasLink's
 application for an injunction, and outlined the impact lack of access would have on our
 ability to deliver our Project.
- Coastal GasLink and LNG Canada will continue to work to find a peaceful solution, one
 in which everyone can benefit from these significant projects. Coastal GasLink will also
 continue to assess its legal options, as efforts to discuss these matters have not been
 reciprocated.

Below is some of the information on the Vancouver Island FTZ. There has not been a major announcement-moment from us on this, but it is something we have referenced in a few tours.

ABOUT THE FTZ INITIATIVE:

- The FTZ Point Initiative was announced by the federal government in 2013. An FTZ Point refers to one of Canada's strategic locations for international trade, where an organization is supported by a single point of access to information on relevant government policies and programs. This information is provided through a single window task force coordinated by a regional development agency and is comprised of representatives from relevant federal and provincial departments. Details on the FTZ Point Initiative are provided in Annex I.
- To date, Prince George is the only municipality that has been approved for FTZ Point designation in BC.

THE VANCOUVER ISLAND ECONOMIC ALLIANCE APPLICATION TO ESTABLISH AN FTZ

- The Vancouver Island Economic Alliance (VIEA) submitted a proposal to WD-BC to establish an FTZ Point on Vancouver Island in June 2017. Details of the proposal are provided in Annex II.
- WD-BC established a single window task force comprised of representatives from WD-BC, Global Affairs Canada (GAC), Canada Border Service Agency (CBSA), Canada Revenue Agency, and Transport Canada, as well as two provincial ministries – Ministry of Transportation and Infrastructure, and Ministry of Jobs, Trade and Technology.
- The task force assessed the proposal from the VIEA, and the proposal essentially meets the criteria outlined by Finance Canada, listed in Annex I.
- Minister Navdeep Bains approved the designation of Vancouver Island as a Foreign Trade Zone Point in February 2018.

Details of the Vancouver Island Economic Alliance's Proposal

The proposal from the VIEA aims to recognize an FTZ Point on Vancouver Island and to have access to a single window FTZ task force comprised of representatives from relevant federal and provincial departments. 
Background

- While Canada has diplomatic relations with Myanmar, there are economic sanctions currently in place and human rights (in particular the treatment of ethnic and religious minority groups) remains a serious concern.
- Most recently, the Rohingya population, an ethnic minority who has been the subject of widespread discrimination, has been forced to flee Myanmar because of a brutal security operation led by Myanmar's security forces.
- Stemming from a spike in violence, including a significant security operation and "clearing exercise" by Myanmar's armed forces, over 730,000 Rohingya refugees have fled from Myanmar to Bangladesh since August 2017.
- This crisis has resulted in widespread and significant humanitarian needs in both Myanmar and Bangladesh.
- The refugees are living in extremely difficult, congested conditions. The situation in the camps and settlements was aggravated by the severe monsoon rains and flooding from July to September 2018. The humanitarian situation in Rakhine state—and other conflict-affected regions of Myanmar—is also alarming.
- In October 2017, Prime Minister Justin Trudeau appointed the Honourable Bob Rae as Special Envoy to Myanmar. In April 2018, Mr. Rae submitted his final report outlining 17 recommendations for Canadian action. In May 2018, Prime Minister Trudeau released Canada's Strategy to respond to the

- Rohingya Crisis, which includes a commitment of \$300 million of international assistance funding over three years to address humanitarian, development and peace and stabilization needs in Myanmar and Bangladesh.
- In June 2018, Canada and the EU sanctioned seven individuals involved in the military operations launched in Rakhine state in August 2017. Canada has in place comprehensive sanctions related to Myanmar under the Special Economic Measures (Burma) Regulations, including an arms embargo and an asset freeze and dealings prohibition targeting both entities and individuals.
- Canada also sanctioned a high-ranking military official in February 2018 under the Justice for Victims of Corrupt Foreign Officials Act as a result of the significant role played by this military official in human rights violations against the Rohingya.
- Canada continues to exercise its leadership in promoting international cooperation in response to
 the crisis in order to better coordinate assistance and align advocacy efforts. Canada will also
 support efforts at the UN and in other multilateral institutions to build political will and coordinate
 international efforts.

A few further points that may be helpful:

- The NEB approval conditions included integrity digs and running smart pigs though the line (assessing the actual pipeline). Those conditions were met before Enbridge was allowed to increase pressure.
- The overall safety of the pipeline is fully regulated and overseen by the NEB. The NEB has been
 directly involved in providing instructions to Enbridge for operation of the pipeline following the
 rupture.
- The TSB is continuing their investigation and it is expect that fully results will not be available for up to 18 months (after the rupture). The BC Oil and Gas Commission has an official observer on the investigation. The BC OGC is very impressed with the process that the TSB is following for the investigation.

Nov. 22 – FortisBC issues news release announcing an improving natural gas supply picture for B.C. Nov. 30 – Enbridge issues statement that the NEB granted its request to operate a portion of the T-South line at full operating capacity following a detailed engineering assessment. There are currently about 260,000 customers without power in the Lower Mainland, Fraser Valley, Sunshine Coast and on Vancouver Island. Since the windstorm hit earlier today, BC Hydro has safely restored power to more than 240,000 customers.

Winds up to 100 kilometres an hour in some areas have resulted in damage to more than 750 spans of wire, 270 poles, 400 cross-arms and 150 transformers. This is one of the most severe storms BC Hydro has experienced in years.

There are more than 550 field staff working to restore power, and crews will be working around-the-clock until all damage is repaired. Due to the extent of the damage, many customers will be without power overnight – and for some customers it could be days.

At this time, priority goes to damage that presents an immediate danger like live wires across roads or near homes, as well as restoring circuits to critical services like hospitals. From there, BC Hydro will make repairs to high-voltage transmission lines and substations as this will bring the most customers back as quickly as possible. For example, a circuit serving 5,000 customers will be restored before restoring a line that serves 50 customers.

VANCOUVER: Strong winds have caused hundreds of individual power outages, affecting more than 300,000 customers in the Lower Mainland, Fraser Valley, Sunshine Coast and on Vancouver Island. In the Lower Mainland, the hardest hit areas are Surrey, Langley and Abbotsford.

There is extensive damage from branches and trees breaking and coming into contact with BC Hydro's electrical equipment. Continued strong winds have made damage assessment and repairs difficult, but where safe, crews are busy repairing damaged power lines, poles and transformers. One of the key challenges is accessing their assets due to trees in road etc. They have crews from all over the province on it however they still have a significant amount of customers out in the LM as well.

Darwin has informed me that Chris O'reilly will likely be reaching out to our Ministry (Dave Nik) to seek support on coordination with EMBC and MOTI to assist. The concern is that some pockets of communities could be out through Christmas.

They have been communicating frequently through various channels and Chris O'Reilly was on the ground and posted a video to social media.

Winds up to 100 kilometres an hour in some areas have resulted in damage to more than 750 spans of wire, 270 poles, 400 cross-arms and 150 transformers. This is one of the most severe storms BC Hydro has experienced in years.

There are more than 550 field staff working to restore power, and crews will be working around-the-clock until all damage is repaired. Due to the extent of the

- While BC Hydro has been communicating that some customers could face outages for a number of days, our most current assessment is that full restoration could now take between four and seven days.
- Examples of areas facing the longest outages include:
 - some Gulf Islands where BC Hydro crews are prevented from restoring power because roads are littered by fallen trees;
 - the Duncan area where there are possibly hundreds of trees that have fallen onto powerlines that have yet to be cleared;

> > Hi,

> Just a quick update on BC hydro's progress in restoring power for customers affected by the Dec 20th storm.

> Since yesterday's call, we have made good progress. We currently have under 18,000 customers out. That's down from the 660,000 that lost power as a result of the storm. The number of outages are expected to further decline by end of day. We remain on track to be below 12,000 by end of Christmas day.

>

> We're now into the hardest part of getting our remaining 18,000 customers restored – it's tough slogging as there are hundreds of outages – most affecting a very small number of customers. It's time consuming as our crews must attend to each of these small customer outages individually to make complicated and lengthy repairs. The Gulf Islands and Bamfield may take until Monday before they are restored.

>

> As mentioned yesterday, BC Hydro and contractor crews have been working around-the-clock since the storm hit, and will continue to do so until every customer has their power restored. Crews and support staff are working through Christmas and Boxing Day.

>

> We currently have 98 crews on Vancouver Island. We've had more than 800 field personnel working hard to repair more than 1,100 spans of wire, 300 power poles, 550 cross-arms and 170 transformers that were destroyed in the storm. More crews will be arriving over the next couple days as we shift resources from the Lower Mainland as that region has been fully restored. Contract crews are being brought in from Alberta and from other parts of Canada.

>

> On the communications front, we continue to be active in social media. In addition to story content and automated notices, Chris O'Riley continues to provide daily updates via video. Social media sentiment remains positive overall, however, negative sentiment has risen which is to be expected given the length of time some customers have been without power.

>

> News media has been overwhelming positive at this point in time. That could change as some communities remain out through til the weekend.

>

> BC hydro has been in regular contact with local government officials providing daily briefings. A briefing was held
today at 1 pm for MLAs of impacted areas. MLAs Olsen and Furstenau were the only MLAs who attended the briefing.
Both MLAs were generally positive and expressed appreciation for BC Hydro's efforts. However, MLA Olsen did mention
he intends to discuss BC Hydro's response to the storm with government. He did not elaborate.
