In my capacity as Acting Deputy AG, I am seeking your permission to move forward with a corridor order to bring section 1 of the *Family Maintenance and Enforcement Act, 2018* into force on January 1, 2019. If you agree, we will arrange for the AG's review and signature so that the package can move forward.

This is the background:

- The *Family Maintenance and Enforcement Act, 2018* (FMEA 2018) was passed by the Legislature during the Spring 2018 Legislative session.
- Section 1 of the FMEA 2018 authorizes the filing of a new form in a land titles office called a "notice of maintenance order".
- The new form replaces the filing of the entirety of a family law agreement or court order in a land titles office against the title of property to secure the payment of child or spousal support.

Earlier this year, the Premier and Cabinet had asked that a process be developed to assess and monitor the impact of government policy decisions on businesses and the economy and to incorporate impact information in proposals being advanced for Cabinet and Cabinet Committee consideration.

I am writing to introduce the **Business and Economic Implications Framework** (BEIF) and to ask that you advise staff of the new requirements. The BEIF was developed by the Ministry of Jobs, Trade and Technology to provide a standard assessment approach. JTT will provide support and assistance as the BEIF is established, establish capacity to track cumulative impacts and review the BEIF after 6 months to ensure that it is meeting its intended purpose.

Effective January 1, 2019, ministries submitting **new** Requests for Decision, Requests for Legislation and Orders in Council intended for Cabinet and Cabinet Committee consideration will be expected to complete the screening and evaluation tools included in the framework. The framework and related screening tools and worksheets are available at <http://gwww.cabops.gov.bc.ca/templates/>.

Training tools have been developed to assist with implementing the framework, including in-person workshops and a self-serve training module on [@work](#). Registration for workshops can be done through the [Learning System](#) (Business and Economic Implications Framework – Workshop). Priority registration may be given to teams that are developing submissions that will be considered early in 2019.

Please circulate this email to your leadership teams, and direct any questions about the framework to Christine Little or Francois Bertrand at JTT. As your teams begin implementing the framework, requests for support can be directed to [BEIF@gov.bc.ca](mailto:BEIF@gov.bc.ca).

## BC Hydro Situation Assessment for December 20, 2018 Coastal Windstorm Event

### Background:

- The windstorm of December 20, 2018 was of historic proportions and has led to extensive damage on Vancouver Island and many parts of the Lower Mainland.
- Over 585,000 customers lost power. As of 730pm, December 21 approximately 103,000 customers remain without power: about 66,000 on Vancouver Island and the remainder in the Lower Mainland, predominantly in Surrey, Abbotsford, White Rock, Maple Ridge and Mission.
- While BC Hydro has been communicating that some customers could face outages for a number of days, our most current assessment is that full restoration could now take between four and seven days.
- Examples of areas facing the longest outages include:



- some Gulf Islands where BC Hydro crews are prevented from restoring power because roads are littered by fallen trees;
  - the Duncan area where there are possibly hundreds of trees that have fallen onto powerlines that have yet to be cleared;
  - Bamfield where 70 spans of lines are down and will require at least three days of restoration. Due to difficult access, some poles of up to 80 feet have to be climbed to carry out repairs;
  - neighbourhoods in Qualicum and Nanaimo where there are multiple examples of damaged poles and lines that will require days of restoration; and
  - Surrey, White Rock, Abbotsford, Maple Ridge and Mission all have extremely high volumes of outages, each requiring multiple crews and co-ordinated work plans.
- BC Hydro has not yet completed all of its damage assessment which means there will likely be other examples of communities facing prolonged outages. There's been damage to more than 1,110 spans of wire, 300 poles, 550 cross-arms and 170 transformers.
  - BC Hydro is utilizing all of its available crews and contractors to respond to these two regions, including, where possible, some crews from other parts of the province. There is currently more than 550 field staff working around the clock to restore power.
  - Complicating matters is the extent of the damage to our infrastructure in both the Coastal and Vancouver Island regions. As an example, on Vancouver Island a significant storm event might generate 300 trouble calls while this storm was the cause of more than 1800 trouble calls.
  - In addition, under "normal" storm conditions, one region is typically harder hit which allows a large number of crews from the other region to help support restoration efforts. Due to the volume of work in each region, this is not possible today.
  - The holiday season further complicates the situation as customers will need to make alternative plans if they are affected by long outages.

Request:

- Support from Emergency Management BC and the Provincial Government to raise awareness about these extended outages with affected communities and the public in addition to facilitate co-ordination of assistance where required. This may include emergency preparedness for vulnerable populations and assistance from other government ministries and agencies (i.e., Transportation, Ferries).
