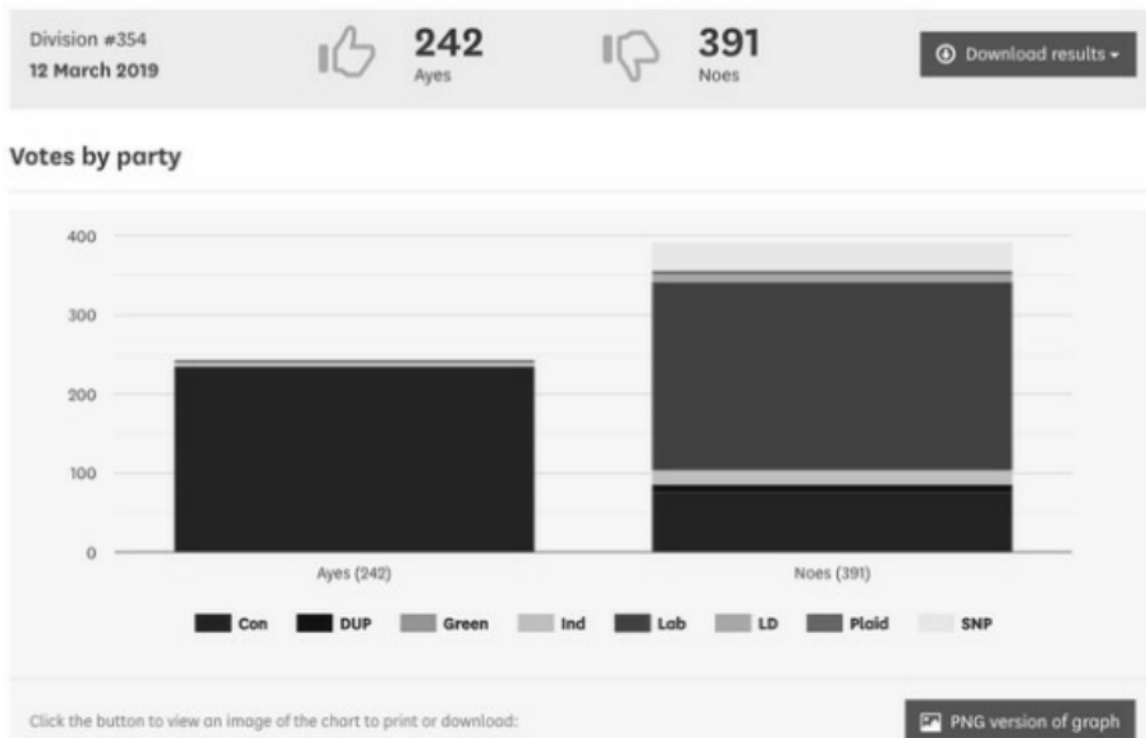

There is an extensive economic review and outlook on pages 67-90 in the *Budget and Fiscal Plan* (link near my signature block) which includes a summary by the Economic Forecast Council (13 leading economists from several of Canada's major banks & private research institutions). But there is not much of a narrative (zero mention of innovation or digital economy, for example). Topics (with a key point or two) include:

- Summary (copied below)
- Labour Market (labour market conditions tight, lowest unemployment rate in country, hiring challenges)
- Consumer Spending & Housing (anticipate BC housing market to transition toward more sustainable levels)
- Business & Government (growth in business investment led by non-residential structures; Oct 1 LNG Canada final investment decision expected to generate significant economic activity)
- External Trade & Commodity Markets (BC export diversity helped strong performance in 2018 – merchandise exports up 7.3% YTD Nov; most commodity prices declined 2nd half year; ratification and implementation of CUSMA expected to provide support for BC exports.)
- Demographics (population reached 5 million in 3rd quarter 2018; over 90% of 57,775 new residents from outside province came from other countries)
- Inflation
- Risks to Economic Outlook (upside: less domestic monetary policy tightening, weaker dollar, more resilient US economy; downside: global trade policy uncertainty, weakening global economic activity, lower commodity prices, risk of disruption to Europe's economic growth (Brexit), timing of hiring and investment related to LNG Canada project, exchange rate volatility)
- External Outlook (US, Canada, Asia, Europe)
- Financial Markets (interest & exchange rates) (Both the Bank of Canada and the US Federal Reserve are expected to continue to gradually tighten monetary policies in the near term)
- Economic Forecast Council (attached as Word Doc) – mention concerns over housing affordability, uncertainty surrounding export sector but noted advantages of BC's diversification, BC's strong fiscal position relative to other provinces, final investment decision for the LNG Canada project contributes to strong economic growth forecast.

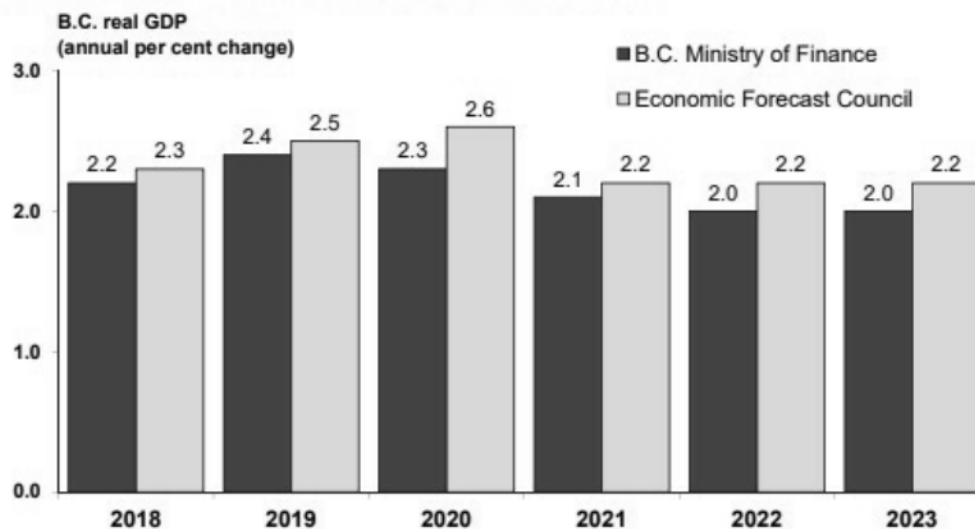
Summary

The B.C. Ministry of Finance (Ministry) estimates that British Columbia's economy grew by 2.2 per cent in 2018. The Ministry forecasts economic growth of 2.4 per cent in 2019, 2.3 per cent in 2020, 2.1 per cent in 2021 and 2.0 per cent in 2022 and 2023.

An average of six private sector forecasters² estimate that B.C. tied for the second strongest growth in real GDP among provinces in 2018. These forecasters expect B.C.'s economic growth to rank at the top of the provincial rankings in 2019 and 2020.

The Ministry's forecast for B.C. real GDP growth is below the outlook provided by the Economic Forecast Council with 0.1 percentage point of prudence in 2019, 0.3 percentage points in 2020, 0.1 percentage point in 2021 and 0.2 percentage points in 2022 and 2023. This differential is one of the levels of prudence built into the fiscal plan.

Note: Economic Forecast Council projection for 2021 to 2023 is based on the period average.

The main upside risks to the economic outlook include less domestic monetary policy tightening, a weaker Canadian dollar and a more resilient U.S. economy. The main downside risks include uncertainty regarding global trade policy, weakening global economic activity, lower commodity prices, as well as ongoing economic challenges in Asia and the euro zone.
