Hi John,

As we had discussed yesterday, I am writing to follow up on DMCNR scheduling and materials distribution issues. Over the last few months there has been marked improvements in attendance and the level of engagement and discussion at DMCNR, but the administrative operations need some work.

A few weeks ago I had advised FLNRO administrative staff that the January 21 DMCNR meeting conflicted with Cabinet. That apparently was not understood as indicating that DMCNR needed to be moved. I hadn't realized that this was not done until I got the meeting materials on Friday afternoon. Aside from the Cabinet conflict, circulating materials on a Friday afternoon is far too late for anyone to provide meaningful review on top of other weekend work.

### Scheduling

Don has previously given instruction that DM Committee meetings are not to overlap with Cabinet or related Cabinet Committee meetings. For DMCNR, this means that meetings must not be scheduled at the same time as any of Cabinet, Priorities and Accountability Committee, Cabinet Committee on Sustainable Shared Prosperity, Cabinet Committee on Reconciliation or Treasury Board. DMCNR members are needed less frequently to support Cabinet Committee on Social Initiatives, Housing Working Group, Mental Health and Addictions Working Group or Childcare Working Group, Legislative Review Committee or Appointment Orders Committee, so overlap with these meetings would only impact the DMCNR schedule when items from the resource ministries – such as the Recovery Framework – were on the agenda.

As we have had ongoing difficulty with communicating date conflicts from our office to FLNRO administrative staff, I will ask Cabinet Operations to coordinate with your administrative team on when DMCNR meetings need to be moved or cancelled to accommodate the Cabinet Committee schedule. A week before every meeting, we would ask that FLNRO administrative staff check with Cabinet Operations to confirm that no conflicts have arisen but not yet communicated. We understand that there will be times when meeting conflicts come up and items still need to go through DMCNR on a tight timeline. In these cases, DMCNR meeting times in the evening or early morning will need to be considered.

### Materials Distribution

Late materials distribution is a universal problem, but particularly so at DMCNR. As he has on scheduling, Don has addressed materials distribution at DMC and Corporate Executive, and commented on this when he came to DMCNR in October. To support meaningful review and to show respect for each other's workloads, committee materials must be circulated a week in advance of committee meetings or items are to be deferred to a subsequent agenda. This does not mean that submissions and presentations need to be perfect at the stage they go for DMCNR review, as the purpose of these meetings is to provide thoughtful input before content is finalized.

Recognizing that administrative staff have limited authority to get materials from Ministries, we are asking that DM Committee Chairs review their meeting agendas and materials a week in advance and remove from the agenda any item (except verbal updates) where materials have not been provided. By the end of that day, materials should be posted on

the SharePoint site and a link circulated to members and assistants. Exceptions to this would be for unusual circumstances.

Thanks for your help in this, and I apologize for being so specific. I know scheduling is a tough job. Once the staff understand what is expected, I am sure this will resolve quickly.

Good afternoon Christine,

TBS has prepared the Ministers of State (MoS) Expected Results for 2019/20 (see below). Non-financial targets for Executive Council members (i.e. Ministers of State) are brought into force through a TB regulation. The regulations for 2019/20 are quite similar to last years. I have attached the MoS Expect Results for 2018/19 for your reference.

We worked with LBR and CFD on the wording and both FIN's legal counsel and Legislative Counsel worked together to draft the regulation; the Ministers of State have also reviewed. In the past, we have provided the draft to the PO for review and confirmation that there are no concerns with the regulation.

This is time sensitive as the regulation will need to be in force by budget. I know this is a tight turnaround; however, if we can please have **confirmation by end of day Wednesday, January 9<sup>th</sup>**, it would be greatly appreciated.

**Minister of State for Trade:**

- (a) promote the 2019 BC Export Awards;
- (b) continue to participate in B.C. trade-related events including those organized by the Canadian Manufacturers & Exporters that aim to increase export opportunities for B.C. businesses;
- (c) promote the benefits of free trade agreements to help B.C. businesses leverage new opportunities;
- (d) continue to support Forestry Innovation Investment Ltd.'s efforts to actively maintain, create and diversify demand for B.C.'s manufactured wood products in key international markets;
- (e) continue to work collaboratively with the Minister of Tourism, Arts and Culture to ensure ongoing representation of B.C.'s tourism industry on international trade missions;
- (f) continue to promote B.C. food and agricultural exports in collaboration with the Minister of Agriculture;
- (g) continue to participate in opportunities for expanding exports in the manufacturing sector;
- (h) submit to Cabinet a report on the results referred to in paragraphs (a) through (g) on or before March 31, 2020.

**Minister of State for Child Care:**

- (a) continue implementation of initiatives that support government's universal childcare plan that provides affordable, accessible and high-quality care and early learning for every child whose family wants or needs it;
- (b) monitor and report publicly on results achieved through the implementation of B.C.'s actions under the Multilateral Early Learning and Child Care Framework agreement with the federal government;

- (c) continue engagement with all levels of government, child care providers and the private and not-for-profit sectors to further inform implementation of the plan for universal child care;
- (d) submit to Cabinet a report on the results referred to in paragraphs (a) through (c) on or before March 31, 2020.
