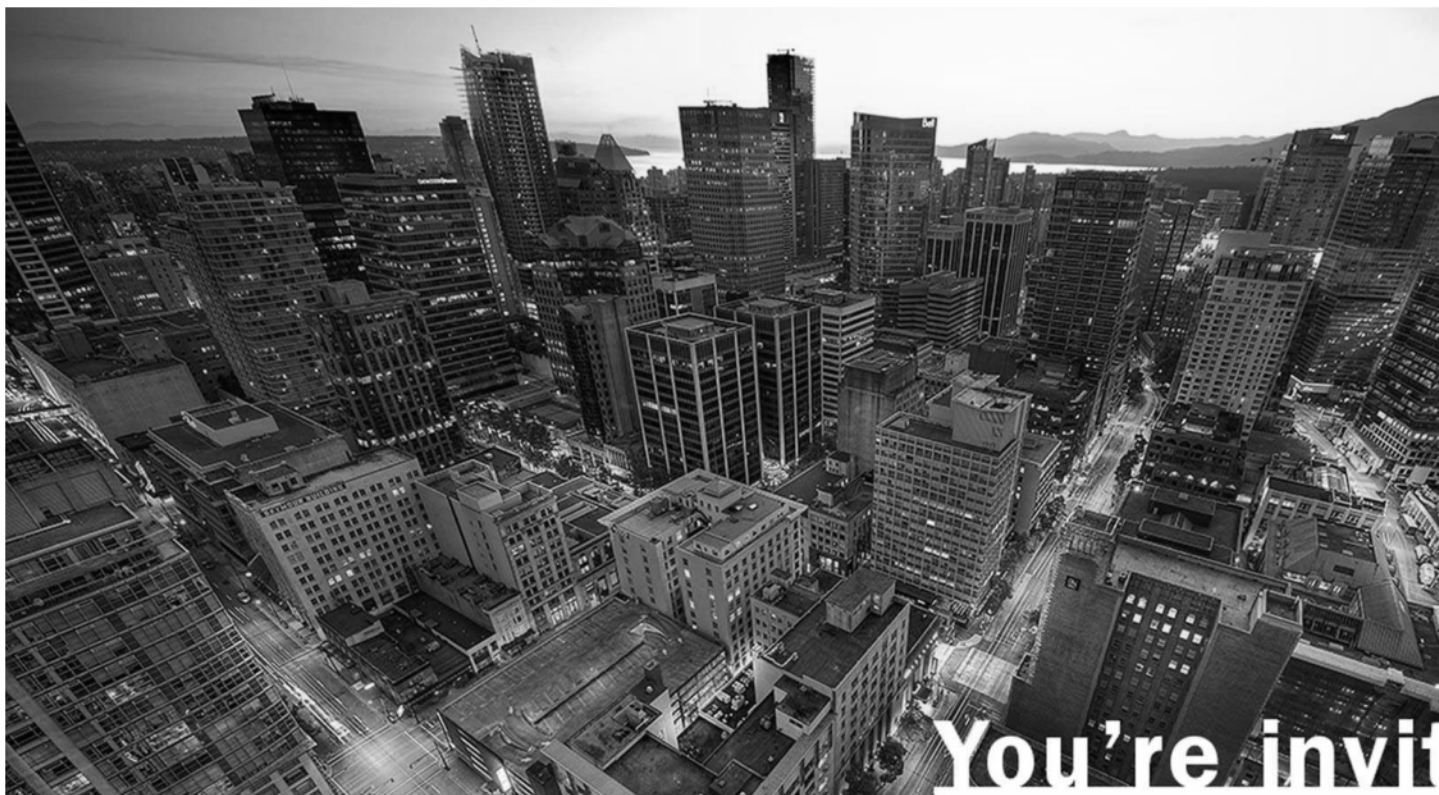

I've been out of the country for over three weeks so have missed the hubbub over your government's plan to meet the challenge of climate change. I haven't read the details yet but congratulations to you and the premier for setting a high bar. I am absolutely astounded that in the face of so much scientific information about the threat we now confront, that leaders of nations in Poland will essentially refuse to take the big steps to get off fossil fuels, even Canada. Basically we are saying "we can't change so we'll carry on our suicidal path. Sorry kids."

I am absolutely sure individual citizens are capable of reducing their energy demand by at least 25% voluntarily. The Japanese did it after Fukushima and have kept that reduction ever since. California did it after the rolling brownouts but it took a major PR campaign by the state government. During the early 2000s, Rick Mercer got paid a chunk of money to do ads for conservation by the federal government. As far as I know, they were not effective. So I approached Dalton McGuinty who was Premier of Ontario at the time and offered to do a series of ads on conservation of energy for no money to me or the David Suzuki Foundation. We ended up doing six ads that were funny but showed the power of changing lightbulbs, getting rid of inefficient frigs, drying clothes on clothelines, plugging holes in houses. Each film was backed up by information on a website. Every ad had a measurable impact. They were offered to other provinces and I think were used by NB and maybe Quebec. Anyway, I think the public will act if they are given information on what to do. I'm probably too old to do stuff like this but would be happy to assist in any way if you were to decide to do it.
