The Canadian Gay and Lesbian Bisexual and Transgendered+ Chamber of Commerce, in partnership with the Supplier Diversity Alliance Canada has been working to improve and modernize the procurement system of Corporate Canada as well as various levels of government. Supplier diversity has been a procurement policy of the United States Government for over 40 years and has led to some very positive economic and social inclusion results. Currently, many corporations including Royal Bank, TD Bank Group, BMO, CIBC, Sun Life Financial, EY, Accenture, Sodexo, Kellogg Company, Bell Canada, TELUS, Merck, and others, as well as the City of Toronto have incorporated supplier diversity into their procurement system.

As a former Manitoba Minister of Industry and Economic Development, I understand how a comprehensive inclusive policy can make a huge impact economically and socially. I have included attachments regarding these benefits for your information. We applaud the Government's recent efforts to improve the procurement process to increase the diversity of bidders on government contracts. No problem Evan, I understand.

No I haven't heard yet from the Ministry. Perhaps the following will help explain why I requested a telephone call with you.

The reason I wanted to speak to you is to follow up on a conversation I had with Premier Horgan at September's UBCM last Fall when he asked for a briefing and which prompted our request for a meeting with him. In June 2016, when we (The Fraser Basin Council) released our Phase 1 Report on the Lower Fraser Flood Management Strategy calling for immediate action by the federal, provincial, local and First Nations governments to work together to avoid substantive

impacts as a result of a major disaster in the LowerMainland from both river flooding such as experienced by Alberta with the 2013 devastating floods and coastal flooding from sea level rise, Premier Horgan, when at that time as Leader of the Opposition, requested and received a briefing on the FBC Report. I spent a full hour with him on the telephone briefing him and responding to his questions.

He asked to be given regular reports and re-iterated this when I spoke to him last September. He requested a full update on our current work on Phase 2 of the Strategy which now includes over 50 funding partners including every municipality from Hope to Richmond and Squamish to White Rock. Phase 2 will be completed next year and will focus on regional priorities, flood mitigation and management options, and governance and funding arrangement options to implement the Strategy.

In addition, FBC has been working with the Columbia Basin Trust, the Okanagan Nation Alliance, the Shuswap Nation, the Ktunaxa First Nation and the federal and provincial governments to work together to make best attempts to see if we can bring wild salmon back to the Upper Columbia River Basin. This is a very exciting initiative that could provide an opportunity for the Premier and his Government to demonstrate a commitment to this initiative by being involved in a Signing Ceremony proposed for May that would include the five governments to demonstrate their willingness to make this possibility a reality by signing a Letter of Collaboration. If given the opportunity to meet with Premier Horgan, I would be able to provide him with more details.

Yes, a meeting with Minister Robinson is welcomed as the Fraser Basin Council is engaged with numerous projects with local governments throughout BC including providing direct support to the North Central Local Government Association, however, we view this as a separate meeting and not as an alternative to a meeting with Premier Horgan for the reasons above.

We would cover much different issues with Premier Horgan than we would with Minister Robinson.

Hopefully, this helps.

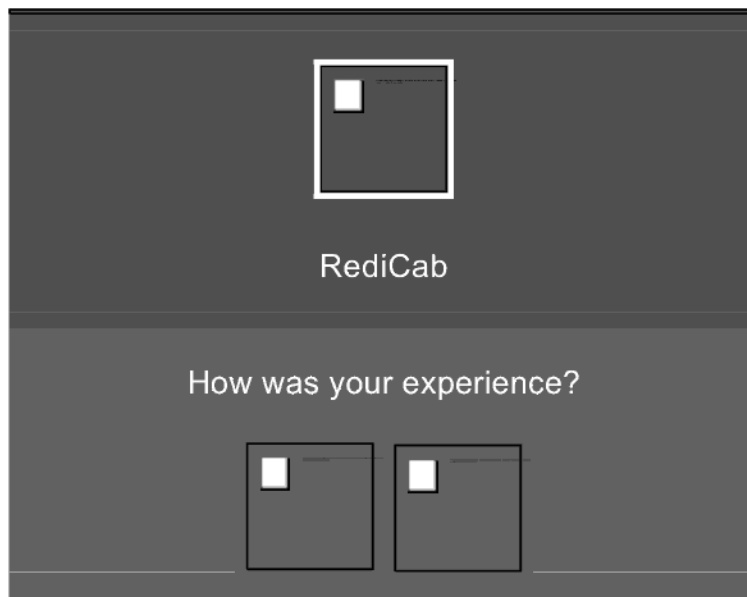

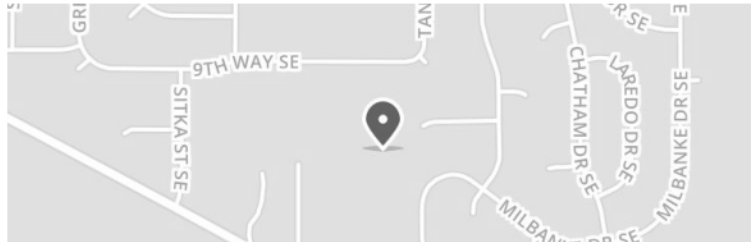

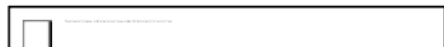
