Don....we've been asked to send out corporate messaging regarding public servants interest in participating in protests....rather than have a corporate message on @Work sent out....I thought I would simply send the following draft communication to Corporate Executive and they could use it as a guide in their discussions with employees. Similar issues were raised previously during the Enbridge protests/and those wanting to put their names forward as an intervenor.

DRAFT:

Dear Corporate Executive:

In the context of the protest events this week, the Public Service Agency has received requests for some messaging to support supervisors and executive in reminding employees of their obligations under the Standards of Conduct. I'm providing the following to use as you deem appropriate to address any questions you may receive from employees or supervisors.

As always with regard to any public policy issue, all of us as citizens have the right to our own opinions and perspectives on an issue, and we may comment on public issues. Being a public service employee doesn't change that.

However, as outlined in the Standards of Conduct, we must not jeopardize the perception of impartiality in the performance of our duties as public service employees by making public comments or entering into public debate regarding government policies.

In particular, we must not engage in any activity or speak publicly where this could be perceived as an official act or representation, unless authorized to do so.

This applies in public events, on social media or in any other venue where our personal opinions may be perceived as conflicting with our professional responsibilities.

We also must not express our personal opinions on policy issues using government equipment or during paid work hours. If an employee wishes to request leave to participate in a public rally or event, they must get approval for that leave from their supervisor in advance just like they would any other planned leave.

We all made a commitment as public service employees to uphold a duty of loyalty to government as our employer, which requires us to serve government to the best of our ability, placing the interest of the employer ahead of our own private interests. I encourage you to regularly engage with employees in discussions about how we apply that commitment in our day-to-day work and to remind them that their ministry ethics advisors, supervisors and executive are always available to answer any questions they have about how we all uphold the trust placed in us as public servants by the citizens of BC and their government.
